ANYONE WHO FOLLOWS MY POSTS KNOW THAT I'M A LIFER AND THEY ALSO KNOW THAT I WAS SENTENCED UNDER THE STUPID THREE STRIKES LAW JUST A SHORT UPDATE TO CATCH YOU UP. I CAUGHT A ROBBERY IN 1993. I PAROLED JULY 31 1994. ON 10-1994 I WAS IN JAIL FOR THE CHARGES OF GET READY ITS ALOT. MURDER W-WEAPON, ROBBERY AND DEGREE, ASSAULT W/ FORCE/GBI, KIDNAP, KIDNAP. THE DISTRICT ATTORNEY TOOK ME TO TRIAL FOR THESE CRIMES. I WAS LOOKING AT GETTING CONVICTED OF ALL CHARGES AND BEING SENTENCED TO LWOP. LIFE WITHOUT PAROLE. THE JURY DEADLOCKED ON LWOP THEN THE JUDGE RELEASED THEM TO GO HOME OW THE JURY DID LOOK ME IN THE EYE AND CRIED WHILE EACH CHARGE AGAINST ME WAS CALLED OUT LOUDLY. ON 12-11-1995 I WAS SENTENCED TO 25 YRS TO LIFE FOR THE MURDER CHARGE, THE ROBBERY, ASSAULT, KIDNAP, KIDNAP I WAS SENTENCED TO 9 YRS 2 MONTHS. THAT ADDS UP TO 34 YRS TO LIFE NOT SO FAST THERE TINSLEY THE DISTRICT ATTORNEY PLEAD AND PROVED THAT I HAD A PRIOR CONVICTION A ROBBERY PLEA BARGAIN IN 1993. IN 1994 THE 3 STRIKES LAW WAS IN EFFECT. THE DA USED THE PRIOR ROBBERY AGAINST ME CALLING IT A STRIKE AND 2ND STRIKED ME GAVE ME 68 YRS

THEY GAVE ME MORE TIME THEN I CAN POSSIBLY DO - I TRULY BELIEVE THAT ON SENTENCING DAY SINCE THE JURY DEADLOCKED ON THE LWOP THE JUDGE TOOK IT PERSONAL AND USED THE 3 STRIKES LAW TO GIVE ME AS MANY YEARS AS POSSIBLE - THE FIRST THING THE JUDGE SAID TO ME WAS THIS IS A 2ND STRIKE CASE NOW MR TINSLEY WHICH MEANS THAT I HAVE TO DOUBLE YOUR SENTENCE. THERE IS SO MUCH I CAN TELL YOU ABOUT ALL OF THIS NIGHTMARE BUT SOMEDAY ILL POST THE WHOLE NIGHTMARE ON MY BLOG FOR EVERYONE WHO IS INTERESTED TO READ. ITS A STORY THAT I COULD FOR A FACT WRITE A BAD ASS BOOK.
