ANNE AS YOU READ MY BLOG YOU WILL READ ABOUT MY BEST FRIEND SCOT PINKERTON. HE WAS MY CELLCIE AT CMC FOR 5 YEARS. HE'S FAMILY NOW. WHEN YOU GET TIME LOOK AT BLOGS/1347/ CHECK OUT SCOT.
