Currently the understanding is that only the Wm Clerks are permitted in the Chapel area without direct supervision. Mind you, the Imam is the designated Chaplain for A-Fac, and evidently only committed here on Tue. and Fri. While he is here he then makes the Chapel classroom available on a 'courtesy' basis for whoever makes the reservation (Unlike B & C Fac which permit classroom time to existing religious groups on the DMS).

Here's the thing: DOM 101060.61 SCHEDULING WORSHIP SERVICES, stipulates "Inmates may conduct services" under "All Chapel Services will be conducted with State employed Chaplains present whenever possible". This seems to make allowance for existing groups to attend Wm led religious service/studies in the classroom area. That being said, I am intending to develop a chapel classroom proposal to present to the Chaplain/CRM, which will permit "established religious groups" reserved classroom time whether or not the Chaplain is present.

We are all aware of the Security issues of unsupervised Wm's, which in actuality, where Clerks or Religious groups are concerned, Chapel Windows (and A-Fac yard camera) provides a direct view of Chapel activity. I believe the Security issue is rather one of LOTTERING in the Chapel area.

This memo is intended to bring this matter to your attention in order to clarify Wm access to the Chapel classroom for religious study/service while no chaplain is present. Thank you for your co-operation in our efforts to provide a wholesome environment for the rehabilitation needs of the Prisoner population at MCSP. X Wm Goehler
