There are plenty of inmates who don't have any family left and do without due to that. Prison is a hard life. I have been in here for 22 years and counting. I'm a lifer and for years it looked like I may never see my freedom but laws are changing and in 4 years when I turn 50 years old I will be eligible to go in front of the Board of Prison Terms for Elderly Parole. You have to be 50 years old and have 15 years in. When I turn 50 on Feb 28 2020 I'll have 25th years in and I will then file for Elderly Parole. I'm ready for my freedom someone else can have my cage. I learned my lesson.
