By 5 P.M. I was back here on G wing in my new cell G 2304. My property is still at U.C.I. What I noticed right off the bat, is this place has changed. And for the better. Every officer I've run into is polite and professional. Completely different from those officers at U.C.I. This is like night and day. I know three of the guys on this wing.

6:49 P.M. Dinner just ran, that's different over here as well, the food is cold, but it's a better quality of food, prepared better. I'm going to go to sleep here shortly.

Tuesday May 5, 2015 5:53 a.m. I woke up at 2am laid there until I fell back asleep. Only had one mattress, my back is hurting. I got up at 5am. Washed up made the bunk, cleaned the floor, and now having a cup of coffee. I wrote mom a letter last night to let her know that I'm over here. I'm glad to be away from those unethical slimballs at U.C.I. That's not a good place to be. I hope to get my property today.

7:21 a.m. I think breakfast is down stairs. Over at U.C.I. we would have eaten two hours ago. I like later breakfast. Cause I'm usually writing early in the morning, I hate having to stop. Yep here's breakfast.

8:48 am. Guys are on the rec yard. I've been told that I have to wait 30 days. That's not in the rules 33-601.830(7)(i) but I'll just wait it out. I'm going to try to roll with the program. I'm tired of fighting all these battles. Right now I'm going to walk and listen to some music. I hope to get my property today.

10:58 am Guys just came back in from recreation. They only get 2 hours over here.

11:50 am. Canteen just showed up. I don't have anything coming. Next week hopefully I will.

12:22 PM. Lunch just showed up. Officer said that UCA still has my property over there. They will probably try to hold it as long as they can. Cause that's UCA for you. I've been reading a magazine.

2:54 PM. Was told by the nurse that my property is still at UCA and all my meds are over there as well. So I still have no property, nor my medication.

6:53 PM. Just finished eating dinner. Chicken rice and corn. I heard my property is over here. I should be getting it tomorrow. Now I'm just waiting on showers then bed. I heard showers don't get started until 8, sometimes 9 PM.

10:42 PM. Just got back from the showers. I'm going to sleep now.

Wednesday May 6, 2015 5:51 am. Been up since 3:50 washed up, and just laid back down. Waiting on the laundry to come. They do laundry every Wednesday. I got to get eye to this

scheduling. I hope to get my property this morning. I need to get some letters out, but I don't even have my address book. I also need to write the Chaplain, I've got to get some request slips in order to do that. I'm having a cup of coffee right now.

7:23 am. Finished eating breakfast, oatmeal and coffee cakes, nurse brought my meds around. Officer picked up canteen slips. They pick them up on wed, and pass out canteen on Monday or Tuesday. They also passed out clothes, sheets, towels, pants, shirts ect. I'm going to do some walking now.
