And House Speaker Steve Crisafulli out of Dist 51 shut's down the Government and kills SB-7020, along with many other Bills that hundreds of hours and millions of dollars are tied up in. And it's all going to be wasted because Rep. Crisafulli a Republican decides he doesn't want to work with a Republican run senate. These are seriously needed here in the FDOC. We have rules 33-208.002 for staff that's governed under Florida statute 944. Laws, but what we don't have is a way to ensure these rules

this prison abuse, Please let's make sure there are no more Darren Rainey's and Randall Jordan-Aparo's here in the FDOC. Help stop prison violence, call for body cameras and Annual polygraph exams to ensure staff is abiding by the Rules and governing laws of the State of Florida. God bless you.
