Then looked at me with a nasty look and then said, "yeah, some one is blogging about me, & wonder who that could be?" Then looked at me again as he was passing three of my blog pages around. He then showed it to me and told me the date Feb 6 8:00 am.

shortly after this, Sgt Blue whose been threatening me, and my loved ones, with that KKK remark, saying "I better fear him, and everyone else better fear him." and said "He's a member of the KKK (this Sgt is black) and then went to saying "They've been trying to get read of me for 24 years, King Kong ain't got shit on me!"

This is mentally unstable behavior. They need to get him, a psychological examination. Cause he's not stable at all!" Sgt Blue came out there about 11 am walked on P-5 Left and then on to P-5-right, the videos will show that, but each time he come off the wing, he was ranting and raving, against the last two grievance's I filed against him. one last week, for making threats, saying, "I better be glad the Doctor's out there." Then the one I put in for Monday, dealing with him sexually harassing me. An intelligent individual, would back off, and protect their job, this cat

won't quite. Now I'll give you this, if I had any sense, I'd stop blogging, and leave these people alone, obviously I'm not too intelligent. But, I'm fighting for more, than just myself, I'm fighting to bring much needed change, to an extremely unethical Department. We need change!"

I received a letter from a friend last night and she said "Don't get yourself killed and become a martyr for this cause." The way I see it, if I get beat down or killed, then it's going to be the house of representatives fault for shutting down the house killing SB 7020 that would have protected me.

We had 160 Plus inmates killed or unexplained deaths last year. We got inmates such as Darren Rainey being boiled to death by correctional officers. We got officers committing murder, killing inmates with chemical agents. Inmates being beat to death and a Republican run House, that doesn't want to work with a Republican run senate so they shut the government down and kill all of these bills that hundreds of man hours are tied up in, Ten's of millions of dollars just got flushed down the toilet because House speaker Steve Crisafulli (Dist 51) threw a hissy fit and shut's it down. What's wrong with him? Do your job, how hard is that?

Now the FIDOC will remain under staffed, no body camera's, which would have brought some protection to me. Cause all this

We need some changes here in P-Dorm. We need new recreation sqts, we need new law library sqt. just for a start. We need cameras placed on the quarter deck, main hall, property room, stair case in the back of the wings, where we go out to recreation. We need audio recording devices placed in all of these areas, as well. We need this place totally revamped, cause right now, this is a dangerous situation. Inmates are mad with me, because it's been announced, that there's a freeze on cell moves, because of my blog.

We have pay to play, on everything we do around here. This has got to be stopped.

I was assaulted by Correctional Officers in May 2012 because of this blog, and because I write about the unethical corrupt staff here. And before they assaulted me, the sqt. said "Blog about this!" and they beat me down. And I've blogged about it time, and time, and time again. I followed that sqt's instructions. And everything that I've written here, if you have a problem with my credibility, please bring out a polygraph or voice stress analysis examiner. I'm more than willing to submit to it.

Here now, I have sqt. Trey going around with pages from my blog showing them to other staff members and inmates. This same

sgt brought Razor Blades into P-Dorm, death row housing on September 1, 2011 and used them to set me up, with a D.R. weapon charge. yes, a weapon that he introduced into a maximum security death row unit! And I'll challenge him to a polygraph exam on this. Cause this, is where he and I fell out. When I witnessed that he had about as much honor and integrity, as a Nazi in a Jewish concentration Camp. The Officer "Bear" who was in my cell P-4105, when he set me up with the Razor Blades, wouldn't even back the sgt. up on the lie. Bear also would not come forward on my behalf, for he knew he would have faced retaliation.

We have some Officers here, who are ethical who have honor and integrity. I'd love to give them a shout out, but if I put their names in here, they will face ridicule, so I don't dare expose them, to the rotten coppers, that exist here in UCA and in P-Dorm.

This is just the hard core reality, of the corruption here in your Dept. I hope and pray that you can fix this, because we are relying on you since the House of Representatives dropped the ball on SB-7020. May God bless you, and keep you strong to do this difficult task of weeding out the unethical immoral staff and their conduct that's unbecoming the Florida Dept. of Corrections. Thank you.
