- MEMORIAL DEDICATIONS TO BE HELD / HOG TROTH TO FEED THE PIGS

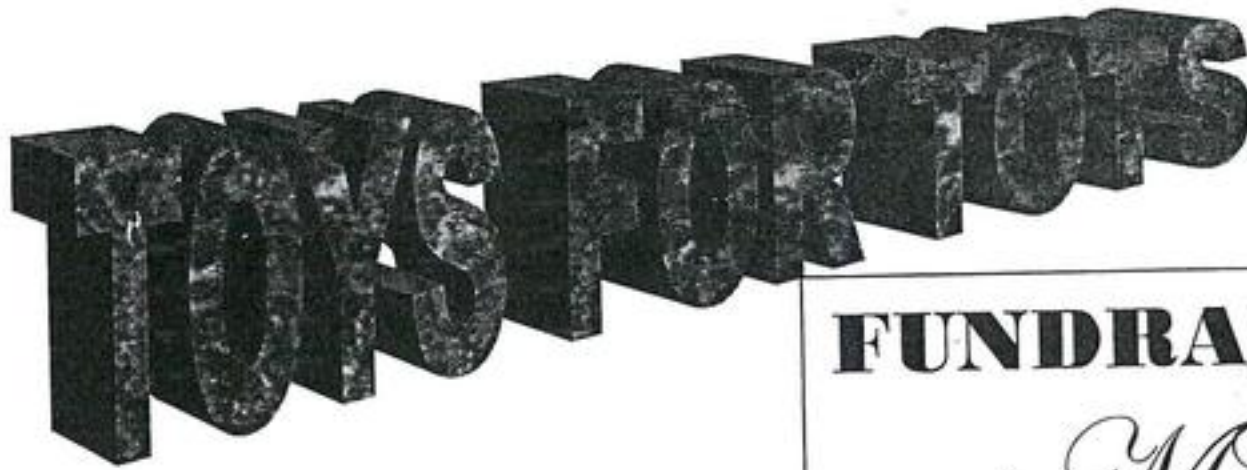
