IN "FEAR OF SEX AND THE BOOGIE MAN", I QUESTION THE AMERICAN THOUGHT PROCESS WHEN DEALING WITH SEX, SEXUAL DEVIANCY AND SOCIATAL INDIGNATION. THIS MAY NOT BE SUITABLE READING FOR ANYONE WHO BELIEVES IN SHOOTING FIRST AND ASKING QUESTIONS LATER, OR THAT DWAYNE "THE ROCK" JOHNSON SHOULD HAVE RECEIVED A BEST ACTOR NOD FOR "FAST SIX".

"EXECUTIONERS" PART 2, WILL COMPLETE THE "STRANGE BEDFELLOWS" SERIES, WITH MY OBSERVATIONS OF PROGRAMS, STAFF AND INTERACTIONS WITH INMATES AND OTHER STAFF, AS WELL AS HOW THEY HANDLE VARIOUS SITUATIONS, I HOPE TO SHOW HOW PHILIP ZIMBARD'S 1971 "STANFORD PRISON EXPERIMENT" IS PLAYED OUT ON A DAILY BASIS THROUGHOUT THE AMERICAN PENAL SYSTEM,

ALSO: A SYNOPSIS AND LIST OF OVER A DOZEN BOOKS AND PAPERS ON THE SUBJECT OF AMERICAN PUNISHMENT, THAT ARE SURE TO ENLIGHTEN AND POSSIBLY SHOCK, LIKE: "THE LUCIFER EFFECT: UNDERSTANDING HOW GOOD PEOPLE TURN EVIL" BY PHILIP ZIMBARD (RANDOM HOUSE-2007), THAT INCLUDES THE STANFORD EXPERIMENT, ABUSES AT ABU GARAIB AND MORE,



## "THE EXECUTIONERS" PART I

I ARRIVED AT WYATT, A PRIVATELY OWNED PRISON IN RHODE ISLAND (THAT ACTS AS A HUB FOR FEDERAL PRISONERS WHO ARE IN TRANSIT OR BEING DEPORTED), ON OCTOBER 30, 2007. AFTER SPENDING 3 WEEKS IN A DORM, I WAS MOVED TO A P.C. (PROTECTIVE CUSTODY) UNIT, AFTER BEING THREATENED. WHEN MY MONEY FINALLY TRANSFERRED FROM THE STATE FACILITY (ABOUT 2 WEEKS LATER), I WAS ABLE TO ORDER \$80 WORTH OF COMFORT ITEMS (COFFEE, TEA, A BOWL, CUP, HYGIENE ETC.), AND A #10 RADIO FOR \$55, FROM COMMISSARY. THE GUARD ON DUTY SAID THAT I WOULD BE ABLE TO TRANSFER WITH EVERYTHING WHEN I WENT TO FORT DEVENIS IN A COUPLE OF WEEKS. 4 A.M. THE NEXT MORNING THE OVERNIGHT GUARD TOLD ME THAT I WAS BEING SHIPPED TO BROOKLYN AND WOULDN'T BE ALLOWED TO TAKE ANYTHING. HE DID LET ME LEAVE IT WITH A YOUNG MAN WHO WAS INDIGENT.

FROM BROOKLYN, I WAS SHIPPED TO FORT DIX, NEW JERSEY ON 12-11-07 (MY 59<sup>TH</sup> BIRTHDAY), WHERE AFTER RECEIVING MY UNIT \* BEDROLL ETC., I WAS TAKEN FROM THE GRAB THAT I CAME IN WITH, TOLD TO STRIP, GIVEN AN ORANGE JUMP SUIT AND TAKEN TO THE S.H.U. (SPECIAL HOUSING UNIT), OR THE HOLE AS IT'S REFERED TO. I WAS RIDICULED, PRODDED AND DEPRIVED OF HEAT AND PROPER TREATMENT UNTIL 01-01-08, BECAUSE THEY DISCOVERED THAT I WAS IN THE WRONG PLACE. ONE GUARD THREW FLASH GRANADES INTO EMPTY CELLS AT 2 A.M. ON CHRISTMAS AS A SICK JOKE. FROM THERE I WENT TO ALLENWOOD PA, WHERE AFTER 6 MONTHS, I WAS FORCED INTO THE S.H.U AFTER BEING THREATENED BY A GROUP OF "HATERS" KNOWN AS THE DIRTY WHITE BOYS WHO WERE GIVEN A LIST OF SEX OFFENDERS BY A GUARD. 5 TORTUROUS MONTHS LATER, I WAS SHIPPED TO F.C.I MARIANNA IN FLORIDA VIA ATLANTA (THE WORST PLACE OF ALL), AND TALLAHASSEE, WHERE I WAS TREATED WITH RESPECT AND DECENCY FOR THE FIRST TIME SINCE I ENTERED THE FEDERAL SYSTEM.

I STILL SIT IN MARIANNA, AWAITING THE F.B.O.P. AND THE 2ND COURT OF APPEAL'S NEXT MOVE. THIS FACILITY, LIKE ANY OTHER BUREAUCRATIC INSTITUTION, IS FRAUGHT WITH INCONSISTANCIES, INCOMPETENCE AND IGNORANCE; HEMORAGING TAX DOLLARS, WHILE EXACERBATING AN ALREADY UNSTABLE SOCIAL ORDER. IMAGINE A SMALL TOWN OF ABOUT 2,000 PEOPLE BEING RUN BY THE LOCAL BLOCK WATCH COMMANDER. THIS WAS MY FIRST IMPRESSION, AND AFTER 6 YEARS IT HASN'T CHANGED MUCH. TO BE FAIR SOME STAFF MEMBERS HERE ARE AS FRUSTRATED AS I AM, WITNESSING ALL OF THE WASTE AND IGNOMINIOUS INEXPERIENCE THAT APPEARS TO EXIST AT ALL LEVELS OF FEDERAL EMPLOYMENT, BUT I'LL REVISIT THIS LATER.

I FORGOT TO MENTION THE TRANSPORT PROCESS, WHICH IS THE MAIN REASON THAT I HAVEN'T TRANSFERRED TO A LOW SECURITY FACILITY IN THE LAST 4 YEARS. I STOOD ON A TARMAC NEAR ALLENWOOD FOR 30 MINUTES IN 22° WEATHER, WEARING A T-SHIRT, BOXERS, PAPER PANTS AND SOCKS, WAITING TO BOARD A McDONALD DOUGLAS 80 JET THAT HAD ACTUAL DUCT TAPE ON THE WINGS. WE FLEW TO ATLANTA, GA WHERE I SPENT 5 DAYS, FREEZING IN A CELL, ON A COLD STEEL BUNK (NO MATTRESS), 1 SHEET AND 1 THIN, VERY SHREDDED BLANKET. THERE WERE LARGE RATS OUTSIDE OF THE CELL AND LOTS OF LARGE COCK ROACHES INSIDE. THE GUARDS SEEMED LIKE THE CASTING CALL FOR COOL HAND LUKE AND THE FOOD WAS ALMOST UNEDIBLE. THE TORTUROUS BUS TRIP TO TALLAHASSEE BY WAY OF USP-1, USP-2, FCI AND FCC COLEMAN IN SOUTH CENTRAL FLORIDA DIDN'T IMPROVE THE SITUATION MUCH.

WHEN EVER YOU ENTER OR LEAVE A PRISON, IT'S THROUGH R+D (RECEIVING + DEPARTURE), WHERE YOU ARE STRIP SEARCHED SHOWING THE GUARD YOUR HANDS, FEET, HAIR, ANUS AND UNDER YOUR TONGUE AND SCROTUM (BASICALLY WHERE EVER A SHANK, CELL PHONE OR SMALL NUCLEAR DEVICE CAN BE HIDDEN). WHEN LEAVING, YOUR HANDS ARE SHACKLED TO A WAIST BELT, THEN TO LEG IRONS WITH A 3 FOOT CHAIN. THIS PROCEDURE IS DONE TO EVERYONE, INCLUDING DISABLED, BLIND, OLD AND EVEN DECEASED (WALKING DEAD). WHEN ENTERING AND AFTER YOU'RE SEARCHED, YOU ARE ISSUED A DIFFERENT SET OF CLOTHES, PHOTOGRAPHED, ASKED MEDICAL AND OTHER QUESTIONS THAT YOU'VE ALREADY ANSWERED AT EVERY FACILITY YOU'VE STOPPED AT ALONG THE WAY. YOU'RE THEN ASSIGNED A UNIT, CELL AND BUNK, AND DISCHARGED TO THE COMPOUND, AND LAUNDRY TO PICK UP YOUR 4 SETS OF KHAKIS, T-SHIRTS, BOXERS AND SOCKS, 2 EACH TOWELS, WASH CLOTHS, SHEETS AND ALLOWANCES, 1 BLANKET AND A PAIR OF BOOTS DESIGNED FOR THE MARQUIS DE SADE. ON TO THE UNIT, WHERE THE UNIT COUNSELLOR EXPLAINS THAT YOU HAVE NO RIGHT TO PRIVACY OR MUCH ELSE, THEN GIVES YOU 2 ENVELOPES, 2 PIECES OF PAPER, 1 TOOTH BRUSH, 1 TUBE OF TOOTHPASTE, 1 DISPOSABLE RASOR AND A 4 OZ. BOTTLE OF BOB'S BARKER "MAXIMUM SECURITY" ALL-IN-ONE SHAVE, SHOWER AND SHAMPOO, THAT HAS THE WARNING: DO NOT APPLY TO BROKEN SKIN, IF RASH OR IRRITATION DEVELOPS, DISCONTINUE USE, ON THE BOTTLE. YOU'RE THEN GIVEN A COPY OF THE F.C.I. HANDBOOK; A SCALD DOWN VERSION OF THE F.B.O.P. PROGRAM STATEMENT, A VALUAMOUS COMPILATION OF RULES AND REGULATIONS THAT ARE CONSTANTLY IGNORED, ALTERED AND MISQUOTED TO ARBITRARILY CONTROL ANY GIVEN SITUATION.

FINALLY, YOU ENTER YOUR CELL, A 6 FT. BY 11 FT. ROOM CONTAINING 3 STACKED BUNKS (IN A 1 PERSON CELL), 3 LOCKERS (TAKING UP 3 SQ FT. EA), AN 18" BY 56" DESK, A TOILET, A SINK AND 3 PLASTIC CHAIRS. THE BOB BARKER MATTRESS IS 30" X 70" X 4" WHEN NEW, BUT SOON BECOMES A 2 1/2" BRICK. MY FIRST CELL MATE THERE, WERE A 32 YEAR OLD MEXICAN ILLEGAL IMMIGRANT AND A 19 YEAR OLD SKIN HEAD WANNABE, WHO AFTER FINDING OUT MY CHARGE, WENT TO THE ARYAN SHOT CALLER, WHO ARRANGED FOR ME TO MOVE TO ANOTHER CELL AND SHORTLY AFTER, HAVE MY RADIO, HEADPHONES AND OTHER PROPERTY STOLEN. I WAS LATER TOLD BY SEVERAL, BALD, SEVERELY TATTOOED, MONOSYLLABIC CAUCASIAN INMATES, WHERE I COULD SIT, STAND, EAT OR WATCH TELEVISION, ALL WITHIN MY FIRST 4 DAYS, WITHIN SIX MONTHS I WAS BEFRIENDED BY THE TOUGHEST "HATER" ON THE COMPOUND, AFTER HE HAD SOMEONE CHECK MY PAPERS TO FIND THAT I WASN'T SOME CHILD RAPING MONSTER, AND SOON I WAS HELPING HIM TO WRITE HIS MEMOIRS, A MUST READ IF HE EVER PUBLISHES.

THE LAST 8 YEARS HAVE SEEN DECADES OF STRUCTURAL INCLUSION, CROMISLE UNDER THE WEIGHT OF KINE-JERK REACTIONS TO AVOID ISSUES, CRAFTED BY INCREDIBLY POOR JUDGEMENT, PLANNING AND EXECUTION. INANE POLICIES, PUNISHMENTS AND CONTROLS THAT GIVE IN TO INTOLERANCE AND FEAR, OFTEN CAUSING EMOTIONAL RIFTS THAT DIMINISH SECURITY AND SAFETY LEVELS FOR EVERYONE. I FIND IT AMAZING THAT A WORLD POWER SUCH AS THE UNITED STATES CAN FOSTER A PENAL SYSTEM THAT WOULD PROBABLY CRASH IF NOT FOR THE MASSIVE INJECTIONS OF TAX DOLLARS, THERE IS SO MUCH BULLSHIT AND DECEPTION COMING FROM BOTH INMATES AND STAFF THAT I CAN ONLY DRAW OPINIONS BASED ON PERSONAL EXPERIENCES, OBSERVATIONS OR CONSISTENCY OF STORIES. EVEN INFORMATION GAINED THROUGH INTERVIEWS OFTEN SEEMS CONTRIVED OR ILLUSORY. I BELIEVE THAT ANY ATTEMPT AT UNDERSTANDING THE SYSTEM, SHOULD BEGIN WITH A LOOK AT ITS HUMAN COMPONENTS, SO I'LL BEGIN WITH MY FELLOW INCARCERATES.

I'VE OFTEN SAID THAT NO ONE SHOULD BE INCARCERATED UNLESS THEY'VE CAUSED COMMENSURATE PHYSICAL OR FINANCIAL HARM, AND FROM WHAT I CAN GATHER, ABOUT 20% OF THOSE HERE ARE CONSIDERED VIOLENT GANG MEMBERS, MURDERERS, RAPISTS, THIEVES AND CON MEN. THE REST ARE MADE UP OF ILLEGAL ALIENS, NATIVES (ANY CRIME BECOMES FEDERAL), THOSE HERE FOR GROWING, PROCESSING AND/OR SELLING VARIOUS MOOD ALTERING SUBSTANCES, OR FOR A VARIETY OF CHARGES DEALING WITH AGE-IRRELEVANT SEXUAL ACTIVITY AND/OR MANUFACTURING, DISTRIBUTING OR MERELY VIEWING OR POSSESSING CHILD PORNOGRAPHY. IT'S INTERESTING TO NOTE THAT AMONG THE MOST VIOLENT FELONS, SEX RELATED OFFENCES INVOLVING MINORS, NO MATTER HOW BENIGN, ARE CONSIDERED MORE HEINOUS THAN MURDER OR RAPE. THESE INDIVIDUALS REFUSE TO ACCEPT THAT ABUSING THEIR OWN CHILDREN IS NOT GOOD PARENTING, AND DRUG DEALERS DON'T WANT TO ADMIT THAT THE CRACK, HEROIN, METHAMPHETAMINE AND ECSTASY THAT ENDS UP ADDICTING, OVERDOSING AND KILLING SO MANY CHILDREN AND YOUNG PEOPLE EACH YEAR, EITHER DIRECTLY OR INDIRECTLY CAME FROM PEOPLE LIKE THEM.

HATERS (SLANG FOR WHITE SUPREMACISTS, ARYANS, SKINHEADS ETC.), WHO SEEM TO ENJOY TRYING TO PIT ETHNIC, SOCIAL AND SOCIO-RELIGIOUS GROUPS AGAINST EACH OTHER, ARE PROBABLY THE BIGGEST THREAT TO SECURITY. MOST GANGS SEEM TO TOLERATE EACH OTHER WITH FEW ISOLATED FLAIR-UPS AT THIS FACILITY, HOWEVER, ANY INDIVIDUAL OR GROUP WHO LACK INTELLECT AND HAVE AN ABUNDANCE OF ANGER ISSUES, WOULD BE CONSIDERED PRIMED FOR CONFRONTATION. GENERALLY SPEAKING, MOST OF THE INMATES AT THIS FACILITY ARE PASSIVE, HAVING LITTLE OR NO INCLINATION TOWARD VIOLENCE OR ESCAPE, AND THEREFORE COULD EASILY BE HOUSED AT A CAMP OR LIVING PRODUCTIVE LIVES OUTSIDE, THAT COULD BENEFIT INSTEAD OF TAXING SOCIETY. MONITORING SYSTEMS LIKE D.E.M.M.S. SHOULD BE MORE THAN SUFFICIENT TO QUEL THE PUBLIC'S CONCERNS. THOSE THAT CROSS OUR BORDERS FROM THE SOUTH, CAN FIND THEMSELVES DOING FROM 5 TO 15 YEARS AT \$83 DOLLARS PER INMATE PER DAY, INSTEAD OF A \$15 BUS TICKET TO SEND THEM BACK HOME.

MANY FIND IT DIFFICULT NOT TO BECOME INSTITUTIONALIZED, AS THE CONDITIONING PROCESS BEGINS WHEN THEY ARE PUT INTO A SYSTEM THAT REMINDS YOU DAILY THAT INTELLECT, HONOR AND HUMANITY HAVE LITTLE VALUE HERE, WHILE PREACHING THE OPPOSITE. THOSE WHO COME FROM USP'S (HIGH SECURITY PRISONS), ARRIVE WITH DEEPLY EMBEDDED ISSUES THAT TEND TO AMPLIFY AN ALREADY HOSTILE ENVIRONMENT WITH LITTLE HELP FROM THE STAFF WHO SEEM TO QUIETLY EMBRACE THE PRIMITIVE CONCEPT OF SURVIVAL OF THE FITTEST, A CONCEPT SHARED BY MANY INMATES WHO BOAST OF GREAT PHYSICAL PROWESS, SO MANY CLAIM TO BE NAVY SEALS, GREEN BERT OR SPECIAL FORCES, AS WELL AS INCREASED INTELLECTUAL CAPACITY THAT THEY SURPRISINGLY KEEP WELL HIDDEN, CONSIDERING THE INCREDIBLY HIGH NUMBER OF INMATES WHO CLAIM TO HAVE IQ'S IN EXCESS OF 150 AND

EVEN 180, AND FACTORING IN APPROXIMATE NATIONAL AVERAGES (LIKE THAT WOULD MATTER), WE CAN ONLY ASSUME THAT:

- A. THE FEDERAL GOVERNMENT IS SECRETLY ROUNDING UP THE MOST BRILLIANT MALES IN THE U.S. AND HOUSING THEM IN MARINA FLORIDA TO AWAIT THE APOCALYPSE.
- B. GENIUS ÷ LAWS X SOCIETY = INCARCERATION
- C. BULLSHIT ISN'T JUST FOR FERTILIZER.
- OR D. LINUS VAN PELT ISN'T THE ONLY ONE WITH INSECURITY ISSUES.

THE MOST NOTABLE ISSUE WITH INMATES, SEEMS TO CENTER AROUND A NEED TO CONTROL PHYSICAL, SOCIAL AND METAPHYSICAL ENVIRONMENTS. DEFIENCE OF AUTHORITY AND PARANOIA SEEM TO GO HAND IN HAND, AS INMATES GIVE IN TO DESIRES FOR ALCOHOL, TOBACCO, SPICE, STRIPS (SABOXIN), MARIJUANA AND OTHER DRUGS THAT IF CAUGHT, CAN GET THEM THROWN IN THE SHU, THEN LOOK AT THOSE WHO DON'T PARTICIPATE AS IF THEY'RE INFORMANTS (SNITCHES, RATS), WHO ARE BEING PAID BY THE GUARDS, THOUGH COMMUNICATION SKILLS ARE SORELY LACKING, INMATES HAVE NO TROUBLE CREATING NEGATIVE STORIES ABOUT EACH OTHER TO EITHER DEFLECT OR ATTRACT ATTENTION, OR JUST CREATE DRAMA.

LIFE OFTEN IMITATES ART HERE, AS MANY WHO ARE NEW TO INCARCERATION, TEND TO MIMIC PHYSICAL GESTURES, PICAYUNE CUSTOMS AND FALLACIOUS PHOBIAS THAT MAKE THEM APPEAR LIKE THE HARDEND PRISONERS OF MOVIES AND TELEVISION. THINGS LIKE KNOCKING ON THE TABLE TO INDICATE THAT THEY'RE LEAVING, RATHER THAN SIMPLY SAYING "SEE YA", APPARENTLY STARTED AT STATE AND FEDERAL PENITENTIARIES WHERE INMATES WEREN'T ALLOWED TO SPEAK DURING MEALS, TO SAY THAT IT'S MERELY A CASE OF MONKEY SEE, MONKEY DO IS TO OVER SIMPLIFY, AND BY THE WAY, THAT OLD MAXIM WOULD HAVE A RACIAL CONNOTATION HERE THAT COULD RESULT IN A VIOLENT CONFRONTATION. THE SAME COULD APPLY TO BUMPING INTO SOMEONE, POINTING OR STARING IN THEIR DIRECTION, SITTING OR EVEN STANDING IN THE "WRONG PLACE", OR ALMOST ANY ACTION THAT WILL GIVE ONE OF THE TROGLODYTES A REASON TO VENT THEIR PENT UP HOSTILITY ON ANYONE THAT APPEARS WEAK ENOUGH TO BULLY.

MOST ETHNIC, SOCIOCULTURAL AND SOCIOSEXUAL GROUPS TEND TO KEEP TO THEMSELVES, WITH THE EXCEPTION OF SPORTS, GAMBLING AND GAMES LIKE DUNGEONS AND DRAGONS OR MAGIC (WHICH ARE NO LONGER ALLOWED AT F.B.O.P. FACILITIES). HISPANIC GANGS ARE SAID TO BECOME OVERZEALOUS WHEN TRYING TO RECRUIT THE UNWILLING NEWCOMERS, OCCASIONALLY TO VIOLENT CONCLUSIONS, NATIVES ON THE OTHER HAND, BLEND WITH OTHERS, YET WITH AN ALOOFNESS THAT SOMETIMES SEEMS HIERARCHICAL. MANY IN THE BLACK COMMUNITIES ARE STEREOTYPICAL OF WHAT PEOPLE LIKE MARTIN LUTHER KING AND ORGANIZATIONS LIKE THE N.A.A.C.P. HAVE TRIED TO DISPEL SINCE THE TUMULTOUS CIVIL RIGHTS MOVEMENT, THE CONVERSATIONS AMONG BLACKS AND HATERS RESPECTIVELY, ARE USUALLY LOUD, ANIMATED, AND QUITE SELF CENTERED, INVOLVING FOOTBALL, BASKETBALL, DRUGS, GUNS, MONEY, CARS, SUBSERVANT WOMAN, MUSIC AND THEIR PERSONAL PROWESS IN ALL THINGS MACHO. SADLY, I HAVE YET TO OVERHEAR ANYTHING POSITIVE CONCERNING FAMILY, COMMUNITY OR HUMANITARIAN ENDEAVORS FROM EITHER GROUP. THE HISPANIC PEOPLE ARE MOST FAMILY ORIENTED, THOUGH GANG MEMBERS APPEAR TO HAVE MISPLACED LOYALTIES, AND NATIVES HAVE A GREAT DEAL OF REVERENCE FOR BOTH FAMILY AND TRADITION. EDUCATIONAL LEVELS VARY GREATLY HERE, HOWEVER THE HIGH LEVELS OF ILLITERACY DISPLAYED BY MANY ON BOTH SIDES OF THE BARS, DON'T EXCUSE THE ANGER, PREJUDICE AND HOSTILITY THAT IVE OFTEN OBSERVED.

SEX OFFENDERS (WHO AREN'T HIDING AMONG THE OTHER GROUPS), TEND TO BE HETEROGENEOUS, CONGREGATING MORE OUT OF NECESSITY THAN DESIRE, THE SOCIOCULTURAL SIGNATURES RUN THE SPECTRUM FROM FUNCTIONALLY ILLITERATE TO HIGHLY EDUCATED, WITH COEXTENSIVE SKILL LEVELS, THE FEW THAT HAVE ACTUALLY FORCED OR COERSED SOMEONE INTO SEX, APPEAR TO FALL STEREOTYPICALLY WITHIN THE LOWER LEVEL OF THE SPECTRUM, WITH VERY FEW EXCEPTIONS, AND ARE DIPLOMATICALLY AVOIDED BY THE MAJORITY, THAT SAME MAJORITY (MYSELF INCLUDED), SEE THEMSELVES AS POLITICAL PRISONERS FIGHTING THE BUND INDIGNATION OF A SYSTEM DEVOID OF REASON, BEING MANIPULATED BY A POLITICAL/MEDIA JUGGERNAUT, DESIGNED TO GENERATE VOTES AND ADVERTISING REVENUE, USING MCCARTHYISTIC FEAR TACTICS THAT WILL GAIN PUBLIC SUPPORT FOR OUTRAGEOUS LAWS THAT ULTIMATELY HARM EVERYONE (SEE "FEAR OF SEX AND ENLIGHTENMENT" COMING UP NEXT), MOST SHARE MY ANGER AND FRUSTRATION OVER THE HARSH SENTENCES IMPOSED USING THESE IMPETUOUS LAWS THAT ARE BASED ON THE SUPPOSITION OF HARM, WHILE THE HIGH PROBABILITY OF REAL HARM INFLECTED ON THE SO-CALLED VICTIMS, AND ALL INVOLVED PARTIES BY THE DUPUCITUS JUSTICE SYSTEM ITSELF IS BEING IGNORED OR SIMPLY VIEWED AS COLLATERAL DAMAGE IN THIS DESTRUCTIVE WITCH HUNT.

NO MATTER WHAT THE REASON FOR BEING HERE, INMATES ARE FORCED TO DEAL WITH A SYSTEM WHOSE STRUCTURE APPEARS TO BE BUILT AROUND CONJECTURE, DECEPTION AND A POLITICAL CORRECTNESS THAT SMUCKS IN THE FACE OF REASON. THIS INCESSANT LABYRINTH OF CONTRADICTION OFFER LITTLE HOPE THAT THOSE IN NEED WILL BE ABLE TO OBTAIN THE TANGIBLE SOCIAL OR ENVIRONMENTAL SKILLS NEEDED TO MAINTAIN A PRODUCTIVE LIFE ON THE OUTSIDE. THE RESPONSIBILITY FOR THIS FAILURE MUST LIE WITH THOSE POLICY MAKERS WHO SEEM TO HAVE LITTLE KNOWLEDGE OR EXPERIENCE OUTSIDE OF THE COMMITTEE ROOM, APPEARING TO BE MORE CONCERNED WITH DOING THE MINIMUM TO MEET FUNDING REQUIREMENTS THAN REHABILITATION. THERE ARE ALSO TOO MANY INDOLENT, UNQUALIFIED STAFF MEMBERS HINDERING THE LITTLE PROGRESS MADE BY THOSE WHO ARE DEDICATED, BY REJECTING PROJECTS OR IDEAS THAT AREN'T THEIR OWN; SOMETHING I REFER TO AS THE N.I.H. FACTOR (NOT INVENTED HERE).

### RULES

THE RULES HERE ARE AS DESPOTIC AS MOST LAWS, WITH ALL OF THE INCONSISTANCY, INFLEXIBILITY AND INJURIOUS CONTEMPT FOR REASON THAT HAS BROUGHT THIS COUNTRY TO THE POINT WHERE EVEN THE SPOKEN OR WRITTEN WORD MAY SOON BE IN JEOPARDY. WHEN YOU'RE UP AGAINST A CONSTANT BARAGE OF INCONGRUOUS EDICTS, DESIGNED MORE AS A DISPLAY OF AUTHORITY THAN AN INTELLIGENT MEANS OF REGULATING SECURITY, SAFETY AND SANITATION (THE ONLY STATED COMPONENTS FOR DISPENSING DISCIPLINE), HOPELESSNESS BECOMES THE ONLY REALITY. ONE DISTURBING TREND IN THE PENAL SYSTEM IS THE USE OF COLLECTIVE PUNISHMENT, WHERE MANY ARE PUNISHED FOR THE ACTIONS OF ONE OR A FEW. THIS IS NOT ONLY UNJUST, BUT CAN BE VIEWED AS AN ATTEMPT TO ENCOURAGE RETALIATORY ACTION, SUBORNING VIGILANTISM. IN WHAT APPEARS TO BE A FUTILE ATTEMPT TO STOP EVEN MINOR RULE INFRINGEMENTS, IS OFTEN AS BAD OR WORSE THAN THE INFRINGEMENTS THEMSELVES, USUALLY ELEVATING AN ALREADY INJURIOUS ADVERSARIAL RELATIONSHIP BETWEEN INMATE AND STAFF. THIS CREATES ADDED TENSION AND INCREASES THREAT LEVELS FOR ALL. I GIVE CREDIT AND DUE RESPECT TO WARDEN PAIGE AUGUSTINE, WHO ACQUIESCED TO REASON, WHEN SHE REALIZED THE COUNTERPRODUCTIVE ASPECTS INHERENT WITH COLLECTIVE PUNISHMENT, GOING AS FAR AS POSTING A MEMO SAYING THAT AS LONG AS SHE IS WARDEN, THERE WILL BE NO MORE COLLECTIVE (MASS) PUNISHMENTS AT THE MAXWELL FCI. THIS UNFORTUNATELY ENDED WHEN SHE LEFT, ONE YEAR LATER.

MOOD ALTERING SUBSTANCES SUCH AS ALCOHOL, CRACK, SPACE ETC., COMMUNICATION DEVICES, FIGHTING AND WEAPONS OF ANY KIND ARE THE MAIN TARGETS FOR DISCIPLINARY ACTION, WITH TATTOOING, CIGARETTES, SEX, PORNOGRAPHY AND GAMBLING NEXT IN LINE. THE COMBINATION OF MOOD ALTERING SUBSTANCES, WEAPONS AND ALMOST ANY ACTIVITY INVOLVING MORE THAN ONE PERSON, COULD EASILY LEAD TO VIOLENCE GIVEN THE ALREADY HIGH TENSION LEVEL HERE, WHILE OTHER MORE INNOCUOUS SITUATIONS SEEM TO BE USED AS AN UNREASONABLE EXHIBITION OF POWER AS IF TO PUNISH FOR SPITE. THE MESSAGE IS CLEAR THAT GUARDS AND OTHER STAFF ARE ALLOWED TO ACT AS THEY PLEASE, WITH FEW RESTRAINTS, AND RULES CAN BE ADAPTED TO SUIT THEIR DESIRES. SOME HOWEVER, ARE RESPECTFUL OF INDIVIDUALS WHO DON'T CAUSE PROBLEMS, AND THE ABSURDITY OF MOST OF THE RULES, OPTING TO OVERLOOK THOSE INDISCRETIONS THAT POSE NO THREAT TO SECURITY, SAFETY OR SANITATION. SMOKING IS BAD; SMOKING DICED AND ROLLED CHEWING TOBACCO THAT GUARDS HAD SPIT INTO WATER BOTTLES, TRASH CANS AND ON THE GROUND, IS JUST NASTY. THE USER NEEDS TREATMENT, NOT PUNISHMENT. TATTOOING BRINGS ITS OWN SANITARY ISSUES THAT OTHER COUNTRIES DEAL WITH BY OFFERING IT AS VOCATIONAL TRAINING; CONTROLLING INK QUALITY, HYGIENE AND SAFETY,

RULES LIKE HAVING TO WEAR ISSUED BOOTS (THAT HAVE CAUSED MEDICAL PROBLEMS AND WERE DECLARED WEAPONS AFTER A 2010 GANG FIGHT), FROM 7:45 AM TO 4:00 P.M, MONDAY THROUGH FRIDAY UNLESS YOU HAVE A MEDICAL/SOFT SHOE PASS, IS ABSURD. OTHERS LIKE SHIRTS TUCKED IN, NOT WEARING GLOVES OUTSIDE (WHAT?), SHOES POINTED TOES OUT UNDER BUNKS, BEDS MADE TO MILITARY SPEC, ONLY RELIGIOUS BOOKS ON DESKS (NONE ON BOOK SHELVES OVER THE SINKS), NO PICTURES OR ARTICLES CUT FROM MAGAZINES OR NEWSPAPERS, NO PILLOWS OR MAKESHIFT PILLOWS (ALL WERE TAKEN AFTER ISSUING EXTREMELY UNCOMFORTABLE BOB BARKER MATTRESSES WITH SLIGHT BUILT IN PILLOWS), ARTWORK AND GROCERY ITEMS ARE TO BE SENT OUT WHEN COMPLETED (NOT HUNG OR USED IN YOUR CELL), AND THE FOOD THAT YOU RECEIVE IN THE CHOW HALL MUST BE CONSUMED OR DISCARDED BEFORE LEAVING; NOTHING CAN BE TAKEN BACK TO THE UNIT. THERE IS NO SLEEPING DURING THE DAY (EVEN IF YOUR JOB BEGINS AT 4 AM), OR EVEN LYING IN YOUR BUNK, LISTENING TO MUSIC OR READING, AND NO VISITING AT ANY TIME. WHILE THERE MAY HAVE BEEN INITIAL REASONS FOR SOME OF THESE RULES, STAFF EITHER REFUSES TO EXPOND OR CAN'T BECAUSE THEY DON'T KNOW,

RULES DEALING WITH ANY ASPECT OF SEX APPEAR TO PLAY A DOMINANT ROLE IN THE UNITED STATES PRISON SYSTEM, WHERE MOST PROGRESSIVE COUNTRIES UNDERSTAND AND ACCEPT THE FACT THAT BOTH MALES AND FEMALES WHO ARE INCARCERATED (FROM YOUTH CAMPS TO PENITENTIARIES), WILL FIND WAYS TO SATISFY SEXUAL URGES, EVEN OFFERING CONDOMS AND CONJUGAL VISITATION, OUR JUSTICE DEPARTMENT HAS CHOSEN TO DEFEY NATURE IN FAVOR OF TORTUROUS CONDEMNATION. HOMOSEXUAL ACTIVITY OF ANY KIND, CAN GET BOTH PARTICIPANTS THROWN IN THE S.H.U. FOR OVER A MONTH, LOSS OF PHONE AND COMMISSARY PRIVILEGES, 2 MAN CELL, JOB AND GOOD TIME. EVEN MASTURBATION COULD RESULT IN DISCIPLINARY ACTION, PORNOGRAPHY, THAT COULD ACTUALLY REDUCE PROMISCUITY AND TENSION, WHEN USED FOR MASTURBATION AS INTENDED, HAS BEEN ALL BUT ELIMINATED, AS INCOMING MATERIAL HAS BEEN GRADUALLY REDUCED FROM HARD CORE, TO SOFT CORE (PLAYBOY/PLAYGIRL), TO "MAXIM". THIS DISTORTED THINKING PROCESS HAS ELEVATED THE "COOKIE JAR EFFECT" TO THE POINT WHERE VICTORIA SECRET COMMERCIALS INCITE CAT CALLS, AND POORLY PHOTOGRAPHED IMAGES OF SCANTILY CLAD YOUNG WOMEN AND MEN FROM ON-LINE COMPANIES TAKING ADVANTAGE OF POLICY CHANGES, HAVE BECOME THE NEW PORNOGRAPHY. EVEN CUT-OUTS OF STARS AND THEIR FAMILIES AT THE BEACH, FROM US AND OK MAGAZINES AS WELL AS CLOTHING CATALOGS AND TRAVEL BROCHURES THAT WOULD NORMALLY BE GIVEN LITTLE MORE THAN A GLANCE, ARE HIDDEN AWAY LIKE COVERED ANTIQUITIES. THE MAILROOM STAFF REJECTS EDUCATIONAL MATERIAL DEALING WITH ANTHROPOLOGY, BIOLOGY, ANATOMY OR ANYTHING THAT MIGHT HAVE NUDITY. THEY EVEN USED A MARKER TO COVER A WOMAN'S BREASTS IN AN ILLUSTRATION OF RENOUR'S "NUDE IN THE SUN" THAT WAS PART OF AN ART HISTORY LESSON, ALL OF THIS ADDS UP TO ONE SIMPLE CONCLUSION, THEY'RE CREATING MONSTERS HERE!

THE DR. FRANKENSTEIN IN THIS CASE, IS THE DEBASING, DECEPTIVE AND DEHUMANIZING FEDERALLY MANDATED SEX OFFENDER MANAGEMENT/TREATMENT PROGRAM, WHICH ALONG WITH SEX OFFENDER LAWS AND GUIDELINES, WERE QUOTED AS "COUNTER PRODUCTIVE, REPRESENTING A SERIOUS ASSAULT ON THE INTEGRITY OF PSYCHIATRY" IN A 2005 SPECIAL TASK FORCE REPORT FROM THE AMERICAN PSYCHIATRIC ASSOCIATION. ARTICLES IN U.S.A. TODAY, NEW YORK MAGAZINE, THE NEW YORK TIMES AND PUBLICATIONS, NEWS REPORTS, NOTED PSYCHIATRISTS, PSYCHOLOGISTS AND SOCIOLOGISTS FROM AROUND THE WORLD HAVE BRANDED THIS FORM OF "THERAPY" AS NOTHING SHORT OF A DECEPTIVE METHOD OF TRYING TO OBTAIN PREVIOUSLY UNKNOWN INFORMATION THAT CAN BE USED TO ADD NEW CHARGES OR TO CIVILLY COMMIT INMATES. OPPONENTS HAVE VEHEMENTLY SUGGESTED THAT INCARCERATION HINDERS THE REHABILITATION PROCESS, AND THAT ONLY INDIVIDUALLY TAILORED THERAPY, CONDUCTED IN AN ACCREDITED CLINICAL ENVIRONMENT, BY THOSE WHO SPECIALIZE IN THE FIELD OF SEXUAL DEVIANCY, CAN BE SUCCESSFUL. A DOCTORATE SEEMS TO BE THE ONLY PREREQUISITE TO INAUGURATE THE USE OF ARCHAIC REPROGRAMMING METHODS, AND ACCORDING TO THREE CHAPEL ORDERLIES, VERBALLY ABUSE ASTRAGHT INMATES SEEKING HELP. THEY TOLD ME THAT AFTER THEY TOLD THE PSYCHOLOGIST THAT AN INMATE WAS AT THE GATE, FRANTICALLY ASKING TO SPEAK TO HER, SHE CAME OUT TO THE GATE ASKING THE INMATE WHAT HE WANTED, AFTER A COUPLE OF BACK AND FORTH'S, HER SAYING THERE WAS NO ONE THERE TO TALK TO HIM, AND HIM INSISTING THAT HE WAS HAVING PROBLEMS, SHE PRESSED HER FIST AGAINST HER CHEEK AS IF GETTING READY TO SIGN, THEN MIMICING A SPEECH/HEARING IMPAIRED PERSON, SLOWLY SAID "CAN'T YOU UNDERSTAND, THERE IS NO ONE HERE, NOW GO AWAY!" THIS COULD EXPLAIN WHY SHE AND OTHERS ARE WORKING FOR A FRACTION OF WHAT PSYCHOLOGISTS, DOCTORS, NURSES AND TECHNICAL STAFF COULD MAKE OUTSIDE, OUTSIDE OF COURSE, SHE COULD LOOSE HER LICENSE TO PRACTICE, BUT ALAS, THE FEDERAL GOVERNMENT DOESN'T REQUIRE MEDICAL LICENCES, OR TEACHING CERTIFICATES TO HOLD POSITIONS OF RESPONSIBILITY (ACCORDING TO THE DIRECTOR OF THE FLORIDA HEALTH DEPARTMENT).

WHAT EVER THEIR POSITION, STAFF ARE ACTUALLY PROUD TO STATE THAT THEY ARE CORRECTIONS OFFICERS FIRST, AND ONLY WHEN ASKED, ARE INMATES INFORMED THAT THE F.B.O.P. AND THE DEPARTMENT OF JUSTICE DO NOT HONOR DOCTOR PATIENT PRIVILEGE. ONE OF THE SO CALLED THERAPISTS HERE, WAS A VICTIMS ADVOCATE (TALK ABOUT CONFLICT OF INTEREST), THAT INMATES REFER TO AS "THE ANGRY LITTLE TROLL WITH IDENTITY ISSUES" WAS REPORTED TO HAVE REFERED TO SANTA CLAUSE AS A PEDOPHILE (AT LEAST SHE STILL BELIEVES) AND HOMOSEXUALITY AS A PERVERSION. IT SHOULD BE NOTED THAT FAITH BASED, SUPERNATURAL BELIEFS PLAY A MAJOR ROLE IN THE LIVES OF MOST OF THE PEOPLE HERE IN WHAT'S KNOWN AS "THE SOUTHERN BIBLE BELT", HOWEVER THIS DOESN'T EXCUSE THE LACK OF SCIENTIFIC AND PROFESSIONAL INTEGRITY OR OF THE INABILITY TO REASON, SO OFTEN EXHIBITED BY MANY STAFF MEMBERS HERE. WITH THE ACCEPTION OF A FEW DEDICATED PROFESSIONALS AND ONE OUTSPOKEN NURSE, MEDICAL NEGLIGENCE GOES UNCHECKED, LITERALLY COSTING LIFE AND LIMB AFTER IGNORING THE ORDERS FOR PROMPT MEDICAL OR SURGICAL PROCEDURES BY OUTSIDE SPECIALISTS, WHEN ASKING A

SIMPLE QUESTION AT "MAINLINE" (OUTSIDE OF THE CHOW HALL AT LUNCHTIME), WHERE MEDICAL AND OTHER STAFF ANSWER QUESTIONS, OR THROUGH INTER-COMPOUND E-MAIL, INMATES ARE TOLD TO COME TO SICK CALL, JUST SO THEY CAN CHARGE SOMEONE MAKING 12 CENTS PER HOUR, A \$2 CO-PAY (THE EQUIVALENT TO A MINIMUM WAGE EARNER OUTSIDE PAYING \$125.00), YOU DON'T WANT TO HAVE A HEART ATTACK UNLESS YOU'RE IN THE MEDICAL BUILDING AT THE TIME. AFTER LOCK-DOWN AT NIGHT, THERE IS ONLY ONE GUARD FOR 2 UNITS, WHO DOES A WALK THROUGH EVERY COUPLE OF HOURS, BUT WILL NOT OPEN A DOOR WITHOUT ANOTHER GUARD, EVEN IF BLOOD OR OTHER SIGNS OF EMINENT PERIL ARE PRESENT. IF AN INMATE USES CPR ON ANOTHER, HE RISKS GOING TO THE SHOE AND GETTING A SHOT FOR TOUCHING ANOTHER INMATE, EVEN IF HE SAVES A LIFE.

THE TWO MEANS FOR DISPENSING PUNISHMENT ARE THE D.H.O. (DISCIPLINARY HEARING OFFICER), WHO ADMINISTERS PUNISHMENT TO THOSE WHO RECEIVE 100 OR 200 SERIES SHOTS, AND U.D.C. (UNIT DISCIPLINARY COMMITTEE), CONSISTING OF THE COUNSELOR AND CASE MANAGER FROM A DIFFERENT UNIT THAN THE ACCUSED INMATE. THEY ADMINISTER PUNISHMENT TO THOSE WHO RECEIVE THE LESS SEVERE 300 AND 400 SERIES SHOTS. THE PUNISHMENTS VARY FROM BEING SHIPPED TO A HIGHER SECURITY FACILITY, EXTENDED SHU TIME, OR NEW CHARGES, TO LOSS OF GOOD TIME, PHONE AND COMMISSARY, TWO MAN HOUSING, JOB, INTERNET AND VISITING PRIVILEGES FOR A GIVEN AMOUNT OF TIME. UNFORTUNATELY, THE LACK OF IMPARTIALITY EVEN EXCEEDS THAT OF THE COURTS, AS THE SEVERITY OF THE PUNISHMENTS OFTEN SEEM TO BE DETERMINANT ON AN INMATE'S ORIGINAL OFFENSE (SEX OFFENDERS BEWARE), ETHNICITY, RELIGIOUS AFFILIATION OR SEXUAL ORIENTATION. ONE COUNSELOR TOLD ME THAT IF HE GIVES HEAVY PUNISHMENT TO AN INMATE FROM ANOTHER UNIT, THE NEXT ONE FROM HIS UNIT TO BE HEARD BY THEIR U.D.C., WILL PROBABLY BE HIT AS HARD OR WORSE, EVEN IF THE SHOT HAS LITTLE MERIT.

### EPITAPH

AT APPROXIMATELY 8:30 AM., ON MARCH 16, 2015, STEVEN LYNN MOUTON, A 62 YEAR OLD MUSICIAN, MICROBIOLOGIST, SCHOLAR AND INMATE AT THE MARIANNA, FLORIDA FEDERAL CORRECTIONAL INSTITUTION, HUNG HIMSELF IN HIS UNICOR WORKSHOP, FACILITATED BY WHAT HE AND MANY SAW AS EGREGIOUS AND MALICIOUS ACTS OF ABUSE BY 5 F.I.O.P. STAFF MEMBERS. ON DECEMBER 18, 2015 FAMILY PICTURES THAT HAD BEEN ON DISPLAY FOR OVER 3 YEARS, WERE TAKEN BY THE UNIT COUNSELOR ON ORDERS FROM THE S.O.M.P. (SEX OFFENDER MANAGEMENT PROGRAM), COORDINATOR, CITING POSSIBLE RISK RELEVANCE, BECAUSE HIS STEP DAUGHTER (ALSO A VICTIM) WAS IN MANY OF THEM. THE FACT THAT HIS NOW 20 YEAR OLD DAUGHTER HAD SENT SOME OF THEM DIDN'T SEEM TO MATTER, BECAUSE ON 03/12/15 (85 DAYS AFTER THE STAFF'S 24 HOUR DEADLINE), HE WAS GIVEN A SHOT, AND 4 DAYS LATER, WHATEVER WAS LEFT TO CLING TO, WAS TAKEN FROM HIM, HIS 2-MAN CALL AND JOB WERE HIS ONLY ESCAPE FROM ALL THAT IS BAD HERE, NOW TAKEN. STEVE WAS THE VERY DEFINITION OF A MODEL PRISONER WHO HAD PAID DEARLY FOR HIS OFFENCE. HIS BEAUTIFUL HOME WAS REPLACED WITH 1/2 OF A 7 BY 11 FOOT CELL, THE FAMILY THAT HE CHRISHED WAS REDUCED TO PICTURES ON A BULLETIN BOARD, HIS LUCRATIVE POSITION AS A MICROBIOLOGIST, ATTAINED AFTER YEARS OF RESEARCH AND HARD WORK WAS DIMINISHED TO REPAIRING TOOLS AND OTHER MAINTENANCE WORK AND HIS CHAIR WITH THE HOUSTON SYMPHONY REPLACED BY AN HOUR OR TWO PLAYING GUITAR IN THE RECREATION CENTER PIANO ROOM. ALL WERE TAKEN BY PEOPLE WHO SHOULD KNOW BETTER.

THIS GENTLE MAN, HIS MUSIC, HIS INTELLECT AND SAGEWY WORDS WILL BE SORELY MISSED BUT NEVER, EVER FORGOTTEN. UNTIL THE MORNING OF MARCH 16<sup>TH</sup>, HE WAS HIS REASONABLY HAPPY SELF, LOOKING FORWARD TO THE NEXT "AMERICAN IDOL", AND TELLING JOSES, NEVER IMAGINING THAT HE WOULD ACTUALLY RECEIVE PUNISHMENT FOR SUCH AN ABSURD EVENT, OR THAT HE COULD EVER BE PUSHED INTO COMMITTING SUICIDE. AT LEAST HE CAN'T BE PUSHED ANYMORE.
