Vow of Nonviolence

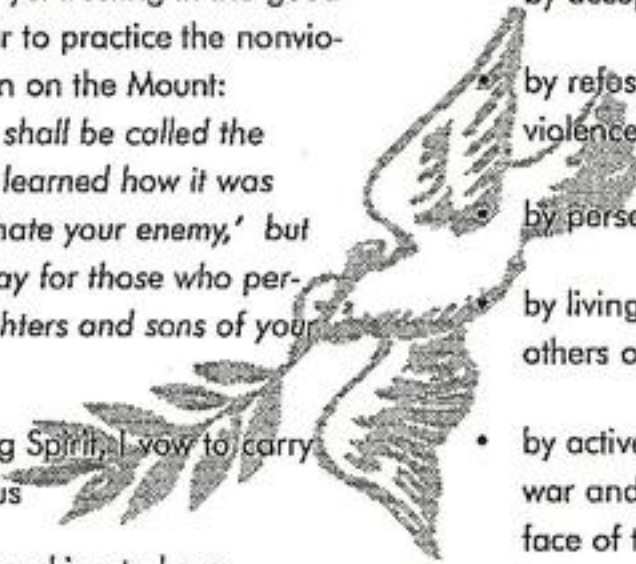
