In the 1850's it was the Virginian, George Fitzhugh, claimed slavery was of benefit to both southern whites and blacks, and said the Northern industrial workers were more insecure and exploited. It was said by some Northerners, that the Southerner is the Negro's friend: his only friend. Let no intermeddling abolitionist, no refined philosophy dissolve this friendship: from sociology for the south. (George Fitzhugh) (1854)

President Lincoln had known that racism was rampant in the North. Few soldiers wanted to spill their blood to free the slaves

This "Compromise" said congressman thaddeus stevens would. Become the Fruitful mother of the Future Rebellion Disunion And Civil WAR:
