This golf course is near many residential homes and will be a great model for prisoners to "test the reentry skills they gained at ShirleyWorld." Now many of these ex-cons gained their skill in the Walks and Grounds Area from the elite force they here at MCI Shirley. Mnay of the former ShirleyWorld Shovelers are filled with a lot of anger, their "Crew Chief" and "Bird Feeding Task Force" Commander, abused them and treated them less than human.
