Why can't State Prisoner have phone cards in Georgia prison system. They have them at ~~how~~ some of the county jails. The inmates purchase them on their commissary store. Maybe somebody can contact the Georgia Department of Correction to help the inmates in the State of Georgia Prison get phone cards. We can still do our phone list. The phone ~~card~~ card can be fix when we still use our state ID number. Put them on the store. Inmates will purchase them like crazy who don't like to call their family only a fool. That would solve a lot of high phone bills and get rid of the ~~phone~~ cell phones out of the prison.

Why not pay the inmates? But then the State of Georgia puts their inmates back on the Street with a \$35.00 check. Some owe thousand of dollar ~~rest~~ restitution and child support. It's a grim on my hallway owe a \$1,000,000 restitution. She has long stretch sentence. But say her time is up tomorrow. The individual leaves only with \$35.00 has not been paid the whole while she set all these years. But the State of Georgia. All the see is I want my money. She already has a strike against her. She is convicted felony. She may get a job or she just might not. If she don't not because she didn't try. Nobody wouldn't hire. Her parole violate on the spot. She is coming back to prison. Does the State care about the individual child or family no. All they see is money. Do you think they care about you tried to get a job, no. They want their money. Georgia system has a lot of traps to trick people into ~~the~~ their penal systems. ~~the~~ Half of Georgia population is locked. If the inmates was paid they could put some money towards their restitution and child support fees. Instead of setting in prison looking at the bill. Then when they ~~get~~ get. Why so many financial schemes happen in Georgia prison in the last year or so. Georgia has came up with you can only have five people on your financial list. Only the people on your visitation list can send you clothing or food packages into the prison. Georgia prisoners are not well taking care of. You not feed well. Weekends and holidays you only gets two meals. The thing where you are taking care of because you
