I will die unable to see and speak to my children before. There is not one decent human being in this entire country that I've contacted over the last decade with the humanit, decency, compassio or empathy to assist me in locating my children on facebook; not one non-racist white nor any other group with the moral-conscious to help a elderly, dying Blackman mak contact with my 16 year old children(2). My children live in Phoenix, Arizona, attending \_\_\_\_\_ . Yet I can't make contant with anyone in Phoenix Arizona. Let me write out their names.

RE: Criminal Complaint; Report of Domestic War Crimes against U.S. Prisoner Transport Services of America(PTS)., LLC, Nashville, Tennessee; appointed agents of the State of Ohio.

ELDER ABUSE, a felony, barbaric, inhumane treatment of a prisoner, abuse of authority. I was harmed and my life senselessly put at risk. Cruel and unusual punishment 8th, 14th Amendment Deseased and deprived cruelty, torture, abuse of prisoner, sadism. 42 U.S.C. 1983 and in violation of A.R.S. 5121:1-1-35

Ohio Adult Parole Authority and Governor John R. Kasich did knowingly hire/appoint as their agents for the State of Ohio PTS of America to transport prisoner Otis Lee Rodgers a prisoner from the State of California to the State of Ohio, Lorain Correctional Institute, Grafton, Oh. On Saturday July 25, 2015; U.S. Prisoner Transport Service presented me with the Governor's warrant and upon inquiry agent Willard explained that U.S. Prisoner Transport Service was the same as PTS.

I was handcuffed and shackled, put in a 6x4½x4½ metal cage built inside of the back of a regular van - forced to sit unrestrained on a metal bench with(7) other about two-hundred pounds prisoners; packed in like sardines in a can for a total of 11 prisoners(two females) in about one-half of the van's capacity; all similarly hogtied; not unlike the slave ships of old. No ventilation, forced to endure mutual air of coughing and body gases; with a minimum a/c, temperatures ranging up to a 100+, DECREASE through Arizona, Texas, Florida etc. A travel period of about six days from California to Ohio making a dozen or so stop to unload and pick up new slaves/prisoners. My fellow prisoners in this small cage at least a dozen-or-so-times couple hundred times like a sack of potatoes on a roller coaster; snapping my neck, bumping my head and knees into other prisoners. This merciless pounding was for thousands of miles on an already injured back. The agents were driving wrecklessly up to 90+ miles an hours at times - hitting bumps, turning sharp corners at unsafe speeds sudden stops to avoid accidents.

In Mobile, Alabama near the County jail Agent Willard and his goon partner stop the van in the middle of the road, jumped out, unsnapped their gun holsters, stopped the vehicle traveling horizon to the Van's path in the middle of the road; accosting and questioning the young white female driver - she began to cry - after about 5 minutes of interrogation detention she was released.

As the agents drove wrecklessly at high speeds to make time not giving a god-damn about their hogtied human cargo. Not unlike the nazis, fascist or racist white savages of old/slavers. I flew up in the air and slammed down hard on my tail bone and injured back joint on the metal bench. I was forced to sleep handcuffed and shackled in the sitting position pressed up against the next prisoner. It was a sweatbox, tempers flaring and violent arguments ensued, pushing and shoving, prisoners slipping their cuff/chains to fight. The guards to quell the violents they would turn on the heater in 100 degrees temperatures. I was unable to bathe or to brush my teeth saving for two nigh that we checked into a County jail. The smell of human bacteria was beyond sickening and repulsive; one guy threw up when he was loaded into the van.

I could see the two females through the holes in the first van and through to plexagalls in the second van. One female was bleeding with a large cyst near her public hair area and crying because the agents refuse to stop to allow her to clean herself. The other female took matters into her own hands, pulled her pants down and urinated on the van floor twice and then in a bottle that she ripped the top off it; leaving her pants down for all to see in apparent anger and frustration as we disembarked the van at a County jail. I was forced to hold my body functions

for hundreds of miles, through multiple states until we reached a designated County jail stop.

Our/my repeated pleas for ice water felled on deaf ears and when answered I was given warm bottle water that was already in the hot van. There was the punishment (dog) cage, the agents put you in ~~for~~ - a cage that you would only put a large dog in. I was unable to stand up or to stretch out my legs at all for hours.

I have lost some of the circulation in my right leg, both of my knees have gotten weaker and more painful. My back is so painful it feels likit broken. I am unable to stand up straight and walk for any length of period of time.

I am sixty-seven years of age in geriatric decline, troubled ailing disable (DPV, DPM), NOW I am even more troubled with reoccurring nightmares of being hogtied and shackled in that slave-van and while I asleep the PST agents run off the road and off a cliff. I see/feel myself crushed upside down, mortally wounded and dying, my life senseless LOST.

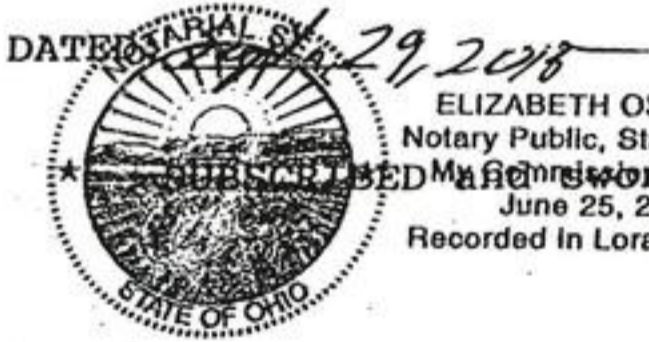

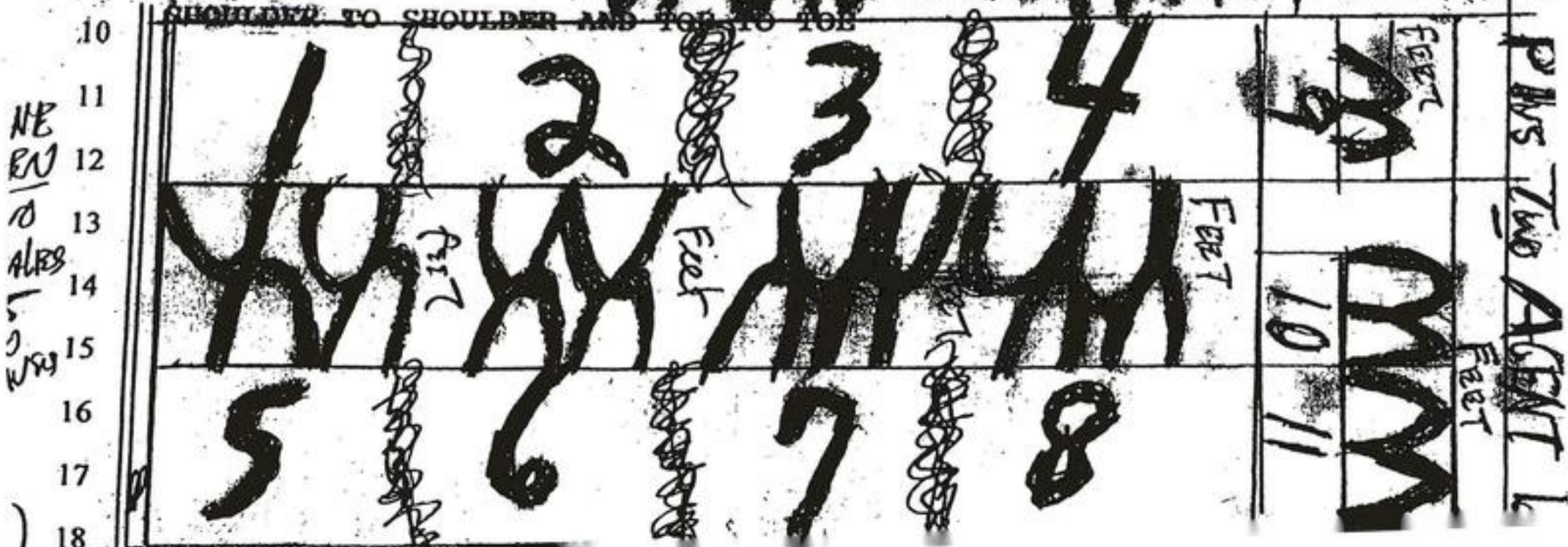

WHEREAS, it has been represented to me by the Governor of the State of Ohio that Willie Rogers aka Willie J. Rogers aka Willie Rogers (Lorci #174297) aka Willie Rodgers aka Willie J. Rodgers aka Otis Rogers aka Otis Rodgers aka Otis Lee Rodgers stands convicted under the laws of that state of Kidnapping (2 counts) and Gross Sexual Imposition (3 counts), thereafter violated the terms of his supervision, fled from the justice of the State of Ohio, and is now found to be in the State of California; and

WHEREAS, the representation and demand is accompanied by the requisition, a copy of the Journal Entry, Certified Copy of Sentence, Warrant, and supporting papers certified by the Governor of the State of Ohio to be authentic, whereby the fugitive was convicted of the crime.

THEREFORE, I, Edmund G. Brown Jr., Governor of California, acting through my duly authorized Interstate Rendition Officer, command you to arrest and secure Willie Rogers aka Willie J. Rogers aka Willie Rogers (Lorci #174297) aka Willie Rodgers aka Willie J. Rodgers aka Otis Rogers aka Otis Rodgers aka Otis Lee Rodgers, wherever he may be found within this state, and to deliver him into the custody of the designated agent(s), to be returned to the State of Ohio, there to be dealt with according to law.

WHEREAS, I, John R. Kasich, Governor of Ohio, certify that the requisition application and supporting documents accompanying this requisition which concern **WILLIE ROGERS a.k.a. WILLIE J. ROGERS a.k.a. WILLIE ROGERS (LORCI #174297) a.k.a. WILLIE RODGERS a.k.a. WILLIE J. RODGERS a.k.a. OTIS ROGERS a.k.a. OTIS RODGERS a.k.a. OTIS LEE RODGERS** (hereinafter "the Fugitive"), meet all necessary requirements of Ohio law; and

WHEREAS, the Fugitive stands convicted in Cuyahoga County, Ohio, with the crimes of: two counts of Kidnapping (R.C. § 2905.01) and three counts of Gross Sexual Imposition (R.C. § 2907.05); and

WHEREAS, it has been represented to me that the Fugitive was in Cuyahoga County, Ohio, at the time of the commission of the aforementioned crimes. Said Fugitive was then convicted, sentenced and released to supervision; and thereafter said Fugitive violated the terms of his supervision, and has since taken refuge in the State of California, and is now believed to be under civil or criminal arrest in the custody of the Solano County Sheriff's Office, in the City of Fairfield, in the County of Solano, in the State of California; and

NOW THEREFORE, in accordance with the Constitution and laws of the United States, I hereby request that you issue a Warrant for the arrest of the Fugitive, and that your Warrant provide that the Fugitive be delivered to Prisoner Transportation Services, LLC, (PTS of America, LLC), as the appointed agent for the State of Ohio.
