These debts mean that any money sent to me goes to those debts until they're paid off. I can't even buy deodorant for myself, shampoo, nothing

I don't have family on the street supporting me. You can sorta find out why by reading a short version of my life story in Adult Children of Incarcerated Parents: Telling Our Stories. I'm thinking of posting a piece, with supporting documents, about the twisted person who was my mom. Maybe it'll help some kids in similar situations.

If you are interested in helping me further, please write me a letter so I can write you back.

My next post will be about homicidal mistreatment of

prisoners at the United States Penitentiary in Terre Haute, where I was this last spring + summer.
