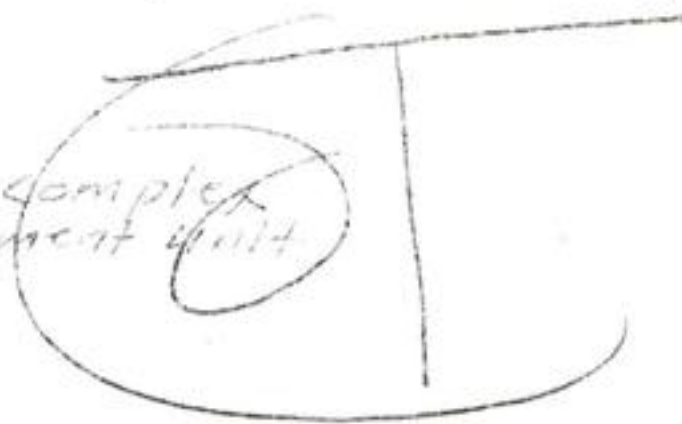


# RANT TO RAVE

CUS-[REDACTED] investigated your appeal. She met with you on 12/14/15 where you stated that you did not remember the officer who allegedly refused yard time, nor could you remember the staff member who supposedly talked negatively to you regarding the kite and displayed "abusive and antagonizing behavior." Since a specific staff member could not be interviewed, there isn't much to go on, and your grievance cannot be substantiated.

You also stated that since you have been assigned to C Pod, there have not been any issues with yard time or showers. If an issue arises in the future, please try to work with the unit staff on a resolution.
