



Sentencing Reform and Corrections Act Introduced with Broad Bipartisan Support

Act (S. 2123), introduced in the U.S. Senate on October 1, 2015, will have a major impact on the mandatory minimum sentencing regimen that has filled federal prisons with many non-violent offenders. Unlike all of the other legislation currently pending in Congress, this bill contains language that would have clear and unequivocal retroactive application to those already sentenced under certain mandatory minimums.

Specifically, the federal "three strikes" provision for drug offenses would be reduced from life without parole to 25 years, applied retroactively, and the 20-year mandatory minimum sentence for a second drug offense would be reduced to 15 years, also retroactively. Mandatory minimums for certain firearm-related offenses would be reduced, too.

Notably, the bill would make retroactive the Fair Sentencing Act of 2010, which reduced the disparity between crack and powder cocaine sentences, and expand the safety-valve provision for non-violent drug offenders with non-serious criminal histories. The effect of such statutory language can not be overstated, as it will eliminate many of the procedural hoops that federal prisoners have to jump through in order to obtain judicial relief. Unfortunately, violent

offenders, sex offenders and certain other prisoners are excluded, but for once, career offenders are not. The legislation would further allow some federal prisoners to earn additional good time credit for completing rehabilitative programs, and includes provisions related to juvenile offenders.

The Senate bill will of course have to be approved by the Senate Judiciary Committee, pass the full Senate and then be approved by the House of Representatives before it can be signed by the President, who has signaled his support for the legislation. The House introduced a similar criminal justice reform bill on October 5, 2015.

"We want to make sure our federal laws and regulations effectively and appropriately punish wrongdoers, protect individual freedom, safeguard civil liberties, work as efficiently and fairly as possible, do not impede state efforts, and do not waste taxpayer dollars," said U.S. Rep. Bob Goodlatte.

Unlike other sentencing reform legislation pending in both houses of Congress, the new Senate bill has important cosponsors. One of the architects of the legislation is Senator Charles Grassley, who chairs the Senate Judiciary Committee and has long been a "tough on crime" proponent. The bill also has the support of Senators Charles Schumer, Patrick Leahy and Dick Durbin, all Democrats, as well as Republican Senators Lindsey Graham, Paul Rand and John Cornyn. This powerful lineup of co-sponsors from both sides of the aisle bodes well for eventual passage of this important legislation.

Prisoners' rights advocates have been largely supportive of the bill.

"Today is an historic moment. It's more than symbolic. This approach exceeds expectations," stated Christine Leonard, executive director of the Koch Industriessupported Coalition for Public Safety.

Senator Grassley agreed, saying the bill "addresses legitimate over-incarceration concerns while targeting violent criminals and masterminds in the drug trade. It's the product of thoughtful bipartisan deliberation."

Wade Henderson, president of the Leadership Conference on Civil and Human Rights, commented that "Thirty years of 'tough on crime' sentencing has created an unjust system that imprisons more people than any other nation in the world, a disproportionate number of whom are black, Latino, low-income and non-violent."

However, in an October 2, 2015 article, Mother Jones senior reporter Shane Bauer noted that the Senate bill is "remarkably unambitious" in addressing the problem of mass incarceration, observing that it only applies to the federal criminal justice system when ten times as many prisoners are housed in state prisons and local jails. Nor would the legislation eliminate mandatory minimum sentences; it would only reduce them, and in fact would create new mandatory minimums for some offenses.

"Overall, the bill focuses on politically safe issues – long sentences for nonviolent drug offenses are now widely unpopular." Bauer wrote. "But it doesn't address the main driver of mass incarceration: sentencing for violent crimes."

The Sentencing Reform and Corrections Act has 26 co-sponsors; it was passed out of the Senate Judiciary Committee on October 22, 2015.



Have you ever heard the old adage "He who laughs... lasts?!" Well, as it turns out, it's true! Current scientific evidence has shown that laughter not only improves our overall health, happiness, and sense of well-being, but increases our life expectancy as well. Here's how:

1. Laughter strengthens your immune system and promotes healing. Your immune system protects your body from threats to its well-being like a virus or infection, even cancer. Laughter increases the number of "killer cells" and antibodies in your body. It helps you not only to get sick less often, but also to heal more quickly if you do.

2. Laughter is good for your heart. Laughter thins blood and blood vessels, improves circulation and acts as a vasodilator. It also lowers blood pressure. Ten-minutes of "hearty laughter" has been shown to produce a 10-20mm drop in blood pressure that lasts for 20 minutes after the laughter stops. It has also been determined that people with heart disease are approximately 40% less likely to laugh than those without heart disease.

3. Laughter may help to prevent type II diabetes. Recent research indicates that laughter may have an effect on the regulation of certain gene expressions that help to control type II diabetes. It also decreases food cravings by giving the same stimulation as eating 2000 chocolate bars!

4. Laugher alleviates bronchitis and asthma. Laugher improves lung capacity and oxygen levels in the blood. It eases bronchial spasms, opens airways and helps to clear phlegm.

5. Laughter is an intense aerobic workout. Laughter has been found to be equivalent to any other aerobic workout. In fact, one minute of rigorous laughter, or approximately 100 "ha ha ha's," has been shown to have the same cardiovascular benefits as a 10-minute workout on a rowing machine or 15 minutes on a stationary bike. That's right! You can burn approximately 400 calories an hour just laughing!

6. Laughter is a great stress buster. Laughter reduces levels of neuroendocrine and stress-related hormones in our body [e.g. cortisol, epinephrine, dopac]. It is a natural relaxant. Think of the last time you laughed so hard, you cried. Do you remember the feeling of peace and inner calmness you had afterwards? Laughter provides a playful pathway physical and emotional relief/release.

Laughter is a natural painkiller. Endorphins, the body's natural painkillers, are released when you laugh. The more you laugh, the better you feel.

8. Laughter relieves depression, anxiety and addictions. Laughter increases the production of "feel good" neurotransmitters [e.g. dopamine] and the "happy hormone" [oxytocin] in the brain. It focuses your awareness on happy feelings in the here-and-now while distracting you from any negative thoughts, emotions, or behaviors. Laughter is a natural high.

Laughter enhances brain functioning. Laughter activates higher cortical functioning while improving mental clarity, focus and concentration.

10.Laughter is internal jogging. Laughter massages internal organs while improving digestion and elimination.

11.Laughter is a challenging abdominal workout. Laughter is a great "abdominizer!"

12.Laughter lifts your spirit and soothes your soul. It isn't what life gives you, but how you respond to it that is the difference that makes the difference. Laughter helps you lighten up by not taking yourself, or your life, too seriously. Live life laughing.



Sanders says no tragedy if he loses Iowa; he can still win

DULUTH, Minn. (AP) — Vermont Sen.
Bernie Sanders said Tuesday his bid for the
Democratic presidential nomination would
succeed even if he fails to prevail in the Feb.
I Towa caucuses, saying in an interview with
The Associated Press he was prepared to go
the distance against front-runner Hillary
Clinton.

"If I lose Iowa by two votes and end up with virtually the same number of delegates, is that a must-lose situation? Is that a tragedy? No," Sanders said aboard a charter flight en route to Duluth, Minnesota, where he spoke at a rally with 6,000 supporters. "We are running a campaign that will take us to the convention and I'm very proud of the kinds of enormous gains we have made." Sanders has said previously that he could win lowa but his comments suggested an attempt to lower expectations in the final week before the caucuses. Asked if the Iowa contest is a must-win, he responded: "That's mythology."

Sanders told reporters earlier in the day in Des Moines that if he could generate large turnout among non-traditional voters, young people and workers, he could claim victory. "We will win here in Iowa if the voter turnout is high and frankly if the voter turnout is not high we're going to he

struggling," he said.

In the AP interview, he noted with a populist flair that if former New York City Mayor Michael Bloomberg entered a race against him and Republican Donald Trump, "two of the three candidates would be multi-billionaires. And by the way I'm the one who is not the multi-billionaire." Turning to his wife, Jane. he quipped: "Is that correct? I haven't checked the bank account lately." Sanders, an independent who often votes with Democrats on Capitol Hill, said Bloomberg's interest in a presidential bid brought forth "one of the issues that I think galls the American people — that we're

moving toward an oligarchic form of society."

He also dismissed speculation that President Barack Obama might be tipping the scales in favor of Clinton after the president praised his former secretary of state in a Politico interview. Sanders said Obama was "very generous to me." He said both Obama and Vice President Joe Biden are trying to be "objective and letting the people decide." The White House said later that Sanders would meet informally with Obama in the Oval Office on Wednesday and "there will he no formal agenda."

Sanders said he and Clinton are in a "nipand-tuck" race in Iowa but predicted that, with a success, he would begin to see more support from establishment Democrats who have coalesced around the former secretary of state's candidacy.

Asked if establishment Democrats would become unnerved if he defeated Clinton in Iowa and New Hampshire, Sanders said "the good news is we still live in a democracy and people have a say in this."

"Some elements of the establishment really will be upset," he added. "But other elements of the establishment, even if they are not supportive of my candidacy, today understand that the major task in front of us is to defeat right-wing extremism." He added: "What Democrats want to do is

He added: "What Democrats want to do is defeat Republicans and if I'm the candidate best able to do that, you can bet your bottom buck we're going to have a whole lot of establishment Democrats on board." Sanders said he did not know if Massachusetts Sen. Elizabeth Warren, a favorite of liberal Democrats, would endorse in the primary.

"Would I like her to come on hoard? Yes,"
Sanders said. "Elizabeth and I have known
each other for many, many years. I knew her
before you knew her, before she was
Elizabeth Warren. Just a law school
professor at Harvard who came to Vermont
at my request to do some town meetings and
did a great job."



Keith Ellison, D-Minn., one of his top supporters in Congress, Sanders has identified the state as one of his top targets in the so-called "Super Tuesday" states that will award a bevy of delegates after the early contests of Iowa, New Hampshire, Nevada and South Carolina.

Donald Trump Drops Out of Fox News Debate on Thursday

After a day of threatening to abstain from Fox News' Thursday night GOP debate, Donald Trump has officially dropped out of the event, his campaign manager told the Associated Press.

The dehate will be hosted by the network's Megyn Kelly, who Trump slammed as "biased against" him.

"Megyn Kelly's really biased against me," Trump said in an Instagram video on



Tuesday, "She knows that, I know that, Everybody knows that. Do you really think she can be fair at a debate?" He also posted a poll on Twitter, asking his followers if he should participate in the debate. Fox News shot back on Tuesday with a tongue-in-cheek statement. "We learned from a secret back channel that the Ayatollah and Putin both intend to treat Donald Trump unfairly when they meet-with him if he becomes president - a nefarious source tells us that Trump has his own secret plan to replace the Cabinet with his Twitter followers to see if he should even go to those meetings," the network said. Trump called the response a "pathetic attempt by Fox News to try and build up * ratings for the GOP Debate."

Trump has threatened to pull out of previous debates, though if he does not participate in Thursday's event, it will mark the first time he's followed through on one of those

threats.

WASHINGTON — The first world war, which claimed the lives of more than 116,000 U.S. troops, will finally get its memorial in the nation's capital and the World War I Centennial Commission announced Tuesday the winning design called "The Weight of Sacrifice."

The memorial will be located on Pershing Park, in front of the Willard Hotel on Washington's Pennsylvania Avenue and one block away from the White House, said Edwin Fountain, the commission's vice chair.

Designed by Joe Weishaar and Sabin
Howard, the design concept features a
freestanding sculpture on the lawn and will
create a continuous space, Fountain said.
The Pershing Park location makes it more
than just a memorial, said Libby O'Connell,
a governance group member of the
commission. "It is also an urban park," she
said. "We can't just walk away from that
responsibility."

Pershing Park includes a statue of John
Pershing, the top commander of U.S. forces
in the war, a fountain and a pond.
The World War I Centennial Commission
reviewed 360 design entries, and cut that fist
to five finalists.

The committee considered multiple factors to pick the winner, O'Connell said, including maintenance. Some designs posed problems with handicap access and security, which is critical given its close proximity to the White House. The committee also wanted to maintain the sight lines down Pennsylvania Avenue to the Capitol.

There's no deadline for finishing the memorial, but the commission would like to mark the 100th anniversary of the war's end on Veteran's Day, 2018, Fountain said. The

Tuesday on ABC and CNN, Trump was asked about being compared to Hitler.
The candidate didn't back down, saying that banning all Muslims "until our country's representatives can figure out what the hell is going on" is warranted after attacks by Muslim extremists in Paris and last week's shooting in San Bernardino, California, that killed 14.

"We are now at war," Trump said, adding:
"We have a president who doesn't want to say
that."

Trump's proposed ban would apply to immigrants and visitors alike, a sweeping prohibition affecting all adherents of a religion practiced by more than a billion people worldwide.

Trump announced his plan to cheers and applause at a Monday evening rally in South Carolina.

"Until we are able to determine and understand this problem and the dangerous threat it poses, our country cannot be the victims of horrendous attacks by people that believe only in jihad, and have no sense of reason or respect for human life," Trump said in a written statement.

At the rally he warned that without drastic action, "it's going to get worse and worse, you're going to have more World Trade Centers."

Rod Weader, a 68-year-old real estate agent from North Charleston who attended the rally and said he agreed with Trump's plan "150 percent."

"As he says, we have to find out who they are and why they are here," he said.

Since the Nov. 13 attacks in Paris that killed 130 people and wounded hundreds more, a number of Republican presidential contenders have proposed restrictions on Syrian refugees — with several suggesting preference for Christians seeking asylum — and tighter surveillance in the U.S.

But Trump's proposed ban goes much further, and his Republican rivals were quick to reject the latest provocation from a candidate who

and his Republican rivals were quick to reject the latest provocation from a candidate who has delivered no shortage of them. "Donald Trump is unhinged," Jeb Bush said via Twitter. "His 'policy' proposals are not serious."

John Kasich slammed Trump's "outrageous divisiveness," while a more measured Ted Cruz, who has always been cautious about upsetting Trump's supporters, said, "Well, that is not my policy."

Trump's plan also drew criticism from the heads of the Republican Party in Iowa, New Hampshire and South Carolina, the first three states to vote in next year's presidential primaries.

"It is un-Republican. It is unconstitutional. And it is un-American," said Jennifer Horn, chairwoman of the Republican Party of New Hampshire.

Trump campaign manager Corey Lewandowski said Trump's proposed ban would apply to "everybody," including Muslims seeking immigration visas as well as tourists seeking to enter the country. In an interview on Fox News, Trump said Muslim members of the U.S. armed forces would "come home" and that his plan would "not apply to people living in the country." In the late 1800s, Congress passed legislation broadly aimed at halting Chinese immigration. But, said Leti Volpp, a University of California expert on immigration law, "there is no precedent for a religious litmus test for admitting immigrants into the United States."

"Excluding almost a quarter of the world's population from setting foot in the United States based solely upon their religious identity would never pass constitutional muster," Volpp said.

Trump's proposal came a day after President Barack Obama spoke to the nation from the Oval Office about the shootings in San Bernardino, California, which Obama said was "an act of terrorism designed to kill innocent people."

The FBI said Monday the Muslim couple who carried out the massacre had been radicalized and had taken target practice at area gun ranges, in one case within days of the attack last week that killed 14 people. Trump's campaign has been marked by a pattern of inflammatory statements, dating back to his harsh rhetoric about Mexican immigrants. He has taken a particularly hard line against Muslims in the days since the Paris attacks, advocating enhanced surveillance of mosques due to fears over radicalization.

"Donald Trump sounds more like a leader of a lynch mob than a great nation like ours," said Nihad Awad, national executive director of the Council on American-Islamic Relations. "He and others are playing into the hands of ISIS. This is exactly what ISIS wants from Americans: to turn against each other."

Putin says Russia backs Free Syrian Army alongside Assad troops

President Vladimir Putin said on Friday
Russia supports the opposition Free Syrian
Army, providing it with air support, arms and
ammunition in joint operations with Syrian
troops against Islamist militants.
His statement appeared to be the first time
Moscow said it was actually supporting
Syrian President Bashar al-Assad's opponents
in the fight against Islamic State forces. Putin
said last month the Russian air force had hit
several "terrorist" targets provided by the
Free Syrian Army.

Western and Arab states carrying out air strikes against Islamic State for more than a year say that Russian jets have mainly hit other rebel forces in the west of Syria. "The work of our aviation group assists in

uniting the efforts of government troops and the Free Syrian Army," Putin told an annual meeting at the defense ministry.

"Now several of its units numbering over 5,000 troops are engaged in offensive actions against terrorists, alongside regular forces, in the provinces of Homs, Hama, Aleppo and

Raqqa," he said, referring to the Free Syrian Army.

"We support it from the air, as well as the Syrian army, we assist them with weapons, ammunition and provide material support." Putin said strikes by Russia's air force and navy had inflicted heavy damage on the infrastructure of Islamic State, which controls large areas of eastern Syria and western Iraq. Defence Minister Sergei Shoigu said, however, that the influence of Islamic State was increasing in Syria, where militants control around 70 percent of the country. The number of IS fighters in Iraq and Syria totals around 60,000, Shoigu said, and there is a threat of violence spilling over into post-Soviet Central Asia and the Caucasus. Talking to his generals, Putin issued a veiled warning to Turkey, whose downing of a Russian bomber jet near the Syrian-Turkish border last month sent bilateral relations to a freezing point and led Moscow to impose economic sanctions to Istanbul.

"I want to warn those who may again try to stage provocations against our troops," he said.

"I order you to act in an extremely tough way. Any targets threatening Russia's (military) group or our land infrastructure must be immediately destroyed," Putin told the generals.

Turkish Foreign Minister Mevlut Cavusoglu earlier on Friday called on Russia for calm, but said Turkey's patience is not unlimited. Venezuela's opposition wins legislative majority

CARACAS, Venezuela — Venezuela's fractious opposition won a crushing victory in legislative elections over President Nicolás Maduro's socialist party, as voters rejected the system created by the late leader Hugo Chávez 16 years ago, officials announced Monday.

The opposition's Democratic Unity coalition won at least 99 of the 167 seats in the National Assembly. And the ruling United Socialist Party of Venezuela won 46 seats, the National Electoral Council said. The opposition needs to win 13 of the 22 remaining races to gain a two-thirds supermajority required to rewrite laws and possibly start a recall referendum to oust Maduro before his term expires in 2019. With a simple majority, the coalition can pass an amnesty law to free political prisoners. Turnout for Sunday's vote was 74% of the country's 19 million eligible voters - the highest for congressional elections since the 1990s, when compulsory voting ended, according to the electoral council. "It's a huge win for the opposition," said David Smilde, a senior fellow at the Washington Office on Latin America, a human rights advocacy group. "It's worrying that 22 seats haven't been decided, as that makes the difference as to what the opposition can do." Many Venezuelans, tired of 16 years of rule

Many Venezuelans, fired of 16 years of rule by Chávez and Maduro, celebrated in the streets. Fireworks lit the skies over Caracas and other major cities.

"I went to bed last night, thinking we had a chance but not quite sure," said Minerva Lopez, 42, a seamstress in Caracas who voted for the opposition. "And then this morning I woke up to the news. What a relief. The nightmare is ending."

"We accept the results," a somberlooking Maduro said, as key members of his government looked on. "Today the opposition hasn't triumphed. No, it is a victory for the counter-revolution. May they manage this triumph well, and hopefully they will take into account the needs of millions of people."

He blamed his party's loss on an "economic war" being waged against his government by the country's business elite that he called "parasitical bourgeoisie."

Opposition leader Henrique Capriles, who is governor of Miranda state, said on Twitter late Sunday, "Venezuela won."

Capriles, 43, had narrowly lost the presidency to Maduro in a special election in April 2013 after Chávez died. Maduro, 53, a former bus driver handpicked by the cancer-stricken Chávez, has been blamed for Venezuela's economic woes.

On Sunday before the results were released, Maduro pledged to work with the incoming National Assembly and said he would schedule working meetings with the new deputies to smooth the transition. Capriles said after easting his ballot, "The government has used state funds to finance their campaigns." He stressed that all changes "must be made legally, constitutionally and peacefully."

Venezuela's oil-dependent economy is likely to contract up to 10% this year, and inflation rages at an annual rate of more than 150%. Shortages of basic food, medicine and spare parts are common, as Maduro slashed imports to free up dollars to make debt payments.

The drop in oil prices has hit Venezuela especially hard. The country sits on the world's largest oil reserves and derives 95% of its hard currency from crude sales. Maduro had asked Venezuelans to support the socialist party candidates to protect Chávez's legacy — the anti-capitalistic movement of giving more to the poor called Chávismo — while promising to boost pensions, scholarships and public housing. Even with the Democratic Unity's victory, Maduro and his party could make it difficult for an opposition-dominated assembly to govern. The outgoing assembly could grant Maduro special powers to rule by decree. Such a decision would certainly be challenged in the Supreme Court, where Maduro's supporters are in the majority.

"This will be uncharted waters for Chávismo, and it is hard to know what will happen," Smilde said.

The Democratic Unity coalition, which includes more than a dozen parties that have competed for power in the past, could also have trouble governing, Smilde said. The coalition is united only in its opposition to Chávismo and has not produced a detailed plan as to how it would reactivate the economy. Even though the coaltion will hold a majority of seats, just selecting the National Assembly's president and other officers will create tensions, he said. "We're going to see all sorts of coalitions emerge," Smilde said.

Colombia finds what may be world's largest sunken treasure

CARTAGENA, Colombia (AP) —
Colombian President Juan Manual Santos
hailed Saturday the discovery of a Spanish
galleon that went down off the South
American nation's coast more than 300 years
ago with what might be the world's largest
sunken treasure.

At a press conference in the colonial port city of Cartagena, Santos said the exact location of the San Jose galleon, and how it was discovered with the help of an international team of experts, was a state secret that he would personally safeguard.

The San Jose originally sank somewhere in the wide area off Colombia's Baru peninsula, south of Cartagena.

While no humans have yet to reach the wreckage site, the government said autonomous underwater vehicles have gone there and brought back photos of dolphin-stamped bronze cannons in a well-preserved state that leave no doubt about the ship's identity.

The discovery is the latest chapter in an ongoing saga that began three centuries ago, on June 8, 1708, when the Spanish ship with 600 people aboard sank to the bottom of the sea as it was trying to outrun a fleet of British warships.

It is believed to have been carrying 11 million gold coins and jewels from then Spanish-controlled colonies that could be worth billions of dollars if ever recovered. The ship, which maritime experts consider the holy grail of Spanish colonial shipwrecks, has remained submerged ever since off the coast of Cartagena even as a legal battle has raged in United States, Colombia and Spain about who owns the rights to the sunken treasure.

In 1982, Sea Search Armada, a salvage company owned by U.S. investors including the late actor Michael Landon and convicted Nixon White House adviser John Ehrlichman, announced it had found the San Jose's resting place 700 feet below the water's surface.

Two years later, Colombia's government overturned well-established maritime law that gives 50 percent to whoever locates a shipwreck, slashing Sea Search's take down to a 5 percent "finder's fee." A lawsuit by the American investors in a federal court was dismissed in 2011, and the ruling was affirmed on appeal two years later. Colombia's Supreme Court has ordered the ship to be recovered before the international dispute about the fortune can be settled. Santos didn't mention any salvage company's claim during his presentation, but the government said that the ship had been found Nov. 27 in a never-before referenced location through the use of new meteorological and underwater mapping studies.

Danilo Devis, who has represented Sea Search in Colombia for decades, expressed optimism that the sunken treasure, whose haul could easily be worth more than \$10 billion, would finally be recovered. But he bristled at the suggestion that experts located the underwater grave anywhere different from the area adjacent to the coordinates Sea Search gave authorities three decades ago.

"The government may have been the one to find it but this really just reconfirms what we told them in 1982," he told The Associated Press from his home in Barranquilla, Colombia.

The president said any recovery effort would take years but would be guided by a desire to protect the national patrimony.

During his presentation, Santos showed an underwater video that appears to show jewels and the cannons.

In the footage, English-speaking crew members aboard a Colombian naval ship can be seen launching the underwater vehicle into the ocean.

UK leader visits flood-hit northern England, Scotland

LONDON — British Prime Minister David Cameron visited a swath of northwest England inundated by floods, as rescuers pulled people from waterlogged homes after record rainfall led to at least one death and swamped some 3,500 properties. The visit comes amid criticism that 45 million pounds spent on flood defenses after major floods in 2005 failed to hold back the deluge in Cumbria, the hardest-hit county. The area got a month's worth of rainfall in a day — about 34 centimeters (13.4 inches). Visiting a flooded home in the city of Carlile, Cameron called the damage "horrific" and vowed to review flood defenses. Environment Secretary Liz Truss said that in the worst-hit towns and cities, water levels were half a meter (20 inches) higher than during the 2005 floods. She said extreme weather events like the weekend deluge were "consistent with the

change."
While local leaders demanded an investigation, Floods Minister Rory Stewart defended the government, arguing that defenses had slowed down the water to allow more time for evacuations.

"When you face, as we have now, probably the highest rainfall we have ever had in the voting interest," Justice Sonia Sotomayor acknowledged. "But there is also a representation interest."

The challengers' argument boils down to this: Texas' population-based system puts more voters in districts with fewer non-citizens and others who cannot vote, thereby diluting the weight of their votes. In heavily Hispanic districts or others with large numbers of nonvoters, the remaining residents' votes carry greater weight.

The equal protection clause of the Constitution is supposed to guarantee each person the same political power. The problem is that the Supreme Court has never decided who should be counted — all people, or just voters.

"It's called 'one person, one vote," Chief Justice John Roberts said of the constitutional principle at stake in the case, Evenwel v. Abbott. "That seems to be designed to protect voters."

The case has pitted scores of civil rights organizations, who want to protect the interests of minorities, against a lesser number of conservative and libertarian groups who want the metric changed so that voting comes before representation.

"In a case like this where there is a 45 percent deviation

... why isn't Texas required at that point to rec ognize that these interests that are legitimate under the Constitution, which are voterbased, should not be accommodated?" Kennedy asked Texas Solicitor General Scott Keller.

But if voting had been the requirement between 1868 and 1920, Justice Ruth Bader Ginsburg said, women would not have been counted when legislative districts were drawn. "They were not eligible voters," she said.

The case is the brainchild of Edward Blum, director of the Project on Fair Representation, which has filed several Supreme Court challenges to racial and ethnic preferences in voting and higher education.

Blum brought the challenge to the University of Texas affirmative action plan that will come before the justices on Wednesday, as well as a challenge to the Voting Rights Act that resulted in the court's 2013 decision striking down the requirement that mostly Southern states and municipalities get federal approval for any changes in voting practices. If the court rules that districts should be based on eligible voters rather than total population, other states with large numbers of non-citizens would see the biggest change, such as California, New York, New Jersey, Arizona and Nevada. Cities such as Chicago and Miami also would be affected. In many other states, the rules could change but require no immediate moving of district lines because the results from using total or voter populations are not significant.

"Extremely inappropriate": The Supreme Court and the sneaky plot to kill affirmative action

Earlier this week, the Supreme Court heard oral arguments for Fisher v. University of Texas at Austin, a case that, many experts say, could lead to the destruction of affirmative action at public universities as we know it. Even if you're not much of a Courtwatcher or civil rights buff, you probably saw something about it in the news; it was during oral arguments that Justice Antonin Scalia wondered aloud if African-American students might be better served on "a slower track." As the New Republic's Brian Beutler observed, Scalia's comment wasn't quite as bad as you may think (it wasn't good, mind you, but it wasn't as bad as some of his critics have suggested). But Scalia's remark, and the outrage it inspired, was nevertheless representative of how volatile are the issues at the heart of the Fisher case. American politics is often about the legacy of white supremacy - and often concerns how that legacy should be atoned for - but rarely is the subtext so in-your-face. Because this is a fraught issue, and because it's likely to inspire more heat than light,

Because this is a fraught issue, and because it's likely to inspire more heat than light, Salon reached out to Rachel M. Kleinman, senior counsel for the NAACP's Legal Defense and Education Fund, to get a sense of both the policy and the politics of Fisher v. Texas. We also touch on how supporters of affirmative action are tailoring their arguments to most likely persuade what is fundamentally a very conservative Court. Our conversation is below and has been edited for clarity and length.

A lot of readers are going to see Fisher v. Texas and think it sounds vaguely familiar. Why?

So, this is actually the second time the Supreme Court is hearing this case. It did so in 2012. The first time it heard the case, the Court reaffirmed the educational benefits of diversity, but they clarified one of the legal standards that need to be used when deciding whether any specific admissions program is constitutional.

So they sent it back to a lower court to apply that standard. The lower court did that again; they once again found that the University of Texas' admissions program, which includes a modest consideration of race, is constitutional. And Abigal Fisher, who is challenging the admissions process at the University of Texas, appealed again to the Supreme Court; and the Supreme Court took the case again for a second time.

So the basic argument hasn't changed, really, despite all the time that's passed. What is that argument?

What's being argued over here, generally, is the University of Texas' program for admitting students.

The University of Texas has a somewhat unique process for admitting students, in that the majority of their class is admitted through, what they call "the Top 10 Percent Program." This program admits approximately the top 10 percent of the class of every high school in Texas. So, if you're

in that top 10 percent, you get into the University of Texas at Austin.

The top 10 percent program does not fill the entire class. It leaves some number of spots — and it's a varying number of spots according to Texas State Law — available for the rest of the class. It is that piece of the admissions program that is being challenged.

And what's the challenge?

The university does a holistic review of every candidate's application, which means looking at test scores, looking at grades, community service, looking at gender, looking at if. somebody's first generation — anything like that. One of the factors that can be considered at this stage is race. (It's a very modest consideration of race; when you look at their specific process, it's a factor of a factor of a factor.) That modest consideration of race is what Abigail Fisher is challenging.

Who is Fisher?

She's a white woman who did not get in through the top 10 percent program and then did not get in through the holistic review measure. She says that it's an unconstitutional admissions process because of the consideration of race, and that she was denied her ability to get into the school because of her race.

Do we know how the Court is likely to rule? Are there any justices who are perceived as on the fence?

It's hard to say. Any time a Supreme Court takes up a case like this we in the civil rights community worry. We are particularly alarmed this time because it seems that this case had been resolved, and no one really expected [the Court] to take it up again. The last time this was heard, the Court ruled a 7-1 majority to send it back down to the other court. The majority opinion also included an embrace of the Court's past jurisprudence [on affirmative action].

"This is a president who was highly respected by all," Trump said Tuesday. "If you look at what he was doing, it was far worse." The idea announced by Trump Monday evening drew swift rebukes, some from abroad. British Prime Minister David Cameron slammed it as "divisive, unhelpful and quite simply wrong." Muslims in the United States and around the world denounced it unconstitutional or offensive. The front page of the Philadelphia Daily News pictured Trump holding his right hand out as if in a Nazi salute with the headline "The New Furor." In morning TV interviews
