Dear Florida State University Professors

Good morning! I'm coming to you from Florida's death row, not to address my legal case, but rather to discuss SB 7020 and HB 7131 and all the corruption within the Florida Dept of Corrections (FDOC)

My goal is to get a movement going for Correctional Bills, that will not only benefit the officers and inmates, but the American public.

Last year the Miami Herald, was doing all these front page stories on prison corruption and inmate deaths, see <http://www.miamiherald.com> to read the horrific story of Darren Rainey a 50 year old mentally ill inmate, that staff placed in a scalding hot shower, and left him there until he died.

Read the story of Randall Jordan-Aparo who was in a secure isolation cell, and was sprayed with a chemical agent and left to suffer a horrendous death! For Randall was found laying on the floor, down by the door, with his face pressed up against the crack of the door, where we can only assume, he was trying to get fresh chemical free air. Underneath his lifeless body, was his Holy Bible.

You can read those stories as well, of these of Jerry Washington, Latandra Ellington, Shawn Gooden, Matthew Walker, Damion Foster and so many other mysterious deaths, but please don't forget Frank Smith a 2012 murder that took place at Union Corr. Inst. under warden Barry V. Reddish, a murder that I warned was going to take place, in my letters to the Governor, Chief Inspector General and FDOC secretary, in May 2012 after I had been assaulted twice by Reddish's officers because I was blogging

about the assaults and torturous acts under Warden Reddish. Reddish had a good mentor "James V. Crosby Jr" see Case law Valdez v. Crosby, 450 F.3d 1231 (11th Cir 2006), you'll read about the murder of Frank Valdez was beat kicked and stomped to death by 9 Correctional Officers. you'll hear testimony of assaults and acts of torture And you'll even see a letter of Seburt Connor, who warned that Frank Valdez, was about to be murdered, just weeks before it happened. Barry v. Reddish was a member of this Administration, of then Warden Crosby, who soon became Secretary Crosby before he was finally indicted, becoming convicted felon, and inmate James V. Crosby Jr.

Since 2012 I've been pushing for body cameras and mandatory annual lie detector test. This not only will stop all the officer on inmate assaults and torturous acts that are going on in here, but it'll also weed out all the Criminal Correctional Officers who are smuggling illegal contraband into these maximum security prisons, jeopardizing the security of the institution and in return endangering the American public.

Look at the history of the FDOC. We just had a major here at Florida state prison indicted in 2015 for selling drugs. Only a fool would say its no longer happening!

In the 1970s White shirts (Captains) was using inmate Johnny Forte aka Johnny Ford, to kill inmates on Q-wing here at F.S.P. so we're dealing with a long history of Corruption!

Body cameras would be great, but the lie detector test will truly weed out the criminal element that not only currently works in the FDOC but will give Secretary Julie Jones the tools to hire honorable, ethical law abiding staff who will not

only protect us inmates, but who will protect the security of the institution, thus protecting the American public

I'm searching for advocates, who will push these Bills SB 7020 and HB 7131 and push Amendment's for Body camera's and lie detectors into these Bills. Some one who will speak out in the senate and House Committees. Cause we need Correction Bills passed now, not the next time the headlines, and front pages are covered with officer on inmate assault's, deaths/murders. Now is the time for change!

Further more, we have Chapter 33-Florida Administrative Codes, that are "unconstitutional," such as 33-601.800(10)(k) that denies inmates of due process, placing them in torturous conditions, where for 3 days and 3 nights the inmate is placed in a cold concrete and steel cell with nothing but his underwear. No tee shirt no mattress or blanket, thus no sleep. And it can be done without any evidence. Trust me, I know. Barry V. Reddish tortured me in this manner, in 2011 and 2012 along with other inmates.

We also have 33-601.308(4)(c) mail suspension, where for a minor rule violation, the Administration can sever all family ties for up to 6 months which not only violates the inmates constitutional rights see Davis v. Goord, 320 F.3d 346 at 351 (2nd Cir 2003); Morrison v. Hall, 261 F.3d 896 at 906 (9th Cir 2001); Zimmerman v. Tribble, 226 F.3d 568 at 572 (7th Cir 2000) It also violates the Friends and Families constitutional rights to correspond with that prisoner, see Nasir v. Morgan, 350 F.3d 366 at 369 n3 (3rd Cir 2003). Rowe v. Shake 196 F.3d 778 at 783 (7th Cir 1999) so 33-601.308 section (4)(c) is violating established constitutional rights of the inmates and free world people.

what we need is an advocate who can go before the FDOC rule making authority and push for Constitutional Corrections in these 33-FLA Admin. Codes

I'm reaching out to you for help, maybe you can pass this letter on, e-mail it to an individual who can possibly help, or lead me down the right path.

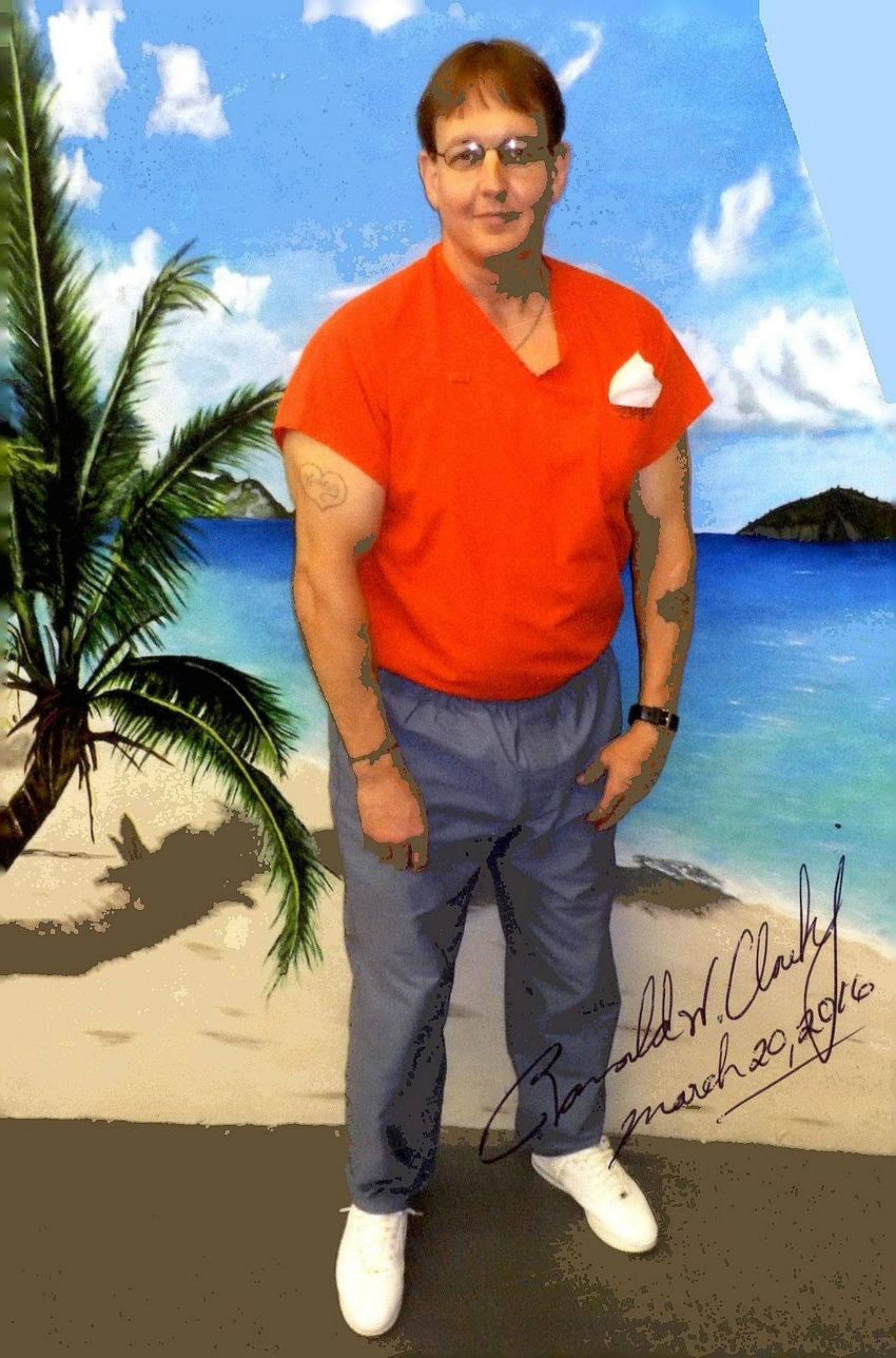
Also due to my death sentence I'm unable to get my GED or participate in educational programs.
