AFTER WHAT MOST'VE BEEN AT LEAST A (1000) TRIPS TO THIS County JAIL ALONE SINCE I 1ST MOVED TO FLORIDA BACK IN THE LATE 80'S, ALONG WITH A Couple OF TRIPS TO THE STATE PENITENTIARY (BOTH) IN FLA, AND NOW "WISCONSIN" Out OF ALL PLACES WHERE I'VE NO FAMILY/FRIENDS THAT I CAN CALL MY OWN, AND WHERE I'M SCHEDULE TO (DIE), AND BE Buried IN A WOODEN "BOX" IN THE BACK OF THE PENITENTIARY LIKE SOME DAMN "ANIMAL" FOR A CRIME I DIDN'T EVEN COMMIT OR HAD ANYTHING TO DO WITH, THIS WAS ACTUALLY THE 1ST TIME IN MY LIFE THAT I HAD MADE THE DECISION TO DO Just AS THIS Country ASS / RACIST COP HAD Sugested I DO / NOT END up LIKE MOST Guys I'VE KNOWN, "DEAD OR IN PRISON 4-LIFE", But You KNOW WHAT THEY SAY You REAP WHAT You SOW, AND "SOMETIMES" PEOPLE GET EXACTLY WHAT THEY DESERVE!!!!!!

AS I WALKED Out OF THE LAST OF THE SECURITY DOORS / INTO THE LOBBY AREA OF THE MARION County JAIL WHERE PEOPLE WERE AWAITING THE RELEASED OF THEIR LOVED ONES, SITTING IN A CORNER WAS THE MOTHER OF MY 2-KIDS NAMED "KIMBERLY ANN CURTIN", WHO THROUGH Out MOST OF MY PREVIOUS INCARCERATIONS HAD "NEVER" BEEN THERE FOR MY RELEASE, But THERE SHE WAS THIS TIME WITH THAT "LOOK" IN HER EYES THAT SAID IT ALL, "IM HERE 4-You NOW JEFF, But ONLY 4-THIS ONE/ONLY TIME" AS IF ALL ALONG "SHE KNEW" EXACTLY WHAT MY DESTINY WAS GONNA BE!!!!!!

THEN WE WALKED Out OF THE JAIL HAND/HAND "TOGETHER" DOWN THE LONG CORRIDOR THAT LEAD TO THE JAIL PARKING LOT UNDER THE HOT FLORIDA SUN AS IT SHINED ON MY GIRLS BEAUTIFULL / ALLMOST "ANGELIC" FACE, WITH HER FIRE RED HAIR / EMERALD GREEN EYES, AS I REMEMBER LOOKING UP AT THE BEAUTIFULL BLUE SKIES / TELLING MY SELF THIS EXACT WORDS, "Fuck THOSE DAMN STREETS, IM GOING HOME TO BE A FAMILY MAN" "LITTLE THAT I KNEW DOE THAT LESS THEN 24-HRS AFTER LEAVING THIS DAMN PLACE THAT I SWORE TO NEVER RETURN I WOULD MAKE A DECISION THAT I WOULD 4-EVER REGRET"!!!!!!

AS WE GOT INSIDE OF MY GIRL'S LITTLE BROWN MAZDA "HOOPTY", AND WE GOT READY TO LEAVE, I REMEMBER HOW CLOSE WE GOT TO GETTING

~~WE GOT TOGETHER AND HAD SEX~~ (Seemed 2-Have)
ARRESTED FOR "PUBLIC INDENCENCY", WHICH MY GIRL "NEVER" REALLY A PROBLEM WITH EXPRESSING HER SEXUALITY DESIRES Out IN "Public", AS WE BOTH GOT A BIT CARRIED AWAY / MY HANDS WERE ALLREADY TRYING TO UNDO THE ZIPPER IN HER PANTS, ONLY TO HAVE A FEMALE OFFICER Rudely KNOCK ON Our WINDOW / TOLD us TO MOVE IT ALONG!

"WE'LL FINISH THIS AT HOME, SAID THE MOTHER OF MY KID'S WITH THAT (FUCK ME) LOOK THAT SHE ALWAYS GOT IN HER EYES EVERYTIME THAT SHE GOT SEXUALLY Aroused"

ON THE WAY TO GO PICK up MY DAUGHTER FROM HER DAY CARE CENTER AT "C.F.C.C", CENTRAL FLA COMuNity COLLEGE WHERE THE MOTHER OF KIDS WAS ATTENDING SCHOOL AT UNDER THE "SINGLE PARENT PROG" TO BECOME A TEACHER I ASKED HER THE FOLLOWIN Question, DO You THINK THAT "GRACE" WILL REMEMBER ME, MEANING MY DAUGHTER WHO'S BIRTH

BACK IN "OCT-1997" NOT ONLY DID I MISSED DO TO "Multiple" INCACERRAT-ION STAYS/MY ROLLING STONE WAYS, But ALSO LITERALLY ABOMDOMED BACK IN "JAN-2000" AFTER THE MOTHER OF MY KIDS/I HAD SEPARATED, AND I ENDED up MOVING AWAY 2-"MILWAUKEE" WITH MY LATE FATHER "JEFF THOMPSON CORTZ" WHERE I GOT ARRESTED IN "FEB-2000" FOR SEVERAL DIFERENT CRIMES THAT INVOLVED SALES/POSS OF COCAINE, 2ND DEGREE RECKLESS, AND EVEN "Murder"!

THEN AS I STOOD THERE INFRONT OF EVERYONE LOOKING AT ME LIKE I WAS SOME SORT OF STREET "THUG OR SCAPED CONVICT" CONTEMPLAITING WEATHER I SHOULD MAKE A RUN 4-IT OR STAY, A SMALL "MIRACLE" OCCURRED WHEN MY LITTLE GIRL WAS FINALLY BROUGHT OUT 2-me, AS WE STOOD THERE EYEING EACH OTHER LIKE 2-GLADIATORS About 2-GO TO WAR WITH EACH OTHER WITH THOSE SAME EXACT "EYES" I HAD OFTEN SEEN 2-MANY TIMES IN THE PAST WHEN I Would MEET up WITH MY OWN FATHER/Question HIS "MOTIVES" 4-BEING AROUND ME!

THEN, AND ONLY THEN DID I WITNESSED THE MOST BEAUTIFULL "SPANISH PRINCESA" I HAD EVER SEEN/WILL EVER SEE BREAK DOWN/RUN TOURCH ME SCREAMING/CRYING SAYING, "DADDY, DADDY", OVER/OVER AGAIN UNTILL SHE GOT WITHIN REACHING DISTANCE, AND I LITERALLY SWOOPED HER OFF HER FEET/HELD HER IN MY ARMS WITH "TEARS OF BLOOD" RUNNING DOWN MY FACE, AS I CARRIED HER OUTSIDE 2-THE CAR WHERE SHE "REFUSED 2-LET GO OF ME/GET IN HER CAR SEAT"

ON THE WAY HOME 2-OUR LITTLE HOUSE OUT IN THE COUNTRY, MY SON ASKED ME, "ARE You GONNA STAY WITH US THIS TIME DAD" AUTOMATICLY MAKING ME FEEL LIKE SHIT/MAKING ME WONDER IF I COULD EVER BE A "FATHER 2-MY KIDS?"

"WE'LL SEE OK", WAS ALL I SAID [REDACTED] 2-HIM, AS WE GOT CLOSER 2-OUR HOUSE/WE STOPPED AT THE LOCAL "QUICK KING" GAS STATION WHERE

LATER ON THAT NIGHT AFTER WE HAD GONE SEVERAL MORE ROUNDS OF INTENSE LUV MAKING, AND WE'RE READY 2-GO TO SLEEP WITH MY LITTLE GIRL NOW LAYING RIGHT NEXT 2-ME, ALL OF SUDDEN THE DAMN PHONE STARTED RINGING, AND AS MY GIRL STARTED 2-GET UP 2-GET IT I SAID 2-HER, "DON'T" WHICH SHE COMPLETELY IGNORED, AND [REDACTED] CAME BACK INTO THE BEDROOM/[REDACTED] ANNOUNCED THAT WE'RE HAVING "COMPANY", AND THAT I SHOULDN'T WORRY ABOUT GETTING "DRESSED", WHICH 2-ME MADE ME REALIZED THAT "SOMETHING" WASN'T RIGHT CUZ I WAS ONLY WEARING MY "BOXERS"?

SEE PRIOR 2-ME BEING RELEASED FROM THE MARION COUNTY JAIL WHERE I SAT FOR APPROX 90-DAYS OR SO BEFORE I WAS SENTENCED 4-MY VIOLATING MY FLORIDA PROBATION ON A (99) CASE WHILE LIVING IN WISCONSIN IN JAN 2000, I FOUND OUT ALL ABOUT WHO "JODY", MY GIRL'S NEW SO CALLED "BEST FRIEND" REALLY WAS WHICH THEN LED 2-CONVERSATIONS ABOUT (US) POSSIBLY HAVING A "THREE WAY" WHEN I CAME HOME, BUT SINCE I'VE "NEVER" BEEN THE TYPE THAT I LIKE (2-SHARE) THE MOTHER OF MY KIDS WITH "ANYONE PERIOD", I DECIDED 2-CHANGE MY MIND BEFORE I WAS EVEN RELEASED FROM JAIL WHICH I "TOUGHT" HAD BEEN UNDERSTOOD BETWEEN US, BUT AFTER I SAW THE "LOOK" THAT THIS TRAILER PARK TRASH HAD IN HER EYES WHEN SHE SHOWED UP AT OUR HOUSE IN THE MIDDLE OF THE NIGHT, "I KNEW RIGHT THEN THAT SOMETHING TERRIBLE WAS [REDACTED] ABOUT 2-GO DOWN"

Re: Your Case

Dear Mr. Poff,

In reviewing your case I find it very hard to believe that you were convicted on the basis of the evidence presented at your trial. The following is a list of the discrepant, inconsistent testimony of Heather [REDACTED]

1. Heather testified several times in the trial that she heard 2 shots fired by the accused, yet only 1 bullet casing was found at the scene. Additionally, the medical examiner found only 1 bullet that first entered the right hand and then apparently passed through the head. The position of the hand of the victim was undoubtedly at his head to protect him from the path of the BULLET, which impacted in both the hand and the head. This suggests it was a single shot.

2. The above single shot had to occur at a distance of inches to 1 foot since gunshot residue was found on the right hand. Yet Heather testified falsely that the shooting was at a distance of 10-15 feet away, a distance where no gunshot residue would be found. She is clearly wrong. Since both shots were fired, according to Heather, at less than 1 second apart (testimony) this would also leave gunshot residue on the head - if indeed 2 shots were fired.

The autopsy Doctor Rebecca Hsu, the medical examiner, stated that the wound she saw in the hand was a "CONTACT WOUND."

In conclusion it is my opinion that the victim was shot once only at a distance of inches to one foot - not at the distance of 10-15 feet as stated by Heather [REDACTED]

Dear Mr. Poff:

I had an opportunity to review your correspondence received by the Commission on February 23, 2016, relating to former Milwaukee County Circuit Court Judge Jacqueline D. Schellinger. I also reviewed the Wisconsin Court System's publically accessible online records concerning Milwaukee County case no. 01CF5315.

It is the Commission's responsibility to enforce the ethical obligations of judges as outlined in Wisconsin Supreme Court Rule 60. Legal decisions made in the course of judicial duty are subject solely to judicial review, not the review of the Wisconsin Judicial Commission. Our role is not that of an appellate court.

The Commission cannot grant relief to a litigant, take action to alter the outcome of a particular case, provide legal advice, or become involved in any way in a person's court proceeding.

You complain about the sentence that the judge imposed after a jury found you guilty. That aspect of your complaint is legal in nature and therefore outside of the Commission's jurisdiction. For that reason, we can take no action upon it.

Additionally, you speculate that the judge "might've been illegally using street drugs back in 2001-02." The Commission cannot launch an investigation based upon mere supposition. For that reason, that aspect of your complaint does not justify further Commission review.

I am sorry we cannot assist you further.

gravel, there were tire skid marks, which traveled in a north/south direction, and lead onto the alley pavement.

Squad 384/Late, I.D. Technician [REDACTED] was summoned to the scene, at which time he took a total of 25 photographs, and 3 blood samples from the puddle of blood, which contained a quarter, located in the southwest corner of the rear yard at 1325 W. Greenfield.

I, Detective BALL, then diagrammed and measured the scene and upon my completion, I collected the 2 disposable lighters that were on the gravel west of the auto that was parked in the rear, along with the spent 380 caliber casing, and the Kool cigarette box. Those items were placed on MPD Inventory #173325. I also recovered the quarters that were near the victim's body at the time of his death, along with the 3 additional quarters that were found in the driver's seat of the Buick auto that was parked in the rear of [REDACTED] and those items were placed on Inventory #171339.

While on the scene, I had an opportunity to speak with a witness, [REDACTED] F/W, dob [REDACTED]-14, of [REDACTED] (phone [REDACTED]). Upon speaking with [REDACTED] she relates that on Sunday, 09-30-2001, at approximately 1:00am, she heard 7 to 8 gunshots, but she never looked out.

Next, I spoke with the occupant of [REDACTED], who identified herself as [REDACTED] F/W, dob [REDACTED] (phone [REDACTED]). Ms. PALMER relates that on Sunday, 09-30-2001, at 12:54am, she heard a couple of gunshots, and about 5 minutes later, she heard 2 more gunshots being fired. She related that she looked out her front window and within moments, the Police were on the scene, and she observed the Police talking to neighbors, and assumed that it was regarding the shots that had been fired.

[REDACTED] relates later in the morning on Sunday, 09-30-2001, at 4:01am, she heard one gunshot, which appeared to come from behind her home from the area of [REDACTED]. She related that she did not look out after hearing the gunshots, nor did she call the Police.

Squad 23 and Squad 282R were responsible for the neighborhood canvas, and will be filing a detailed supplementary report regarding same.
