WE ARE JUST BEGINNING, BUT I'M HOPEFUL THAT ILL RAISE \$25,000 FOR AN ATTORNEY THAT WILL GET ME BACK INTO COURT AND SECURE A RETRIAL FOR ME. I TOLD MY WHOLE STORY BACK AT THE BEGINNING OF THIS BLOG.
