## ABOUT ME, MICHAEL A. FRIMMEL

I was born October 2, 1968. Philadelphia, Pennsylvania. At present, I am 45 yrs old. At around the age of 30 yrs, I was confronted with overwhelming stress stemming from many different situations in my life at that time. I started drinking alcohol as a coping mechanism. I was married for nearly 10 yrs and now that too was failing. Around the same time, I had lost my job and my father was dying from cancer. My Drinking escalated, and my troubles increased. The next step for me was self medicating, with pain killers. Shortly after my father passed away, my wife had left me, I was out of work, and I found myself using poor judgment and irrational thinking.

Here I am after that onset of trouble began now 15 years and a couple of prison terms later, somewhere in the middle of the desert and away from all my family and loved ones. I am broken...

At least I was! I have been incarcerated here in the Nevada Department of corrections since 2008 serving a sentence of 10 yrs to life.

When I first entered the system this time, 5 yrs ago. I was so used up and mentally exhausted. I realized that I must make changes and rebuild myself from the inside out. This is what I have done:

I voluntarily entered the OASIS THERAPUTIC COMMUNITY PROGRAM at Southern Desert Correctional Center. At First I did not meet the criteria, because of the length of my sentence. However, I was very convincing and determined to be a positive influence within the program. My case manager at the time accepted my sincerity, and I was enrolled into the long term program with a projected completion date of 18 months.

Program Start Date: April 2010.

I graduated the program December 7, 2011 (see attached Certificates)

Today is December 2013; I continue to be an active member in the therapeutic community.

Throughout the program, I completed different challenging phases:

## PHASE I:

Intake, Probation, Orientation, and Initiation...Completed.

## PHASE II:

Resocialization, Treatment, and Recovery...Completed.

### PHASE III:

Transition and Reintegration...completed.

### A.S.A.M.

Level III.5 Intensive Long term Residential (Evidence Based)...completed.

Upon graduating the program, I was given the option of moving on somewhere else within the prison (non-programming unit), or I could enter the Aftercare Phase of the program.

I chose to continue in the program....

I graduated the Aftercare phase on August 17, 2012... (see attached certificates)

It is now December 2013 and I have been working on changing everything about myself, my character, and my way of thinking.

Refining positive social interaction and good habits along with responsibility.

Total program time completed 3 1/2 years or 42 months and going.

I am currently still in the residential program as a mentor, big brother, and positive role model.

This program is recognized by the state of Nevada, the Nevada department of corrections (parole Board) the director of prisons, the director of programs, as well as the various wardens within the system.

It is a nationwide Program model in use with the department of justice.

I like to share my personal experiences with people, especially if I know that it will benefit them in some way.

## QUALIFICATIONS AND ACCOMPLISHMENTS

I am a High School Graduate. Deleware Valley High School Class of "86" Philadelphia Pennsylvania.

I completed the Carpentry and Building maintenance course from The ORLEANS TECHNICAL INSTITUTE in Philadelphia shortly thereafter.

For a few years following, I worked as an independent contractor building and refurbishing equestrian centers, barns, horse stables all over the tri-state area NY, NJ, PA. I worked for a couple of years building new homes at high elevations of the POCONO Mountains. Laying the foundations to finishing carpentry, including interior and exterior roofing, tiling and painting.

Following that experience, I moved to a town by the ocean, Ventor, New Jersey (1990)
My love of life is the ocean; I involved myself with boats and the seafood industry. I worked at the
"FARLEY STATE MARINA", also known as TRUMP MARINA hotel and casino. I was self employed boat
detailer Started from the bottom and worked way up to bigger and better things. By the end of that
Year, I was well known in the Marina, had made a name for myself, and was well liked.

My familiarity with boats, turned into working knowledge of Sport Fishing Yachts. Then to commercial fishing vessels to 150 ft in length. A little over ten years in the boating industry, I acquired the following skills: 1. Mate, Engineering and ship Electronics systems. Aids to Navigation, Storm Systems, Communications, Survival Techniques, CPR, Hypothermics, PFD's (personal floatation devices).

## PRISON RECORD

The last time I had a disciplinary issue was over 1 yr ago.

The rule violation was: Misuse of supplies (I had cleaning supplies left in my personal area)

This was a low level, minor infraction.

I received a verbal warning.

I am out of my element here. There are few like me in this environment. I have morals.

I do my best to be the best person I can be all the time. I attend school here 20 + hours per week. Independent studies.

I am enrolled in the following classes five days per week; Business management, Entrepreneurialship, and advanced computer skills.

I have not been denied for parole. I am managing as well as can be expected considering where I am.

I have goals and aspirations for the near future and distant future. For now I'm awaiting to see about restructuring my sentence through the appelate process.

There are other ways too, such as the pardons board, motion for modification of sentence, motion for reconsideration. All of which I need an advocate for assistance, pro bono counsel etc...

cannot do it alone.

## IN CLOSING

I just want you to know that I am a good person with a good heart. I am intelligent. I have made a few mistakes in my life. I am not some hardened criminal.

I love people, I am an animal rights activist and want the world to be a better place.

Anything that has positive energy is what I seek. I don't belong in a prison.

I am grateful for the people who count on me, inve me, and are pulling for me.

I hope I have provided enough information.
