



Wow Nicki, I thought you'd been mauled by a kaola or something!

Was gonna write you when I was in the feds, but didn't have your address

notice I'm 6'4"? Grew 2"! until I came back + was given property with a postcard with your address on it. (Is it the same still?)

Anyhow, yeah, I know your character is good, but Joan offered to help transcribe my prison bio + has published before, so I'm going to give her a chance. Do please look her up + ensure I'm not being catfished. You might want to network anyway: [joan@forensic-psychology.net](mailto:joan@forensic-psychology.net) If she opts out, I hope you'll still be willing to "take the case".

There are 3 other projects I need outside help with, which I'd trust you with. Please let me know if you'd be willing to handle:

1) Transcribing for e-publishing on wordsmash my three poetry/song books. Two of these are posted on prisonsfoundation.org, mis-listed under the titles "Selected Verse" + "Em Daer" - they're actually vols. 1 + 2 of EM DAER ("Read me backwards"). At the moment, because I'm revising vol. 1 + its cover, I only want vol. 2 transcribed, as is; then use a graphics program to remove my crappy photos + my address from the cover (so it looks crisper) - then post it on wordsmash ASAP.

2) Running the "official" Prometheus Writes! facebook page - [facebook.com/Prometheus-Writes!](https://facebook.com/Prometheus-Writes!) Repost what I post on my blog on that facebook page (please get a lock on those URLs now). This would be a full-time job, meaning whoever does this, that's all I'd want them to do for me.

3) Set up a kickstarter/gofundme page seeking donations to pay off my 10 grand debts + provide me postage + paper to continue my writing + litigation. If that sounds greasy, consider that one guy sought 20\$ so he could buy a pizza ("I never ate one"?! ) + got 20 grand,

which he used to throw a pizza party for his town. I'm not looking for a pizza - that would be a dream. I'm looking to pay off debts I owe for filing suits + appeals to secure rights for prisoners, which, until the debts are paid, stops me from buying deodorant, shampoo, paper, postage, etc. - none of which are provided by the prison. Some people will hate, just because I'm in prison. But others will see my needs as worthy. This too would be a full-time project, all I'd want one person to do. Whoever opts to run it, let me know (Joan or Nicki) + I'll post what should go on the page, + you'll need to let me know what the sites require.

You already know that any \$ I get from royalties is going straight into... a lifetime subscription to Prison Legal News, paying bills, maybe hiring a lawyer to help me bitch-slap the WI DOC in court. Say I earned a million - what am I gonna do with it, buy 400,000 snickers bars? My nature is not inclined that way. (Sadly I've known inmates who're rich + piss their money off, do nothing to improve the environment.)

Anyway, what, you got a Masters in Psych. + crim' now? Please clarify.

Yeah, generally, America's prison system is backwards, in major part to Bible-thumping scum who dislike reality. Prisonrats project their devils on us, then cry when they get a horn in the butt. The U.S. bates its own citizens, a least a large chunk of the voters do, thus throws them away, struggles to degrade them, + is absolutely baffled at someone like me, who understands + firmly resists.

Some prisons are more humane, like Coleman @ USP, in Florida. But even there it wasn't perfect: 1) dope flooded the yard; 2) there was less respect from the inmates towards each other because they felt too safe, which results in serious violence; 3) some asshole staff try to make prisoners miserable.

Look forward to getting those photos + post cards! 😊 You know what I like.

The only reason you won't hear from me is if something other than me is causing it. And, if I seem overzealous about promoting my endeavors + self, well, that's because I'm buried alive + need help to get out.

I figure Joan should read this too, as you should read my letter to her, as they concern the same subjects.
