These photos - on this letter + Nicki's - should be interesting because they show that when I first arrived in the B.O.P. I was 6'2" + 170 pounds. Somehow I grew 3 inches + 30 pounds a year + a half later, at age 40! Tells you how the WI prison system physically wrecks inmates. Clearly I was malnourished.

Anyway, Joan, yes I got that message from that company; + I sent them a letter for you, with a S.A.S.E + a letter to them cussing them out for not explaining how I'm to reply nor including your address so I could mail you a reply. Don't say the company name, so I know stuff from there is yours.

Because I've been catfished before I'm asking Nicki to verify who you are, etc. Ha! No, I don't have anyone to send you e-mails; if I had that, I'd have a facebook page, etc. by now. Meeting people who are simply sane is hard for me. :)

Uh, I prefer psychologists. That's nothing to be shy about. At least a psychologist should understand the human psyche. Of course, as you seem to know, most psychologists are incompetent, with judgement clouded by their own problems or projections, + once they get a Ph.D. they can disregard valid critiques, especially from a "stupid" prisoner like me. :)) Have yet to meet a psych. in the WDOC who adheres to the ethics for licensed psychs (e.g. they'll diagnose prisoners as the administration directs - once a shrink labelled me as having "narcissistic features" b/c I ~~saw~~ myself as a "savior" for mistreated prisoners; her "prescription" was that I lay off writing complaints + suits for one week...), or is even a decent human being. While in the B.O.P. I met two At psychologists - Dr. Mitchell @ Allenwood U.S.P. (he used to bring me issues of Scientific American + Nature when I was in seg, wasn't

hating on my brilliance) + Dr. Sierra @ Coleman 2 USP (beautiful heart!) But lets leave that subject alone, for now.

Huh, if you are who you say you are, I'd be thrilled to have your help e-publishing my prison auto bio (vol. 1 — which is approx. 300 pgs + stops after I stabbed a guy in a psych. prison + was sent back here). The rough draft is done (160 pgs, 5-600 wds. per page, so approx. 300 pgs typed.), as is 1/5 of the final (waiting for yellow legal pads, which is what I started writing the final draft with. Six of the over-a-dozen drawings are done. Archolle has most of the doc's for the appendix, so I'll have to get her to mail them to you — so, up your address please!

Can you please send me info — case captions, courts cases were in + their addresses, + attorney names + addresses you were hired by — that I use to verify that you're not a one-eyed gay paraplegic who just wants to jerk off (with prosthetic help) over wasting my time? Yes, I've had people like that try to insert themselves into my already disturbed life. (That's why serial killers exist!)

Please read my letter to Nicki too, so I can write more here.

Let me know the terms upon which you'll take on this task. Editing advice will be considered, but, probably little will be needed — I made a handwritten copy of On Writing Well, Creating Short Fiction, The Elements of Style, etc. — + I want to keep my voice. I'd love for you to extensively comment through the text, provide psych. analysis, in which case you'd copyright that material + you'd deserve 50% of royalties from the product; how to format that'd be tricky.

There's a lot of "racist" stuff, how I came to join the Argon Circle + be more racist, due to Black racism. But I'm not promoting racism, just being totally honest. You okay with that?

The book will be titled No Way Out: One Man's Journey Through the Wisconsin Prison System, + you should secure a facebook page like "No-Way-Out-Books" on which, eventually, the beginning of the book + its cover will be published + you'll post about our progress on the book, to help build an audience. Pre-selling of the book.

I'm totally honored to have you on the team for this project! ☺
