PROS

RE: "INTERSTATE TRANSPORTATION"

Pros are in essence the reason for the "Freedom Rider" and those reasons were to;

- 1). Test the enforcement of the federal Desegragation Laws in "Interstate Transportation"; of which fell under the "Interstate Commerce Clause" of the United States Constitution
- 2). Plainly put "freedom Riders" wanted to change things, wanted to change the white racistsocial norms in amerika.
- 3). Not unlike any law as is with the U.s. Constitution it isn't self-activating, it must be exercised used either use it or lose it.
- 4). It follows you can't say you have a right unless you've actually exercised it and; thus the PROS to the Freedom Riders,

THEY WERE SIMPLY EXERCISING THEIR CONSTITUTIONAL RIGHTS.

- 5). Freedom Riders were a psychological conditioning of YES WE CAN.
- A). And to the white racist it was to say: SEE! SEE!
 WE DID IT, WE HAVE INTEGRATED YOUR "Interstate Transportation" and your
 "Interstate Transportation" facilities.
- 6). BENEFITS: were enormous to open a new world for blacks in interstate transportation without being limited to back kitcken doors for food, using an out house in back of a bus station; allowed only motel/hotel accommodations in black neighborhood and possibly far away from the Bus Terminal; Tran terminal etc.
- 7). UPLIFTING OF SPIRIT: With intergregation of "Interstate Transportation" Black could NOW feel as a whole person now equal in some way as were WHITE whereas, "Interstate Travel" before because of segregation was usually dauting and fearful to many,
- 8). Even from my experience in the post"Freedom Ride", my old people during the fifties would say as soon as we would cross the ohio river into Kentucky, called the Mason Dixon Line, they would say "Let us pray, because our hearts are in our hands now." Whatever that was suppose to mean. Anyways,
- A). Desegregation of Interstate Transportation was MERELY EXECUSING A

CON'S TO BEING A FREEDOM RIDER

RE: "interstate transportation

Con's are in essence as to why one should not have been a"Freedom Rider"
Reasons why one should not intergrate the Interstate Bus system and facili
ties.

- 1). It was disruptive and attempting to break up decades old well established laws of legal precedents; and cultural norms.
- 2). It was literally throwing dirt on the "FEELING" and "BELIEFS" of many. many people mostly whites, but I am sure a few blacks who had accept segre gation as an acceptable way of life.
- 3). OBVIOUS CON: of not engaging in "Freedom Rides" would be to avoid serious injuries and even death.
- 4).SOCIAL STIGMA: A Freedom Rider in his community would/may be known as an agitator simply by participating in the Civil Rights Struggle
- A). To most whites in those southern state and a few blacks, they were creating a problem that wasn't henceforth there before and therefore, Freedom Riders were looked down as the PROBLEM.
- 5). OSTRACIZED: Freedom Riders couldsuffer and would be ostracized by whites and local law enforcement as a "TROUBLE-MAKER".
- 6) RETALIATION: Freedom Riders could suffer and most likely would suffer retaliation from their white employers, racist or otherwise - who felt that he had to fire him and or that it would be in the best interest of a white employer to fire an employee participating in civil disobedience.
- 7). FREEDOM RIDERS FAMILIES: Families could and would also suffer collateral RETALIATION(e.g. injuries, death, lost of employment along with the social stigma of having a family member participating Civil Disruption attracting national attention.)
- 8). CREATED MORE RACISM AGAINST BLACKS: Freedom Riders agitation of white supremacist and segregationist could have provoke they to engaged in renewed, neo-Ku Klux Klan terrorism, bombing of churches, raping of black women, killing of blackmen, lynching of blackmen; and trumped up charges of arresting blackmen to reenslave them
- (). "ACCOMMODATIONIST RHETORIC", A black school teacher scolded one of the freedom riders for delaying the bus, adding that whether you sit in the back or fron you'll still reach your destination.

Dear Warden:+

Pursuant to our conversation some weeks past regarding my complaint that you are illagally holding me here against my will without probable cause that I am indeed an ancient twenty-plus year release violator. Warden as you are well aware this grievous and gross injustice happens to blackmen in ameri-Ka all the time.

I am poor, black and old and my life is meaningless to anyone saving myself. I am in my twilight-years and I would prefer not to die in prison as punishment for being wrongfully punished in California. Warden, I fully realized this is a godless state and my wrongful enslavement is meaningless to anyone who has the power to rectify this injustice.

Well, its up to you warden, alls I can do is ask; I am certain my five child ren 16 years old and down would appreciate seeing/knowing their father for the first

time before he died in prison



PROS

The U.S. Supreme Court in Morgan V Virginia in 1947 and; in 1960 in Boynton V Virginia Banned all racial segregation on Interd state Buses and trains. It also ruled that the restrooms, waiting rooms and lunch counter terminals should be open to everyone.

The U.S. Supreme Court had ruled twice on this matter, so you'd think that would be the end of it

- 1). For those of you who may or may not know the U.S. Supreme Court has no enforcement authority, it is up to the excutive branch of the government to enforce the Supreme Court's Order and in specific, the President of the U.S. States.
- 2). So, as you can well imagine the southern states completely and totally ignored the Supreme Court's oder to desegragate its "Interstate Transporttation"; and so did the White House
- 3). Now bear in mind the U.S. Supreme Court had already ruled segregated Interstate Transportation was unconsitutional
- A). The first Freedom Ride was in 1947 after the Supreme Court's ruling and the PROS were,
- 4). To end the <u>pent-up bitterness</u> of years of seeing the colored people pushed around; to embrace the responsibility of being a witness and to confront the oppressor.
- 5). To challenge Jim Crow and; a part of an ever widening struggle for Civil Rights and Human Rights
- 6). To challenge the sanctity of segregation.
- 7). To challenge the delicate balance of southern racial etiquette. and;
- 8). There was the rising militancy of the DOUBLE "V" CAMPAIGN which sought victory abroad and the racial discrimination at home.
- 9). To test the enforcement of the federal Desegragation Laws in "INTER-STATE TRANSPORTATION"; of which felled under the "Interstate Commerce Clause" of the United States Constitution.
- 10).Plainly put "FREEDOM RIDERS" wanted to change things, wanted to change the white racist social norms in amerika.
- 11). Blacks during that time-period blacks had the right to desegregated interstate travel
