Dear Mr. Phipps:

The Department of Enterprise Services, Office of Risk Management, has reviewed the tort claim filed against the state of Washington on April 07, 2016. Your claim alleges sexual misconduct against your person by a Washington State Department of Corrections (WSDOC) staff member. You are seeking \$25,000.00 in damages.

You allege that on March 23, 2016, a WSDOC correctional officer intentionally rubbed his genitals against your right side and lower butt area while escorting you into your cell. This is the only information you provide.

Our review of your claim as submitted does not support a finding upon which to base any payment as required by statute. Per Chapter 4.92.040 (5) RCW, "All claims, other than judgments, made to the legislature against the state of Washington for money or property, shall be accompanied by a statement of the facts on which such claim is based and such evidence as the claimant intends to offer in support of the claim..."

With the exception of your accusation, you have provided nothing that would support a prima facie conclusion that a tort had been committed (i.e. documentation to support that you attempted to address this alleged incident with WSDOC management on the date it allegedly occurred, and/or a detailed narrative that would lead one to suspicion the alleged physical contact was other than incidental).

Based on the evidentiary inadequacy of your claim, our office has no alternative but to respectfully deny your claim.

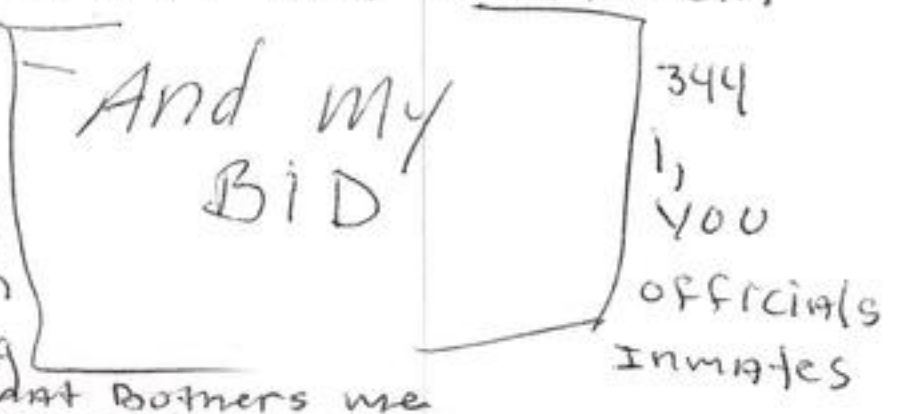

Dear Mr. Phipps:

The Department of Enterprise Services, Office of Risk Management (DES ORM), received your claim for damages on April 08, 2016. You allege that a Washington State Department of Corrections (WSDOC) custody officer "rubbed his genital up against the right-side of [your] lower body and butt area" on March 26, 2016, as you were being escorted by the same "to the yard and shower". You are seeking \$25,000.00 in damages.

Before this office can proceed with a directed investigation, we need you to answer the following questions in detail by April 25, 2016:

1. What were you wearing when the alleged genital contact occurred?
2. What, if anything, was said to you by the alleged offending party prior to, during, and after the alleged genital contact?
3. Provide a very detailed narrative of exactly what happened prior to, during, and after the alleged genital contact.
4. How long did the alleged genital contact last (i.e. minutes/seconds)?
5. Was the alleged offending party flaccid or erect when the alleged genital contact occurred?
6. How soon after the alleged genital contact occurred did you report it?
7. To whom did you report this alleged genital contact and by what means did you do so?
8. Have you ever experienced a similar incident to this one? If so, on what date(s) and by whom? Please apply questions 1-7 to any alleged prior incidents.

Should we not receive a chronologically formatted and very detailed response to the questions presented in this letter, the merit of your claim will be impacted accordingly.
