Dear Commissioner Spencer:

Possibly you could inform me if the department is still in favor of "Family Reunification Programs" as it states on its website and indits annual report. It appears that "Team DOC" (or at least the squad here at MCI Shirley) are not adhering to their professed game plan.

We have been attempting to have the "Family Reunification Program" here at MCI Shirley since 2011. We have received nothing but excuses and mixed messages from the Deacon and the Deputy here. This program was held, to great acclaim, three (3) times thus far at MCI Norfolk. What is the problem here at MCI Shirley?

Just recently we were given three (3) seperate "excuses" by Deacon Art Rogers as to why the program did not take place on its scheduled dates;

- 1) The Office of Christopher Mitchell had some "problems" with the proposal and it had to be modified. The funny thing is that Director Mitchell claims to know nothing about that.
- 2) That the "format" that the program was proposed on was the wrong one and that it had to be resubmitted. And now,
- 3) That Deputy Karen DiNardo says these programs are "not running" anymore in the DOC.

It was downright disrespectfull for Deacon Art and Deputy DiNardo to keep Professor Stephen Pope, from Boston College, waiting for two (2) years to facilitate a program it seems neither one of them support. Professor Pope was eager to run this wonderful program here but instead the adminsitration would rather have the facility rise to number one in drug use in your system. How do you let them get away with it?

Please let me know if they are a "Yea" or a "Nay? You may want to change your website (and annual report) or at least for here at MCI Shirley.

Re: RESOLUTION OF PURPORTED "UNDERSTAFFING" ISSUES at MCI SHIRLEY

Dear Commissioner Spencer:

My hopes are that your office can instruct your subordinates here to begin operating the prison at full operating capacity. For close to a year this facility has operated at a limited capacity, with the law year this facility has operated at a limited capacity, with the law library, school, programs, and religious services, shut down on varying nights. Your experience as a former superintendent lends you the knowledge that such closures, and the inability of men to access positive knowledge that such closures, and the inability of men to access positive activities, results in men engaging in counter-productive activities (i.e. activities, alcohol use, tattoo art, gambling, etc.) which diminish public safety rather than enhance it.

Captain Stubbert (the evening shift commander) instructed us that Deputy Karen DiNardo had issued an "order", via email, that he not open the school building on certain nights, not open the voc ed building on other nights, and to force men to hold religious groups and programs in classrooms rather than the prison chapel. When recently questioned about the "new hires" here at the prison, creating higher staffing levels, Captain Stubbert said that Deputy DiNardo's "order" is still in place. I have REAL to say this perplexes me. This Friday night the recreation coach "Fred" DOLT was asleep in the break-room of the school building while the gym and voc ed building were closed. There was an officer with him in the school building (who did in fact stay awake and do his job) but the rec coach was dreaming of greener pastures. Most nights when the school building is closed (especially when Sgt. McGarvey is working) there are two or three guards (a mixture of sergeants and line guards) hanging out in the break-room of the school building, but the building is still closed. Many nights we have two (2) captains patroling the walkways (Stubbert and Hebert) but they cannot find one (1) guard to open the Chapel (voc ed bldg.) for religious services/programming. Volunteers vocally complain. Program attendence is depleted, but no one seems to care. When men from groups, volunteers, clergy, or anyone else seek answers it all seems to point back to Deputy DiNardo. Is she the new superintendent here?

With the numerous new hires here at the prison I cannot see a reason, other than guard apathy and administrative neglect, that the yard, gym,

school building, and voc ed (Chapel), should not be open every night. Public safety demands such. I am personally enrolled in the "Alpha Program" on Friday evenings and I have watched as attendence has declined since the Chapel was ordered closed by Deputy DiNardo on Friday nights. The volunteers are angry as they make the long trip here only to be stuck in a classroom instead of the Chapel. It is a religious program that requires the Chapel. no one here cares. We need you to care.

68% of the DOC budget goes to salary. How can there not be enough guards? You and I both know there is a 2.2 to 1 prisoners to staff ratio in your department. When the news gets out that the prison is "closed due to lack of interest" someone will have egg on their face. The buck stops with you. Please intervene.

I have reviewed your letter and offer you the following. Due to a variety of issues, a directive was issued departmentwie to consolidate programming. The recreation, library, religious, and programming schedules have been reviewed
and restructured to allow for appropriate space for the scheduled programming. As you note, some volunteer
programs have been relocated, however, the services of recognized religion are conducted in their designated place of
worship on the designated worship day(s).

Although there have been basic training classes conducted, it has not offset the staffing needs department-wide. I have spoken with the Captains and they do make rounds each shift and are available to speak with volunteers, staff, and inmates. I will not discuss the staffing of this facility with you but can assure you that all programming, recreational and religious needs are addressed in an appropriate manner.

Re: CLOSURE OF LIBRARY/SCHOOL BUILDING - STAFFING

### Dear Superintendent Ryan:

I continue to have serious concerns and questions over the claims of "understaffing" here at MCI Shirley which is blamed for the closure MOM of rehabilitative opportunties. Let me give you another case in point; On Sunday afternoon, June 16, 2013, there were three (3) guards assigned to the yard [CO Williams, CO Goodsell, and CO Smeltekop]. They sat very comfortably while the school building/library was closed. Also on duty that afternoon were Lt. Irwin, Lt. Cormier, Sgt. Murphy and Sgt. Charleston. Abb Lt. Irwin was able to make rounds and Lt. Cormier was available to conduct pat searches on the way to the yard, but not one guard could be secured to ope the school building. It continues to perplex me, and RIDE THE I believe will perplex the taxpayers when they find out. My interests "FLWIN]" are to be able to access all rehabilitative opportunities. Partial operations, with guards basking in the sun out in the yard, diminish my quality of rehabilitation. Staff seems more concerned with excess water bottles, extra rolls of toilet paper, and antenna wires sticking out of windows than they are with rehabilitation. The attitude of your Unit Team Lieutenant is horrible and I have always been taught that attitude is reflective of leadership. It is folly to allow Deputy DiNardo to instill attitude in your unit team. Disrespect breeds disrespect, but the opposite is also true. You must set the tone.

I am asking that you please see to it that when there is adequate staff that all operations are functioning. It is very obvious to me that your staff are fully abusing these so called "understaffing" claims. There must be oversight.

I know I am probably hoping against all hope but I would ask that you ensure operations are "open" and that your unit team focuses on the bigger picture rather than being a punative, nit-picking, attitude patrol. Thank you.



Re: SUNDAY SCHOOL BUILDING CLOSURES

Dear Superintendent Ryan:

On Sunday, June 30, 2013, the school building was closed for both the morning and afternoon movements. There were two (2) guards posted in the yard for the afternoon movement: CO Williams and CO Tosti. Sgt. Garcia-Sturges seemed to be floating around as well, but still the school building could not be opened. The programs building is not staffed on weekends, but it still appears that the prison cannot operate at full capacity.

It is my right, under G.L. c. 124, § 1(e), to be rehabilitated. I offer that it is damaging that right to have a prison that is only partially operating. The staffing of the school and voc ed buildings must become as important as the staffing of the towers and vehicle trap in order to reduce recidivism. You never "close" the towers. You never "close" the vehicle trap. Why then are education, programming and religious opportunities closed?

My hopes are that you may be an advocate for full staffing. The guards union has crippled your prison. Someone must speak out. As I am sure you are aware I always will from my restricted, but ever broadening, platform. My hopes are that you would consider meeting with prisoners here to discuss expanding opportunities here. There should not be this great disconnect between your office and the lives you are duty charged with overseeing. I would be more than willing to assist you in arranging such a meeting. Just let me know. Common ground can always be found if parties are willing.

Thank you for your time and anticipated attention to the needs of the prison as well as consideration toward meeting with your wards.

WHAT A LAZY BASTARD!

Dear Deputy DiNardo:

On Thursday morning, July 4, 2013, CO <u>Swanfeldt</u> was assigned to the post in the school building. He informed me that the "Shift Commander" had ordered that only the "law library" portion of the school building be opened while the "library" portion of the building was to remain closed. I informed CO Swanfeldt that each day only one (1) guard is assigned to the school building and that both the law library and regular library remain open, along with classrooms. I asked him why today was different and he stated it was the call of the shift commander. I asked who the shift commander was and CO Swanfeldt informed me it was Captain Kenneway.

I am uncertain if the shift commander did in fact issue such an order, all I can offer is that CO Swanfeldt said that he did. My concerns are that this may become some type of practice here. As you know our access to the building is already limited by purported "understaffing" and any further limitations on access would prove detrimental to rehabilitation and access to the courts. The school building is regularly staffed by only one (1) guard with all activities able to operate. I would ask that you look into this matter and ensure that the entire building is available when it is open. I can see no penological interest in closing the general library while opening the law library, or vice versa.

Thank you for your time and anticipated attention to this matter. My hopes would be that you notify me of your findings/conclusions.

I spoke with the shift commander in regards to your observation of the law library being open and the general library being closed. Captain Kenneway indicated that he was able to assign a staff person to the school building on July 4. There may have been miscommunication with this staff person, as the captain was not aware that only the law library was open, however, that was his motivation for opening the building.

I would like to reinforce that classrooms and other space in this facility are not accessible to inmates unless there is a scheduled program with staff or volunteer supervision.

It is also significant to note that the shift commander is unable to predict emergencies and has the authority to utilize staffing as he sees fit.



Dear Deputy DiNardo:

I am safely in receipt of your letter of July 6, 2012, in which you respond to my June 7, 2012, letter to Superintendent Ryan concerning Frank Soffen. I am very disappointed in your response, as I always viewed you as a more compassionate individual, but I guess prison hardens both prisoners and administrators.

Superintendent Ryan's new "directive" does not trump Frank's constitutional right of access to the courts. Frank cannot use the satelite law library, as he is too debilitated, and it is a fact that the law clerk who visits the HSU cannot handle Frank's needs. That law clerk has admitted such to me, as well as has offered me an affidavit stating same, but I told him it was not required at this time. I was stunned to read that you, "Question how my credentials prove to be superior." All I can say is that I have prepared over thirty (30) parole packages for second degree lifers, many of whom are home today, as well as just had a disciplinary report vacated in the Suffolk Superior Court on June 25, 2012. I have many other legal victories, but I won't bore you with the details. I help lifers get out and stay out - those are my credentials. I am a DOC certified law clerk, but we know that means little, but mostly I am self-educated in the law. My best credential is I care for Frank - he is my Catholic brother, and I can help him. My years of experience, as a Board member of the Lifers' Group, Inc., allowed me to become one of the most proficient men in the system in perfecting parole packages.

Enclosed you will find a "Power of Attorney" FRank has afforded me. My request is reasonable - to meet with Frank in the HSU Satelite Law Library for one (1) hour per week. My prayers will be that we can agree to this amicably. I would be willing to test my "credentials" in another civil litigation, but why is that required? Frank needs help, I can give it to him, and I know have the legal right to act on his behalf. These matters should never be adversarial.

I will take you on your word that Frank's health is, "the priority at this time, but I cannot, and will not, sit back while he dies over in the HSU.

I simply stated that I believed he already had a power of Attorney in the past ans that I wanted to check with Deputy Dinardo first prior to notarizing another one as I have concerns as a notary. My first goes with what Legal has already stated in regards to one inmate having control of another. Inmate Soffen can hardly sign his own name and my observations of him indicate that he is often confused. With that said I do not believe that he authored the original document and I am not sure if he has the ability to understand what the document language actually states. With that said I will not notarize another Power of Attorney letter for him from Inmate Muise as requested.

Please review complaint below (which appears to have been authored by Muise) and advise. You probably already know, but the DOC is not required to provide Notary Services, and DOC Legal has worked on this in the past. I will send the email, which is approx. a year old, that relates to Soffen/Muise. In the email, DOC Legal's Margaret Melville asks me to send her grievances related to the Power of Attorney issue. Ok to do that? Thanks,

#### COMPLAINT:

I requested to have a "Power Of Attorney" (legal document) notarized here at the facility. Director of Security Paul Henderson (the purported Notary Public) took the legal document from me stating, "I have to look into this Frank." I was then informed by the HSU Law Library Clerk that DOS Henderson had informed him that Deputy Karen DiNardo instructed that my official legal document, a power of attorney authorization, would not be notarized on her orders. Under the "Standards of Conduct for Notaries Public" (Governor's Executive Order of 12/19/2003, "Standards of Notaries Public") a Notary Public "must serve anyone who makes a lawful and reasonable request for notarization..." and goes on to state in the same section, "these provisions do not (emphasis added) allow notary to refuse services based on the status of a signer." My request is lawful and reasonable and it is a violation of the sworn duties of a Notary Public Henderson to refuse notarization of my official legal document. Deputy Karen DiNardo's order not to allow my document to be notarized violates Massachusetts law and is actionable. [See Revised Executive Order No. #455 (04-04)]

#### REMEDY:

Immediately have my official and legal Power Of Attorney document notarized before I suffer further damage and rights violations. Train Deputy DiNardo and DOS Henderson concerning the law governing notary services.
