Dear Mr. Phipps:

The Department of Enterprise Services, Office of Risk Management (DES ORM), has reviewed the tort claim filed against the state of Washington on April 08, 2016. Your claim alleges that a Washington State Department of Corrections (WSDOC) custody officer “rubbed his genital up against the right-side of [your] lower body and butt area” on March 26, 2016 as you were being escorted by the same “to the yard and shower”. You are seeking \$25,000.00 in damages.

Our investigation of your allegation revealed no remotely credible evidence of the incident as you described occurring both in your original tort submission as well as your “more detailed” response received in our office on April 25, 2016. Our review of numerous WSDOC videos memorializing your escorts to and from the yard and shower, including the two dates you mentioned, depicted nothing like you described.

It appears that perhaps you take some form of pleasure in making very serious, but false, allegations against WSDOC staff. Our office has taken note of this. Based on the outcome of our investigation, your claim against the state of Washington is denied.



- Law Librarian (Lisa ~~Matten~~) filled gaps and directed non-effected offenders away from the scene and to lay down on the ground.
- Staff were very conscientious and knowledgeable of crime scene preservation and acted within policy guidelines.
- Local I&I staff did an exceptional job with response and follow up of the incident. Appropriate reports, evidence, and Infractions were collected and shared with local PD and prosecutor.
- CISM activated the day of incident and a follow up approximately a week later with debriefing. All staff are very aware of CISM and had nothing but compliments regarding your local chapter.
- Management response and follow up to the incident was received very well by all staff interviewed. The superintendent responded to the hospital and checked on injured staff. This was HUGE in the eyes of your staff. Staff here had the upmost respect for the entire management team at Walla Walla and staff morale was OUTSTANDING.
- Mark ~~Knighton~~ was an outstanding representative for Walla Walla with the CIR team. He provided our CIR team with excellent information prior to the visit and during our time at the facility. The booklet he provided upon our arrival was very thorough and complete. His work and information provided easily saved our team a day's work. His work was second to none.
- CC3 ~~Bell~~ met all of the guidelines concerning Offender Phipps. Offender's intake was completed in 9 days offender's arrival to the Unit (this gave the Unit staff somewhat of an idea who they were dealing with), also met guidelines of Offender Phipps ONA by completing it, and assigning him to the correct programs to meet the needs of that assessment.
- Mental Health ~~Miller~~ did complete an intake in a timely manner.
