friend in Houston and me had did a couple of roofing jobs

But that work was short in Texas. This is the only thing this Jail-House Informant said true that I had told him when he came up to me and started to ask me questions like what was I in jail for so I tell him that I was here because the police in Houston had me charged an unauthorized use of a motor vehicle, which I didn't know anything about. Until two detectives came to Oklahoma and had question me about my two friends' death: so this Jail-House Informant started to come talk to me everyday after in his question he found out I had money on my account books he kept asking to let him write me some motions to get the unauthorized use of vehicle done away with. But I kept telling him that I didn't need any motions. Because I didn't do the crime, so he suggested that I take the crime even if I didn't do it, so that I would not get nothing but about 3 to 4 months state jail time. This man had told me that he had been to prison 3 or 4 times and knew how to write motions, so I just kept telling him that I never did the crime, so by this time I had done been to court and was appointed an attorney. I even told him I had a lawyer but he just kept on wanting me to let him work for me: so by then he had his county time did and he gets out. And stays out for 2 to 3 weeks before he gets caught robbing pay-phones to buy crack-cocaine and he comes back to be ~~pross~~ process back in to jail. And there is where he decided to use me as his escape-gate to get him-self out of jail on his new charge. There was no other evidence to connect me to this crime of capital murder that I have a life sentence with almost 21 years did in prison for another man's crime. Even after this 21 years the man that did the crime will have to take my place in prison any pay his debt

For those two people whose death came to them by the hand of this other man who did have a motive because of some disagreements over some things this other man had stolen from my friend. That had just had a fight at a beer-bar around a week & a half before my two friends came up dead.
