for hundreds of miles, through multiple states until we reached a designated County jeail stop.

Our/my repeated pleas for ice water felled on deaf ears and when answered I was given warme bottle water that was already in the hot van. There was the <u>punishment</u> (dog) cage, the agents put you in few - a cage that you would only put a large dog in. I was unable to stand up or to stretch out my legs at all for hours.

I have lost some of the circulation in my right leg, both of my knees have gotten weaker and more painful. My back is so painful it feels likits broken. I am unable to stand up straight and walk for any length of period of time.

I am sixty-seven years of age in geriatric decline, trouble() ailing disable(DPV, DPM), NOW I am even more troubled with reaccurring nightmarss of being hogtied and shackled in that slave-van and while I asleep to PST agents run off the road and off a cliff. I see/feel myself crushed upside down, mortally wounded and dying, my life senselesslt lost.



#### DOMESTIC WAR CRIMES!

RE: Criminal Complaint; Report of Domestic War Crimes against U.S. PrisoneR Transport Services of America(PTS)., LLC, Nashvilee, Tennesee; appointed agents of the State of Ohio.

ELDER ABUSE, a felony, barbaric, inhumane treatment of a prisoner, abuse of authority. I was <a href="harmed">harmed</a> and my life senselessly put at risk. Cruel and unusual punihsment 8th, 14th Amendment Diseased and deprived cruelty, tobure, abuse of prisoner, sadism. 42 U.S.C. 1983 and in violation of A.R.S. 5121:1-1-35

Ohio Adult Parole Authority and Governor John R. Kasich did knowingly hire/appoint as their agents for the State of Ohio PTS of America to transport prisoner Otis Lee Rodgers a prisoner from the State of California to the State of Ohio, Lorain Correctional Institute, Grafton, Oh. On Saturday July 25, 2015; U.S. Prisoner Transport Service presented me with the Governor's warrant and upon inquiry agent Willard explained that U.S. Pri-

soner Transport Service was the same as PTS.

detention she was released.

I was handcuffed and shakled, put in a 6x44x44 metal cage built in side of the back of a regular van - forced to sit unrestrained on a metal bench with (7) other about two-hundred pounds prisoners; packed in like sardines in a can for a total of 11 prisoners(two females) in about onehalf of the van's capacity; all similarly hogtied; not unlike the slave ships of old. No ventilation, forced to endure mutual air of coughing and body gases; with a minimum a/c, temperatures ranging up to a 100+, DECRESS through Arizona, Texas, Florida etc. A travel period of about six days from California to Ohio making a dozen or so stop to Unload and pick up new slaves/prisoners. My fellow prisoners in this small cage at least a desen-er-se-times couple hundred times like a sack of potatoes on a roler coaster; snapping my neck, bumping my head and knees into other prisoners. This merciless pounding was for thousands of miles on an already injured back. The agenats were driving wrecklessly up to 90+ miles an hours at times - hitting bumps, turning sharp corners at unsafe speeds sudden stops to avoid accidents.

In Mobile, Alabama near the County jail Agent Willardand his goon partner stop the van in the middle of the road, jumped out, unsnapped their gun holsters, stopped the vehicle traveling horizon to the Van's path in the middle of the road; accosting and questioning the young white female driver - she began to cry - after about 5 minutes of interrogation

As the agents drove wrecklessly at high speeds to make time not giving a god-damn about their hogtied human cargo. Not unlike the nazis, fascist or racist white savages of old slavers. I flew up in the air and slammed down hard on my tail bone and injured back joint on the metal bench. I was forced to sleep handcuffed and shackled in the sitting position pressed up against the next prisoner. It was a sweatbox, tempers flaring and violent arguments ensued, pushing and shoving, prisoners slipping their cuff/chains to fight. The guards to quest the violents they would turn on the heater in 100 degrees temperatures. I was unable to bathe or to brush my teeth saving for two nigh that we checked into a County jail. The smell of human bacteria was beyond sickening and repulsive; one guy threw up when he was loaded into the van.

I could see the two females through the holes in the first van and through to plexagalls in the second van. One female was bleeding with a large cyst near her public hair area and crying because the agents refuse to stop to allow her to clean herself. The other female took matters into her own hands, pulled her pants down and urinated on the van floor twice and then in a bottle that she ripped the top off ( leaving her pants down for all to see in apparent anger and frustration as we disembarked the van at a County jail. I was forced to hold my body functions

At that same hearing Parole Board Hearing Officer Marc. C. Hauk "rejected" the charge that on or about 5-22-98 I was suppose to report to Ohio OAPA Deputy Administrator, Interstate Compact Officer, Gail A. Price on or about 5-22-98.

footnote: Ms. Pice was unavailable as a witness retired or dead.

I was found guilty of failing to on or about 5-22-98 (Bibing to provide my residence to OAPA.. Without a shred of proof I was never instructed, nor did I ever receive any instructions to provide my residence to OAPA on or about 5-22-98.

I was found guilty of violating <u>some tersm</u> by my 8-1-03 dated California conviction; I wasn't under any ohio release supervision on or about 8-1-03.

What is wrong with you white people why are you so evil and so corrupt and your perversion is to kill blackmen or enslave blackmen; when will you people evolve and grow up and stop being so lazy living off of the death, dying and misery of the Afri-Kan ameri-Kan Blackman?

The facts: I left Ohio on 12-2-92 and I did not return until forceably dragged in handcuffs, shackles and leg irons in a small van without A/C, packed in a slave ship/van like sardines forced to sleep on a metal bench unrestrained; eleven all total to include two females crying and bleeding, begging for a rest room break urinating on the floor leaving their pants down in protest for all to see when we did stop hundreds of mailes later; forced to hold our body functions and to smell each other is body fumes.; just like those white racist savages did during formal slavery in ameri-KKK.
