I AM TRYING TO GET ANOTHER TRANSFER TO A PRISON THATS JUST 15 MINUTES FROM MY PARENTS BUT NO ONE SEEMS TO BE WILLING TO HELP. THEY PRETTY MUCH TOLD ME I USED UP MY 1 FAVOR TO GET HERE & THATS THAT. SOME PEOPLE ARE WILLING TO HELP BUT THEY HAVE NO REAL POWER OR AUTHORITY IN HERE SO THEIR HANDS ARE TIED. BUT I WONT GIVE UP. I WENT ON A LETTER WRITING CAMPAIGN, ASKING FAMILY, FRIENDS & ASSOCIATES IF ANYONE KNOWS OF ANY PENNSYLVANIA POLITICIANS. IF POLITICIANS CALL THE D.O.C. HEADQUARTERS ASKING QUESTIONS AS TO WHY THEY WONT MOVE ME TO SEE MY DYING MOM, THEY WOULD PROBABLY MOVE ME. SO I AM EXHAUSTING ALL AVENUES. I AM NOW ASKING IF I CAN HAVE AN EDUCATIONAL TRANSFER TO THAT SAME PRISON IN ORDER TO DO ANY VOCATIONAL TRADE PROGRAM THAT THEY HAVE TO OFFER. WE'LL SEE WHAT HAPPENS.

LET ME ASK YOU'S ABOUT FACEBOOK. MY BROTHER RECENTLY MADE MINE PUBLIC SO ANYONE COAN SEE ME WITH THE PUPPY DOGS. BUT THERE ARE PEOPLE ON THERE WHO HAVE SENT ME FRIEND REQUESTS THAT I DON'T KNOW. MEN & WOMEN HAVE DONE THIS BUT THEY DON'T CONTACT ME SO WHATS THE POINT OF IT? I JUST DON'T GET IT. WHY WOULD YOU REQUEST SOMEONE, THEN THEY ACCEPT & I NEVER HEAR FROM YOU? KIND OF STRANGE. I KNOW MOST PEOPLE ARE ON COMPUTERS & NOT REGULAR MAIL BUT I DON'T HAVE INTERNET ACCESS. I ONLY HAD IT PUT UP SO PEOPLE CAN SEE THE PHOTO'S I PUT UP. I DON'T KNOW WHAT MY BROTHER & SISTER HAVE DONE TO IT BUT I WANTED PEOPLE TO SEE ANOTHER SIDE OF ME. NOT JUST MY CRIME. & NOW WE'LL BE GETTING PUPPY DOGS IN THIS PRISON. THEY WILL GO THROUGH OBEDIENCE TRAINING BEFORE THEY GO TO A SPECIALIZED TRAINING CENTER IN THE OUTSIDE WORLD. THESE DOGS WILL BE TRAINED FOR THE BLIND, DEAF, & PTSD DOGS FOR WOUNDED WARRIORS. AS MUCH AS I WOULD LOVE TO BE A PART OF THIS, I MUST DECLINE BECAUSE I AM ACTIVELY FIGHTING TO BE TRANSFERRED TO SO I CAN SEE MY MOM. BUT I'M SURE THE PRISONERS WHO ARE SELECTED TO BE DOG TRAINERS, THEY WILL MAKE THE PROGRAM PROUD.

IF MEAGAN BROWN IS READING THIS, I AM NOT SURE IF YOU GOT MY LAST LETTER BUT I HAVEN'T HEARD FROM YOU LATELY SO I HOPE YOUR MOVE WENT GOOD. LOOK FORWARD TO HEARING FROM YOU.

AND WHAT ABOUT YOU MARIANNE DANIELSEN? I STILL WONDER WHY I HAVEN'T HEARD FROM YOU.

I LEARNED TODAY THAT MY BROTHER JUSTIN LOST HIS JOB. HE HAS BEEN HEART BROKEN & DEPRESSED SINCE HE FOUND OUT HIS GIRL WAS CHEATING ON HIM. NOW SHE IS MOVED OUT & HE IS A MESS STILL. HE IS STRUGGLING TO MOVE ON. BUT HIS ATTITUDE & DEPRESSION CAME TO WORK WITH HIM & IT AFFECTED HIS JOB. SO NO HE IS UNEMPLOYED. I REALLY HOPE HE CAN GET IT TOGETHER. I'M WORRIED ABOUT HIM.

TELL ME HOW CRAZY IS THIS. MY SISTER DAWN HAS 3 KIDS. RONNIE IS 17, JORDAN IS 13 & RICHARD IS 11. HER BOYFRIEND RICH, HIS MOM RECENTLY DIED OF CANCER. DAWN WAS VERY CLOSE

TO HER. BUT HER BOYFRIEND USED A PART OF HIS INHERITANCE & BOUGHT A BIG BOAT. AND FROM WHAT I'M TOLD, I DO MEAN BIG. MY NEPHEW, 13 YEAR OLD JORDAN, HE WENT ONLINE AND TOOK SOME TESTS AND SOMEHOW LEGALLY GOT A BOATING LICENSE. HE IS 13, CANNOT DRIVE A CAR BUT HAS A LEGAL LICENSE TO DRIVE A BOAT. AND HE'S GOOD AT IT FROM WHAT I WAS TOLD. I DON'T GET TO SEE MY NEPHEWS ANYMORE BUT I WANT THEM TO HAVE AN AMAZING LIFE. I WAS WATCHING THE NBA DRAFT A FEW DAYS AGO AND RONNIE HAS THE CHANCE TO BE A PART OF THAT IN A FEW MORE YEARS. KID IS THAT GOOD AT BASKETBALL.

THE LAST THING ON MY MIND, A MAN, EBED DELOZIER, AND HIS WIFE ALLOWED THEIR BABY DAUGHTER TO DIE FROM SOMETHING AS SIMPLE AS AN EAR INFECTION. THE DOCTORS TOLD THEM IF THEY REFUSED TO GIVE HER MEDICINE, SHE WILL DIE. THEY CHOSE TO PRAY & THEY LET HER DIE. A SENSELESS PREVENTABLE DEATH CAUSED BY THE PEOPLE WHO WERE SUPPOSED TO LOVE & PROTECT THIS LITTLE BABY GIRL. THE HUSBAND WAS GIVEN . 1 DAY TO 23 MONTHS IN COUNTY JAIL, THE WIFE WAS GIVEN 23 MONTHS PROBATION. THEY KNEW THIS CHILD WOULD DIE IF THEY DIDN'T HAVE HER TREATED BUT THEY CHOSE TO PRAY AND LET HER DIE. THIS HAPPENED IN BRADFORD COUNTY, PA. THIS SICKENS ME. WHAT MAKES IT WORSE IS NO ONE SEEMS TO BE UPSET THAT THEY ALLOWED HER TO DIE AND THEY GOT NO PUNISHMENT FOR IT. THE NEWS ISN'T EVEN SAYING THE BABY'S NAME. IF YOUR CHILD IS EVER SICK. DO WHATS RIGHT AND TAKE HIM OR HER TO THE DOCTOR. NO CHILD DESERVES TO BE NEGLECTED BY A PARENT AND LEFT TO DIE. A PARENTS JOB IS TO PROTECT, RAISE, WATCH OVER. KEEP SAFE. PROVIDE FOR. MOLD. GUIDE & LOVE THEIR CHILD NO MATTER WHAT. THESE PARENTS FAILED. DON'T FAIL YOUR CHILD LIKE THIS. MY HEART BREAKS FOR THIS LITTLE ONE WHO IS NO LONGER ALIVE BECAUSE SOME ONE TAUGHT DELOZIER & HIS WIFE THAT PRAYER HEALS OVER ACTUAL MEDICINE. THATS ALL I GOT FOR NOW.
