Personnel (2nd), and providing "proper" care and supervision of all offenders under our jurisdiction while (lastly) assisting their re-entry into society. Okay then, "Proper" would entail Law. And for the purpose of Religion we have: U.S. Constitution, Amendment #1 - Freedom of Religion, which in matters regarding Prisoners is regulated by a Federal Statute 42 U.S.C. 2000cc Religious Land Use and Institutionalized Persons Act, which permits a standard for redress. Furthermore, Calif. Code Of Regulations, Title 15, section 3210 'Establishing Religious Programs' (a) states: Institutional heads shall make every reasonable effort to provide for the religious and spiritual welfare of all interested inmates, and (b) Depending upon the number of inmates, Chaplains may be employed or their services may be accepted on a non-paid volunteer basis. Then we have a Dept. Operations Manual, Article 6 Religious Programs, section 101060.5 Religious Program Activities: 'Shall include activities that will encourage inmate participation. The activities may include the following: • Regular Worship Service • Special Religious Observances • Religious Education • Interfaith Services • Meditation Services • Religious literature Distribution • Outside Religious Group Participation • Self Study Religious Courses • Speech Forums • Service Projects • Religious Interest Groups • Religious Societies & Orgs. • Participation in Community Betterment Programs.' Then we have DOM Article 9 Volunteers Section 101060, "Responsibility" 101090.5 Deligating responsibility to Mule Creek Community Resource Manager. The Approval-Appointment Standard (section 101090.6) is based on: Need of Service • Time/Frequency of Service • Space/Supervision. And then section 101090.10 relates to "Volunteer Minister Rights and Responsibilities", which states: Volunteers who wish to appeal a decision/disapproval of Volunteer position/program, may write to the Hiring Authority. Which in this case would be Warden Joe Lizarraga. If "Need of Service" is denied per "number of Scientology Students", then suggest section 101090.6.1.1 'VISITORS', stating: Wardens may approve a Volunteer to meet with an inmate during regular visiting hours for the purpose of facilitating specific program services.

FREEDOM MAG's mission statement prompts me to share my story about establishing a Scientology Prison Outreach (SPO) study group here at Mule Creek State Prison - Tone, CA, which is beginning its second year of existence now.

My story begins in 1985 though, if I may preface this SPO WIN!: Turning 21 in prison, I'd picked up a Dianetics MS-DH book, and my LSD & PCP addled IQ soared exponentially as so many MUs were finally given significance & learned to inspect for corresponding cognition WINs. I immediately wrote a letter to every Calif. Mission/Org. listed in the book requesting more LRH tech., ultimately receiving a reply from Tree Nebeker, who worked with me to develop an Extension Course program at Dual Vocational Inst.- Tracy, CA. We were able to interest several dozen prisoners who were doing coursework by the time I ended-up being transferred to Folsom Prison in 1987, where I fell out of communication with Tree, and the extension course program.

Though at 25 years old in Folsom, I took what I'd learned of LRH Study Tech. and applied myself to obtaining a GED. Then there was also the radicalizing demagogues who were disseminating their propaganda to satiate the burgeoning prison populations Answer Hunger which I'd also become fascinated with. Until I was released from prison in 1990 to Yuba City, CA where I met a Meth head gamine who eventually cleaned-up her act and got her boys back from their grandmother. I remember when her rambunctious lad was sent home from second grade with a psych. referral to be added to the Ritalin rolls; I had learned enough about the psych. industry and Preventative Dianetics to rather homeschool him - again putting my knowledge of LRH Study Tech to use. Those were the best years of my life, thanks to Tree. Assuming more and more responsibility, my dynamic exchange was the best ever! Until the devastating Meth epidemic hit home and National events triggered demagogic implants prompting me to rise an inverted U.S. Flag at Washington D.C. in 1995, begining my seditious crusades and adding to my GFM ridges. "The greatest good for the greatest number of dynamics", was the only think which kept me from blowing up our local courthouse of tyrants with the explosives an Agent Provocateur dropped off at my house in April 1997, which I'm serving a life sentence for now.

The ensuing decade of despairing rage then took me through a couple years of solitary confinement before being sent to Pelican Bay, where I determined to teach tyros to THINK for themselves. After a few years of that volatile vocation I was evicted, and a few years later, in 2008 (10 yrs into my life sentence) I was transferred here to Mule Creek, where

I threw-in the proverbial towel surrendering myself to a wee glee of insanity for a reprieve from the ennobling responsibilities. Consequently, mock-heroic display developed gradient degrees of that insanity until, discovering the dozen or so Scn./Dn books removed from the prison library shelves - I located them in the Chapel's storage room where I 'sequestered' them to my cell, certain that my reprieve was over!

In 2013, Joe Riley at BRIDGE Publications, had answered a letter I'd written proffering my usefulness here as Scientology's Inside Guy. Then he came into visit with me on X-Mas day ... my first visit in 16 yrs of exile! My utter Admiration snapped me out of my irresponsible condition right then and there, I'm glad to say. Yet it took most of 2014 to recover my integrity while voraciously studying all the material Joe was sending in through the Chaplain. And by Jan. 2015, I'd won a designated time to officially conduct Scientology Services in the Chapel Classroom. A generalized list of WIN's for 2015, other than my own recovered Responsibility, include: An increase in Criminon Course applicants and completions - making myself available to help resolve problems while also polling students assessment of Criminon Services to present for consideration; An entire facility of Staff and Prisoner alike witnessing several men's personal transformation under Scientology's standards; A flow of men who've been introduced to Scientology for the first time, clearing up MUs - be it from reading IAS/ABLE/Bridge Publications, watching our DVD's and/or listening to our LRH CO Lectures, or simply by picking up xeroxed articles we display for dissemination at our weekly group meetings where we discuss the tech, and demo what we're learning to apply in everyday life situations. Those of us who've determined to become committed students of Scientology have completed the Basic Study Manual, and have a new-found appreciation of study tech. We'll be able to help others with from here-on; We've changed erroneous Policy which was restricting personal CD purchases from Bridge Publications; We have managed to get Religious CD/Book titles from Bridge added to authorized care package vendor catalogues; We're establishing comm-lines with Prison Policy Makers in Sacramento; And I'm told that more Scientologists are developing an interest in becoming more involved too.

In this new era of prison reform concentrating upon actual rehabilitation services, now is the time for Scientology's VM's to get involved in this particular Fourth Dynamic Salvage campaign! Aside from the SPO groups to help prisoners rehabilitate their response-ability to face life challenges, I'm also postulating PR introduction of the Personal Efficiency Course to (the CDCR) Prison Guard Training Academies, eventually making way for Life Improvement Course classes for all prison staff. There is also an opportunity to introduce the science behind e-meter consultations to screen candidates for parole board release date considerations. And there are Transition Housing contracts available from CDCR, to help early release prisoners reintegrate back into society. The Fourth Dynamic salvaging opportunities with the U.S. Prisons are ripe for picking
