She died two months ago in prison. I want to say this to the parole board, Georgia and citizens. It's amazing how when you do wrong, you feel you should be forgiven. Believe me the state does not take care of inmates like they should. I am living witness, I almost die at the age of 24 years with my health issue behind these bars. They treated like they are inmates. Some get talked harsh and treated like they are a nobody. Inmates and staff is subject to be raped, shanked, beat up and even killed. The ~~accused~~ man accused of gunning down an Eastman police officer Saturday night had only month earlier pleaded guilty to shooting and wounding a man in neighboring county. Who is say ~~to~~ Mr. Keyheem DelShawn Deeds didn't take this plea bargain out of coercion - fear that he would get more time because two lawyers said it would be in his best interest. The truth of the

Mr. Royhem Delshawn Deeds might have not been guilty. Yet because he is African American. He knew he didn't stand a chance in the courts. The alleged cop killer Royhem Delshawn Deeds was arrested last August after shooting a man in the leg during an apparent altercation in Telfair County town of Lumber City. So my question is, is it wrong to have altercation with somebody, so I guess everyone that has altercation killed or shoot somebody. I am not knocking that ~~person~~ people do these things some time as result of altercation. Later, the best witness in the cases recanted a statement that implicated Deeds and the victim himself claimed not to know who had shot him who say this witness ~~was~~ even like Royhem. The individual could had a personal vendetta against ~~Mr.~~ Mr. Royhem. It could have been his divine moment to do him in even though he knows that Mr. Royhem didn't shoot him. But you see this particular witness has conscious got the best of him or her. They recant because they was ~~at~~ scared. They knew they was lying. Even so in April according to court records Deeds 24, pleaded guilty to aggravated assault in exchange for a sentence that included time served in jail and five years of probation. To me this sound like a coercion plea bargain. If you don't take this young going to get a large amount of time. No lawyer is to put fear in their client to make them do something out of fear. It's illegal to do this. This has nothing to do with Mr. Tim Smith death. The state is trying to poison the jurors and citizen minds before the individual go to court. Source with knowledge of Saturday's killing of Eastman police officer Timothy Smith told the telegraph that for real what does all this has to do with Mr Timothy Smith death. Deeds had only recently begun hanging out in an area on the south side of downtown Eastman where Smith was fatally shot. Deeds had bounced around from town to, ~~the~~ town he said and even had ties to the Atlanta area. Sound like they was trying to say he was a drug dealer. But let me say this. If this young man has not been arrested for drugs, his probation didn't restrict him from traveling or being in certain areas. Whoever gave that statement is bringing defamation to Mr. Rayhem's character on a sly trying to make the people think he was running drugs and that he didn't get caught. If Mr. Rayhem didn't have no restriction far as to where he could. He could go anywhere he wanted to who is the law to hinder him from doing that. Mr. Rayhem there presence at the ~~scene~~ scene is not sufficient to sustain a conviction of one being party to a crime, but criminal intent may be inferred from conduct before, during and after the ~~crime~~ commission of the crime.

The courts cannot convict Mr. Roykeem based off his mere presence of being in that area. But they would have to something he did before that was similar that show he wouldn't mind killing Mr. Timothy Smith. Their going to try to use his case where he pleaded to shooting this man in the leg. The witness recanted said he didn't know who shot him, which with that case that plea should have become null void and vacate along with his probation and record sealed because a witness basically admit to lying. But the courts being who they are continue railroad Mr. Roykeem, which they are trying to do in this case but I hope something prominent lawyer see this pick up Mr. Roykeem Deeds case because everyone deserve equal justice.
