

<p>I reviewed your initial grievance as well as all appeals and responses.</p> <p>DOC Manager, Tim Thrasher, also reviewed this grievance and provided this response:</p> <p>I reviewed your Level I and II grievance, the investigation, and the responses. I have read your Level III appeal.</p> <p>The Level II response appropriately addressed your issue. You are assigned to Maximum Custody (MAX), the departments highest custody level. Offenders housed in MAX custody do not have access to food items or hygiene items that offenders have access to in general population due to safety and security concerns. The hygiene items you do have the ability to order are adequate. Several of these items have been replaced with better quality products over the last two years. At this time no changes to the Commissary List which offenders assigned to MAX custody have access to are scheduled to be made.</p> <p>I concur with the previous responses.</p>
