On 9/8/2016 at approximately 0945 hours I, Lindsay [REDACTED] was facilitating Alternatives to Aggression in the MCC IMU Program Classroom. Offender Linnell Phipps DOC# 718276 was a participant in the class and was sitting in the front row, closest to the smartboard. I was standing by the smartboard facilitating class, and I observed offender Phipps looking me up and down my body. He continued to look at me in an inappropriate manner, also making eye contact with me and then proceeding to look me up and down my body again. I observed him staring at my chest area and other parts of my body. His stares began to interfere with my ability to teach in front of the class so I requested CS2 [REDACTED] to switch places with me at the front of the class and I moved to the back of the classroom by the computer. The reason I asked CS2 [REDACTED] to facilitate the class was because Phipps continued to look at me inappropriately and it made me feel uncomfortable. When I was sitting by the computer, in the back of the classroom, Phipps turned around and started staring at me again. I told him to face towards the front of the class. He said, "I can look where I want". I told Phipps to face towards the front of the class or return to his cell. A few minutes passed and he once again turned around, staring at me and then he waved at me. I informed him that I had already warned him about staring at me and told him he would be returning to his cell. Offender Phipps made the comment that he was looking at the computer monitor in the back of the class, however he made eye contact with me, and then looked up and down my body again. I then called the unit Sergeant and requested Phipps be removed from the class.
