MacDougall* 454 U.S. 364, 102 S. Ct. 700, 70 LEd. 2d 551 (1982) They don't even bother to read your motions. But the Law Court has a special obligation to construe pro se litigant's pleadings ~~drafted by attorneys~~ liberally *Pulling v. Hornum Enterprises* 97 F. Supp. 2d 502, 506-07 (D.N.J. 2000) We held pro se pleadings to a less stringent standard than pleadings drafted by attorneys and construe them liberally *Tannerbaum v. United States* 148 F.3d 1262, 1263 (11th Cir 1998) Mrs. Hillary Clinton. What are you going to do about the poor citizens who has been denied due process and still due process in the courts. What are you going to do about Correctional officers who use excessive force and inmate, jumping on inmates, allowing other inmates to jump on other inmates and killed the inmates, rapes and gangs inside the state facilities.
