I've just rec'd your 26 Sept. comm yesterday. Thank you for ack'ing my letter of 22 August.

FYI: My records indicate the following comm to: COS-LA, New Civilization -

Please pardon the overwhelming August outflow^① prompting a wrongness you apparently felt warranted an apology in re "for taking so long to respond"^②. I appreciate Joe's considerate request for you to allay my Answer Hunger, sir. Also, it's nice to finally meet who has "been working behind the scene with Joe, on putting together a Scn VM^s into Prisons Program"^③.

Interesting Stable Datum you posit in re "Joe's been mostly carrying the torch of the program, despite the fact that it has nothing to do with his functions here at the Church". Perhaps I don't understand Scn.org Hats/Individual responsibility vs. Zeus complex^④ but I had the impression that Joe is a VM - alongside his functions there. Interesting Anchor Points of view, wouldn't you agree?

This appears to me a possible foundation for a fundamental Problem in your Program, sir. Vis-a-vis: Postulate-VM^s into Prison/counter Postulate- Prohibition of unsanctioned robots^④ "We both decided", you wrote; "that it would be best to turn the program over to someone who has more time to care and make it grow"^③. Now it appears the fundamental Problem has been compounded in your assertion: "I wish I could say that person was me but, while this program is better connected with my post in the church, I am also over about 10 other programs as well^⑤". (PS - "I'm going to preapologize for any future slow responses...^②?" All these potential problems are alarming to me, sir).^⑥ Are these compounding problems (viz: Dwindling Spiral in 3 universe game), economical? I mean, considering the Ethics Cond. we're in now - especially since Joe's blow^⑤ ushering in 1/10th Interest... at best?

I do appreciate your responsibility over "10 other programs", and that will be an asset available to SPO¹⁵. But in developing this particular SPO "fledgling program", where status quo here has competition^⑦, we must establish a better strategy than simply having "caring people" available for the Overwhelming Domination Games so prevalent in Tone 1-Tone 2 societies amongst Degraded Beings, inside this theater of the absurd. Just consider why the Prison Industrial Complex has had a strategy to maintain status quo - as a self-perpetuating postulate embracing SP/PTS phenom., i.e. DB⁵.

Of course I realize the very name: "Dept. Of Correction & Rehabilitation", suggest otherwise... BUT statistics exposing recidivism rates - and the exponential growth rate of the Psych Industry wardship, reveal the Merchants, and their Evil Purpose. My "Happiness" at knowing that I'm not the Only One concerned about this Dwendling Spiral, is encouraging. Joe's generous VM influence permitted my endurance, well aware of the $PV=AD^x$ equation ~ substantiated in Science Of Survival, pages 52 & 169.

This presentation is proof of that generous influence, I hope. Despite any trouble it may have caused. Accolades are definitely due to you too, "working behind the scene". And especially for your PR-Laurels in changing the Los Angeles paradigm. I'm confident you're able to understand the paradigm-shift game concerns in my theater of operations then. Though I'm certain you had much more of the grandeur of Scn. behind your thrust to improve conditions where the org has vested interest ~ much more than Joe was afforded pioneering this SPD, I bet. I would very much like to read more about your L.A. campaign success. Would you say that Engaging three universes requires Certainty? And that the distance between Insanity and Genius is measured only by success, aka the Supreme Test! And finally I must ask; Are you in this to WIN? Fortunately, I Am - well aware of the Actual Cycle of Action in theta mest games, and despite my GPM's, Insanity is a relative term which is entirely hinged upon $ARC=U!$ Consider Logic 24.

On that note, you are "of course playing catch up on everything", as you wrote in re WG. So let me briefly recapitulate. Let's see... Joe alerted me that he had handed over all of my mailings to him over the years - for your consideration (personal Dailylog-Journals for 2014.2015/ SPO Grp Logs 2014-2015/etc?). So what more can I add to those? From the beginning... in the first book called Genesis, schism was established as "good". Then... from "splitting", there is a zygotic re-union of Lambda (= mest+theta) of the "Individual" with the inherent impulse TO BE + CAUSE (vide The "Gift" Factors - LHM). Applying the Universal Solvent to this Actual Cycle of Action, I'm able to Admire the Conditions of Existence and rise above Individuation. Thus there is comm, and thus there is LIGHT[®] (i.e. visible radiation).

Now, if Joe handed over "everything", you'll see the voluminosity (pun intended), evidence of my Interest. You'll see the unknowness of consideration is antipathetic to ARC and hence to Me! Being Free θ . Early-on with my comm-line to Joe, I intended my comm (journals, grp logs, etc.) to be a useful Dimension Points for Scn. 'students'/Administrators, who can get past the First Obstacle to Learning ~ so I wonder why you feel like you're missing so much, reading my letters to Joe. Perhaps if you'll assume a ninth-dynamic POV and consider my voluminous outflow as Aesthetic Products, you'll understand where I'm situated within the $PV=AD^x$ equation, and hence my usefulness as SIG (Scn. Inside Guy).^①

In re The Scn. Grp I have going here: Fortunately, my Purpose to Instigate Change (CAUSE EFFECTS) is actually aimed to ward the Interest of Scientologist, who are qualified to deliver Scn θ , Scn tech,^⑩ while re presenting the illustrious grandeur of Scn, as a thrust to HELP improve conditions here in the Dept. of Corrections - where the Psych Industry is currently affecting their own paradigm-shift.^⑦

As I see this game; Arousing INTEREST requires Being There and Communicating^⑧; in order to raise the Necessity Level. That has been all I ever intended to Do, as those produce the Havingness of Randomity wherein we're able to see what we're made of via ARC demonstrations/dramatizations. This game permits me to discover Significances buried in old GPM's - recovering the entheta with the Cognitions I WIN. Perhaps this is what eludes you sir, reading my letters to Joe. I've been with this Randomity-Purpose for a full 36 months now, with corresponding confusion ('w', ARC breaks, MU's, Incomplete Cycles, etc.), all as enturbulating as expected and ergo; re-warding to the degree I've been able to apply ARC. Ever aware to maintain personal Integrity.^⑪

Quite a feat for one entombed near 20 yrs - in a different environment developing higher education, engaging SP games in order to apply Sen tech to get myself through the four zones: from death to higher existence - from entrapment to freedom! I suppose that maybe I am a roller-coaster enthusiast, certain that the only way out is through confronting/handling the other-determinisms/other-determined realities. I'm thankful to all I've engaged to develop my awareness of awareness.

My stable datum purpose has been to maintain the SPO space and time (build it and they will come) for VM's to come through the open door. And as you know, we had three VM's attend our group back in April 2015 - and then the young one returned from June through August 2015. So I can actually count this game a WIN already - except for the SP opposition presenting necessity level opportunities for (usc. Equal Protection/Disparity) litigation, as Leverage⁽¹²⁾ to encourage co-operation. As is apparent by my recent PR campaign both within the Prison Administration here, and within Scientology's hierarchy; I'm still endeavoring to get this SPO out of the non-existence condition while awaiting VM's to declare a danger condition and take over this rehab game.⁽¹³⁾

That said; You wrote that you have a few VM's/OT's working with you on this program? Wonderful! Would you please convey my ARC and invite them to write me, simply for the sake of developing ARC Terminals in this theater of action. Thank You.

The Secret of efficiency (in TPOW), is in the proper handling of situations in order to prohibit incompetence, accidents, difficulties. Our SPO Strategic Administrative Scale - "POLICY = KSW" will ensure that I expect... yet WG's POV may be useful as well.

I too have taken the liberty to introduce this comm-line to several other Scientologists who've expressed their interest in our SPO ambitions, in the interest of coordinating this Restorative Justice - Fourth and Seventh Dynamic Salvage Campaign⁽¹⁴⁾!

"A good executive arranges personnel and organization to handle types of actions and confusions. He does not broadly comm into disorganized areas except to organize them. .. An executives evidence of this is the receipt from there of dev-t."

2) Apologies? (1a: a formal justification b: excuse 2: an admission of error or discourtesy... 3: a poor substitute) for dramatizing engrams ultimately in your power to control? Wrongness = Miscalculation of effort, viz: Suppressive Reasonableness (ITSE p. 256) - "a common trait which comes from the inability to confront". vide: No Responsibility. "There is no good reason for any outness".

My good sir, in accord with HCOPL 4 Dec. 66 AKH Series 9: EXPANSION, it concludes with: "The ultimate product of Scn. is ... accomplished by the de-aberration of individuals ...", so let's rather rely upon KSW. In that, I'm obliged to point out "One of these days" your "slow response aberration" will be resolved? I think maybe HCOPL 26 Mar 75: CAUSE, relates that to your post, as well. ⑥ of HCOPL 9 Jan 51 - THE CREDO OF A GOOD AND SKILLED MANAGER. With all due respect sir, the POWER OF DECISION SCALE rises from COMM, which it appears you've cch^{ed} 'suppressed'.
