What do I do without social support. The letter to Ken Klein was address to Monroe City Hall. But the thing is, the amount of time they held on to it. The letter is dated 10.2.16. you can't tell when it was mailed by looking at the postal stamp. But I received it on 11.2.16. Look at the Light House envelope how clear the post office stamp dates are.

Then I'm over charge on the letter to Finland. It was only 1 piece of paper in the envelope how did it come to .69¢. The envelope was pre-frank. So it should be no more than an additional .25¢ right!

When I filed a grievance, following the instruction of the floor staff, I still was the blame.

I know for sure my access to use the phone has been mess with. I just got some information to relative and was trying to hit them up to get some hygiene without calling my mom.

**PART B - LEVEL I RESPONSE / PARTE B RESPUESTA PRIMER NIVEL**

This investigation was conducted by Sgt. Hite. He interviewed the staff that worked shift 1 on 9/2/16, the grievance coordinator, Sgt. [REDACTED], Sgt. [REDACTED] and Sgt. [REDACTED]. He interviewed you on 10/19/16.

You assert that you handed legal mail to staff on 9/2/16, and it was returned to you several days later with a note stating it was found on the book cart. You believe your mail was intentionally handled incorrectly.

You state you do not know the officers name that you gave it to. Staff working the night of 9/2 state no one picked up legal mail from you. The legal mail log does not show any legal mail processed from you on 9/2/16. Lt. [REDACTED] and Sgt. [REDACTED] attempted to review video from this night, but it was not able to be viewed.

There is no evidence to support that you gave the letter to an officer on Shift 1 on 9/2/16. You say you did, but several staff say you did not, it is not logged. Your allegation that your mail was intentionally handled incorrectly on 9/2/16 is not substantiated.

On 9/5/16 instead of following the correct process for legal mail you attached your legal mail to the emergency grievance you filed. The Grievance Coordinator should have taken a copy of it, and returned it to you to process correctly with floor staff. Instead, she brought the mail to shift. Several staff handled this mail. It was not properly handled or logged since the correct process was not followed. This was not intentional, this was a mistake on how it was handled once received by the Grievance Coordinator. At this time, it is unknown what occurred with the piece of mail.

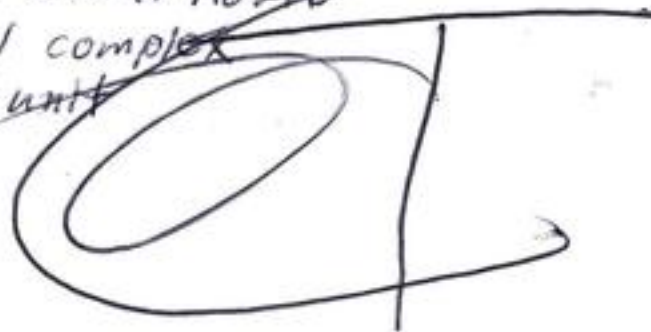
# RANT TO RAVE

Have you heard of the A2A program at Monroe Correctional Complex?, or the acts that are conducted by Mike Walker, Jason Ulrich, Lindsay McIntyre, Vilma Kouphixat, Susan Collins, Lisa Anderson, Daniel White, Brandi Btair and countless of other staffs that participate in this program.

Since, I arrive at MCC I have been sexually and physically harassed, assaulted, verbally assaulted by numerous of the correctional officials upon the instructions of Lindsay McIntyre as well as by her, while participating in the A2A class or just being housed in the IUC.

Lindsay, Mike Walker, Ulrich, Hiese and the MCC Administration strategy was to single me out and turn the offenders against me while I was participating in the A2A assignment in the classroom.

She would then simultaneously (as well as Mike Walker, Jason Ulrich David Hiese) act out a different psychological program hidden in the A2A assignment at the same time pretend to conduct the A2A assignments, in a scenario against me. The A2A instructors and support staff would encourage the rest of the offenders to gang up against me as what is describe by them as, "to ostracize me from the A2A class." But what they did was make it so inhospitable that any reasonable minded person would just not return.

Are you familiar with a parapsychological word, "para-psychology"? What about, "parapsychological abilities"...

Every living being has this ability. That's why we are able to communicate with dogs, cats, and soon. But with that same abilities we are able to harm each other with under certain condition. If the action of the assaulter or aggressor is not stop,

Lindsay McIntyre Filed An ~~allegation~~ infraction against me falsely Alleging that I sexually Harassed Her by Looking Her body up And down, Attempting to make eye contact with her.

on top of everything else, this was the Breaking point. so when I was escorted into the AZA class on 9.20.16 Mike Walker knew that the provocative action He conduct would have me requesting to be escorted back to the cell. I was eventually removed from the class upon request by sending A kite to my unit counselor.

I requested that the police be contacted so I could file A report against the AZA instructors and Numerous of correctional officials. But, Nothing Has Been done.

I wish, I can attach a copy of the response of the Kites I sent complaining about the AZA instructors behaviors, But policy prohibits this.

I know that I ~~will~~ be transfer from MCC within the weeks to come because this was their overall objective,

but my question is, Not How come such action by the Department of correction officials is acceptable... But, why?

The Psychological and Emotional Traumatic Injury that I suffered from the abusive action of the Department of Correction officials is so real, And Injust.
