I WAS IN THE PREP ROOM PREPARING FOR EXPLORATORY SURGERY. 2 NURSES CAME IN THE ROOM ONE PLEASANT (DEMEANOR) THE OTHER MORE OR LESS SO. I PLEASANT ONE HAD A COMPUTER

on wheels. As the PLEASANT NURSE, JOVIALY spoke to me. VIRTUALLY INSTANTLY THE FIRST NURSE INSERTING THE I.V. INTO MY WRIST PLUNGED THE NEEDLE DEEP INTO MY VEIN AND OUT AGAIN! I SCREAMED STOP! AS THE PAIN OVERWHELMED ME AGAIN THE PAIN CAUSED ME TO YELL TO HER TO STOP! AGAIN THE NURSE PLUNGED THE NEEDLE DEEPER INTO MY WRIST.

AS BLOOD Poured down my wrist THE NURSE SQUEEZED THE NEEDLE VIOLENTLY INTO MY WRIST ONCE AGAIN I CRIED OUT REPEATEDLY FOR HER TO STOP SHE IGNORED ME AND JUST SMILED. FINALLY SHE POSITIONED THE IV CORRECTLY TAPED IT ~~WAS~~ WIPED THE BLOOD OFF HER FINGERS (SHE WORE NO GLOVES!) AND MY BLEEDING BLOODY WRIST AND SAID ARNT YOU THE NERVEOUS NELLY ARNT CHA.
