- HARVARD P.L.A.P. VISITS THE LIFERS' GROUP / POLICY WORK AHEAD

Five Staff members of Harvard's Prison Legal Assistance Project (PLAP) came and visited with the Lifers' Group here at MCI Norfolk on Tuesday night, November 1. They covered the topics of Parole Representation, Commutation representation, representation at disciplinary hearings, as well as their new "Public Policy" division.

General members of the Lifers' Group were able to engage in a lengthy questions & answers segment and some men were able to secure direct representation opportunities through Harvard PLAP. Two of the PLAP Co-Directors gave a clear overview of what the organization can and cannot do, which was elaborated upon by PLAP's supervising attorney. The Parole Hearing Coordinator answered many questions for 2nd degree lifers' in the group and the Policy Coordinator assured The Lifers' Group Board of Directors that they would like to build an ongoing and continuing relationship with us.

The Lifers' Group will immediately begin solidifying this relationship and doing its best to be able to offer lifers and long-termers here at NorfolkWorld/WallyWorld the most effective advocacy. Stay tuned for more on this work; work feared by the suits and Nazis.

- OVERTIME BEING ABUSED AT MCI NORFOLK / SINGLE CELLS BEING DENIED

As of late the gulag staffers have been racking up the overtime hours here at WallyWorld; getting ready to buy pitchforks and horn shiners for the little Devil's spawn at Christmas. They have been robbing the state without a mask or gun each and every week. Usually who would care?
