CALLING ME A PUNK ASS BITCH, THE "N" WORD. WITH THE SERGEANT AND OTHER FLOOR STAFF JOINING IN. JUST BEING RUDE, OFFENSIVE AND DOWN RIGHT INHUMAN. I DON'T KNOW WHAT THESE WHITE PEOPLE ~~WANT~~ THINK I WOULD DO. NOW, JUST IMAGINE, WHAT THE REST OF MY DAYS AND WEEKS HAVE BEEN LIKE AFTER 12.5.16. WHAT WAS THIS NURSE AND CORRECTIONAL OFFICIALS EXPECTING. OH! I KNOW! A HUMAN BEING OF NO MORALS.

FOR THEM TO PLACE ME IN ONE OR TWO STEREO-TYPICAL CATEGORIES. TO COIN ME AS THE ANGRY BLACK MAN OR THE IGNORANT BLACK MAN, WHO HAVE NO SELF CONTROL, EASILY BROKEN DOWN, WEAK MINDS, LACKING THE ABILITY TO OUTWIT HER AND DUE TO MY HEALTH CONDITION OR IN ANY STATE.
