
So, now that that's taken care of, assuming Donald Trump hasn't brought on WWII yet, & this gets posted, here's what's going on with me.

1. Class-action Lawsuit over Solitary Confinement in WI

This is explained in the post directly preceding this one. I've been exhausting the grievance process, preparing to file this suit since my return from federal custody in Aug. of 2015. Sadly none of the so-called litigators in this or the other WI seg. units have prepared for this, let alone took the time to write the suit. Yet when I told a WI prisoner advocate I wrote it & am ready to file (it's over 40 pgs. long!) she insisted that another guy in another joint be the main plaintiff, so he'll look like the guy who put it all together.

That ain't happening. Ya gotta do the work to get the credit & only I have done so. (It irritates me how guys who know how to litigate do nothing but play chess all day, then think they even have a say in what someone does who works 10 hours a day pursuing humane treatment of prisoners!)



2. Racketeering/Embezzlement Investigation of W.D.O.C.

The Progressive, a Madison newspaper ran an exposé on the subject, by Bill Lueders, published on the 16th or 23rd of February. It might also be on WisconsinWatch.org by now, where you'll also find a series of articles also by Mr. Lueders about guards at the Waupun Correction Institution (W.C.I) torturing prisoners — I'm cited as a source for many of the incidents, as is this Blog. they only took 25% prior, for the last 30+ years

Long story short, without relevant changes in the law/statutes, the WDOC began to take 50% of all our pay & incoming \$, to pay court-ordered obligations that in many cases we already paid decades ago, & they take 5% on top of that from everything they collect. They're making us pay for things they've no authority to collect (e.g. attorney fees) without valid information that we even owe it, no doubt to get their 5%. In some cases, they take all of a prisoner's money, for these dubious & illegal debts.

It only takes three acts outside of their authority to constitute a "pattern of racketeering activity" under WI's RICO law. WDOC officials are engaging in thousands of such acts, every time we get money.

So far I've written a petition to begin an inquest into the matter, which dozens of prisoners have filed, along with multiple outside activists. Also wrote complaints & a motion to modify sentences so only 25% is taken. Next I'll write a guide on how to sue the WDOC civilly, possibly under the U.S. RICO Act; lotsa research left to do.

This racketeering by the WDOC is going to end, but not before it costs taxpayers hundreds of thousands of dollars from just defending the coming flood of lawsuits & more to return the stolen money.

Hey, that's what the taxpayers get for letting the WDOC do whatever the fuck they want, which taxpayers already give the WDOC over a billion dollars a year (gov. Walker's recently proposed budget was 70-some billion) to fund. Mo-fos apparently got money to burn, & I got a match.

3. Why I Seek Your Help

You probably think I'm loved by prisoners & prisoner activists too. It is true that some prisoners like me, some recognize & respect my efforts, some have helped me with some coffee or paper (they can't give me stamped envelopes as staff write our #'s on the back in red ink). But most inmates are indifferent, some even insult me just because they're haters. Most of these prisoners around me are emotionally sick, morally insane, selfish & already insane or driven there by the solitary confinement.

One prisoner wrote & thanked me for my efforts, but didn't ask how he could help me.

C'est la vie pour moi.
