# Letter to Daniel Tutka — dated 26 Feb 17

Daniel, as I ran out of space in my last letter, I'm writing again, before I hear from you, to be clearer in answering your questions, and explain my situation.

**WSPF, P.O. Box 9900 Boscobel, WI 53805-0901** It's the state's most secure/strict U.S.A. prison, so, keep these rules in mind for sending me stuff, because I have no \$ to mail back large items (e.g. books, electronics).

### \* Rules for Sending Me Stuff \*

The only things you can mail me are letters, copies/printouts of articles (nothing torn or cut from a book/magazine/paper), photographs printed on photo paper & no photos of women's nipples or male/female genitals or anuses (just in case you wanted to! ), nor can you mail me any property, no T.V., no candy, or anything except

Property must come from www.JLMarcusWisconsin.com, WIinmatepackage.com or wisconsinpackages.com — only accept payment with Pay Pal from overseas, so that's who you'll have to use. If the property you want to send is allowed & not sold by these places, it can be mailed from any business, but must have a receipt.

Some property I'm allowed, most sold by (is: a T.V.) (I don't have one), a radio (don't have one), headphones (don't have) shower shoes (don't have), scented oils, postage-embossed envelopes (I always need postage/envelopes), paper, greeting cards, folders, soft covered books (hardcovers banned), magazines (no staples).
