resemble herself in the Maxim pic. She's a total bitch.

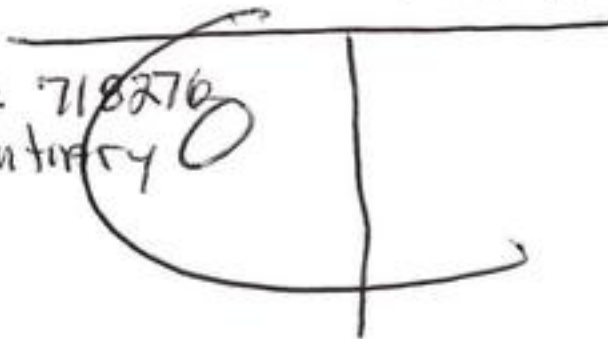
She don't infract me, but she is one of the person


