TO ESCAPE YOUR PRISON." ALSO I COMPLETED
"THE STREETS DON'T LOVE YOU BACK,
INTERVENTION PROGRAM." BOTH PROGRAMS
WERE VERY HELPFUL IN TRANSFORMING MY
WAY OF THINKING.

NOW FOR THOSE OF YOU WHO MAY NOT
KNOW MY STORY, AND MY STRUGGLE FOR JUSTICE
AND FREEDOM FROM THIS BELLY OF THE BEAST.
PLEASE ALLOW ME TO SHARE MY SIDE OF WHAT
HAS BEEN A BAD DREAM WITH YOU.

FOUR (4) YEAR SENTENCE FOR PETTY THEFT, AND WITH JUST THREE (3) MONTHS LEFT BEFORE MY RELEASE BACK INTO THE FREE WORLD, I WAS INVOLVED IN A PRISON RIOT, WHICH WAS INITIATED DUE TO THE SAUAGE BEATING OF A PRISONER BY RACIST GUARDS. NO ONE WAS KILLED IN THE RIOT, AND I WAS GIVEN A 142 YR SENTENCE FOR MY INVOLVEMENT IN THE INCIDENT, AND I SPENT 19 YRS IN SOLITARY CONFINEMENT.
