Crushed !!!

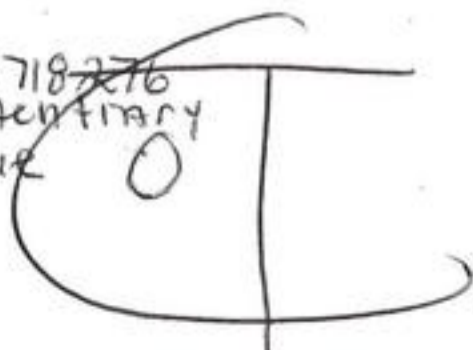
Life ... often serves up dishes of such horrible proposition
