1996 to 136 in 2004. With the Supreme Court ruling there is a "national consensus" that the execution of alleged murder suspects younger than 18 at the time of the crime is cruel and unusual punishment, 20 state laws were invalidated and 70 juveniles had their death sentences lifted nationwide, including Texas which had 28 of them. This is a long overdue step towards preventing further murder. The fact that 117 people were falsely sentenced to death before their exoneration, and hundreds more are waiting to have their evidence of innocence heard, there can be no doubt that the states have murdered many innocent people like Cameron Willingham. Cameraon was murdered last year for an arson that never occurred. "We cannot teach that killing is wrong by killing. We cannot defend life by taking life," Cardinal Theodore McCarrick told a Washington news conference. It is time for everyone to step up and begin practicing what they preach.

Thousand Wrongly Convicted Because of Poverty!


Thousands of suspects unable to afford lawyers are wrongly convicted each year because they are pressured to accept guilty pleas or have incompetent attorneys, says the American Bar Association in a report.

The study by a committee of the nation's largest lawyers' group says that legal representation of indigents is in "a state of crisis." These defendants are at constant risk of wrongful conviction and unjust punishment, including the death penalty, according to the study released February 12, 2005.

"The fundamental right to a lawyer that Americans assume apply to everyone accused of criminal conduct effectively does not exist in practice for countless people across the United States," the study states. "All too often, defendants plead guilty, even if they are innocent, without really understanding their legal rights."

The ABA committee wants Congress and local governments to spend more money and create oversight groups to guard against shoddy legal representation. Judges also are asked to be more vigilant in ensuring defendants have competent counsel.

It has been more than 40 years since the Supreme Court



I would also like to thank those of you that have sent me suggestions for the JDC. They are appreciated and I am considering several of them for here in Mass.


