I Truly believe that the letters that are return to me as return to sender have been unconstitutionally block by the correctional officials.

It's Reports of my mail being thrown into the trash by the correctional officials. I know for sure they give my mail to other offenders at times. Some of them are civilize enough to return it to the floor staff. The CO's do this type of Bull-shit all the time.

~~Some of the~~ If you sent me some material in response to a letter I've sent you from Oct. 2016 or before then and recently from Feb to May 2017 and you received a rejection notice or your mail was return or have not receive a letter of thank from me or is not confirm here that I received your material. Or you sent me a letter and it was return or someone else besides me responded to your letter or material. You would want to;

(1) contact the Secretary of Department of Correction filed a complaint, appeal the notice rejection, and file a tort claim.

(2) file a civil complaint in your state under the Long Arm of the Law statute of your state or this state in your state superior court or the equivalent of the superior court in your state. The Long Arm of the Law statute for this state is under title 4 of the RCWS. You'll have to report the act first or appeal the rejection. This demonstrate to the court that you are a responsible citizen and standing up to a corrupt entity. -B- Reporting an unconstitutional and criminal act that has been committed against you by them.

Your next step is filing a tort claim with the office of Risk Management with this state and your state to be safe. If your state has a Risk Management Office.

The address to the office of risk management is on the back. If you have thrown the rejection or return mail away. Alleged the date or time of the incident or for which the incident occur.

Contact an Attorney if you are unable to file and litigate a civil complaint on your own. Give them the cited case law in this blog and they should now what to do at that point.
