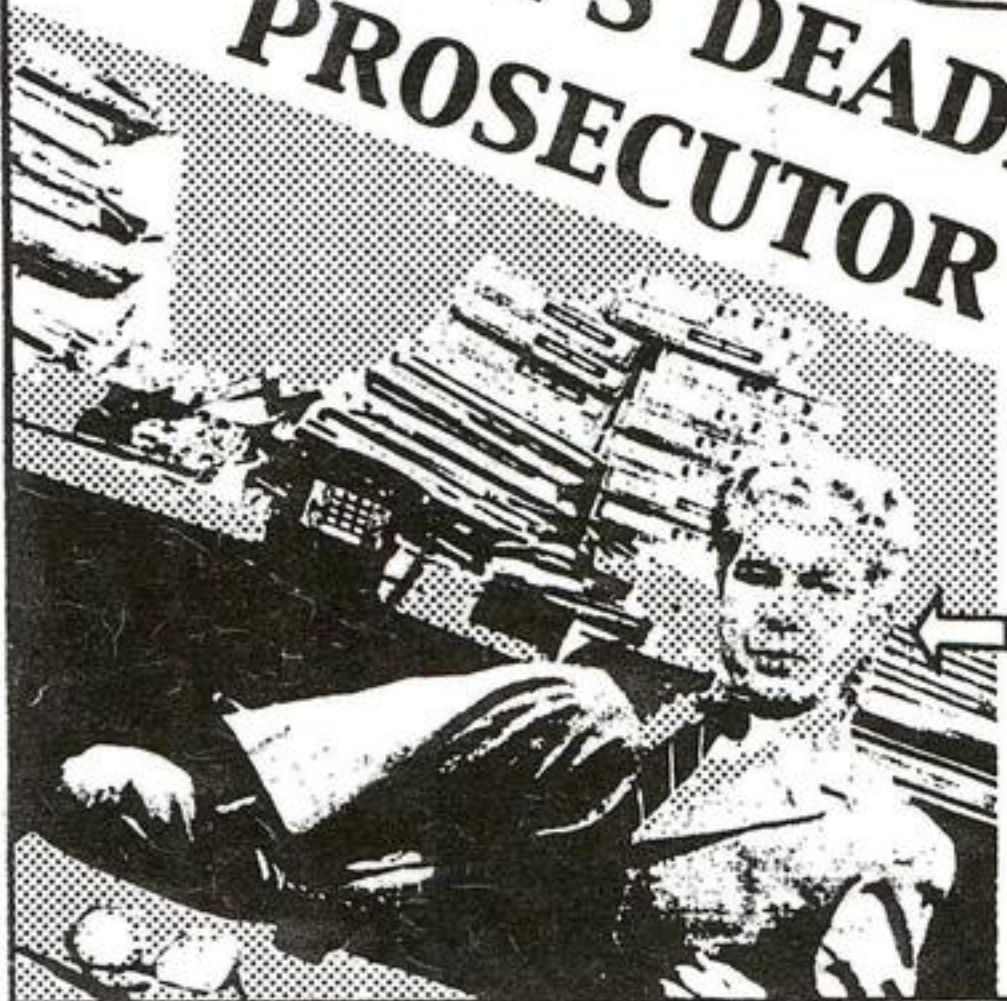

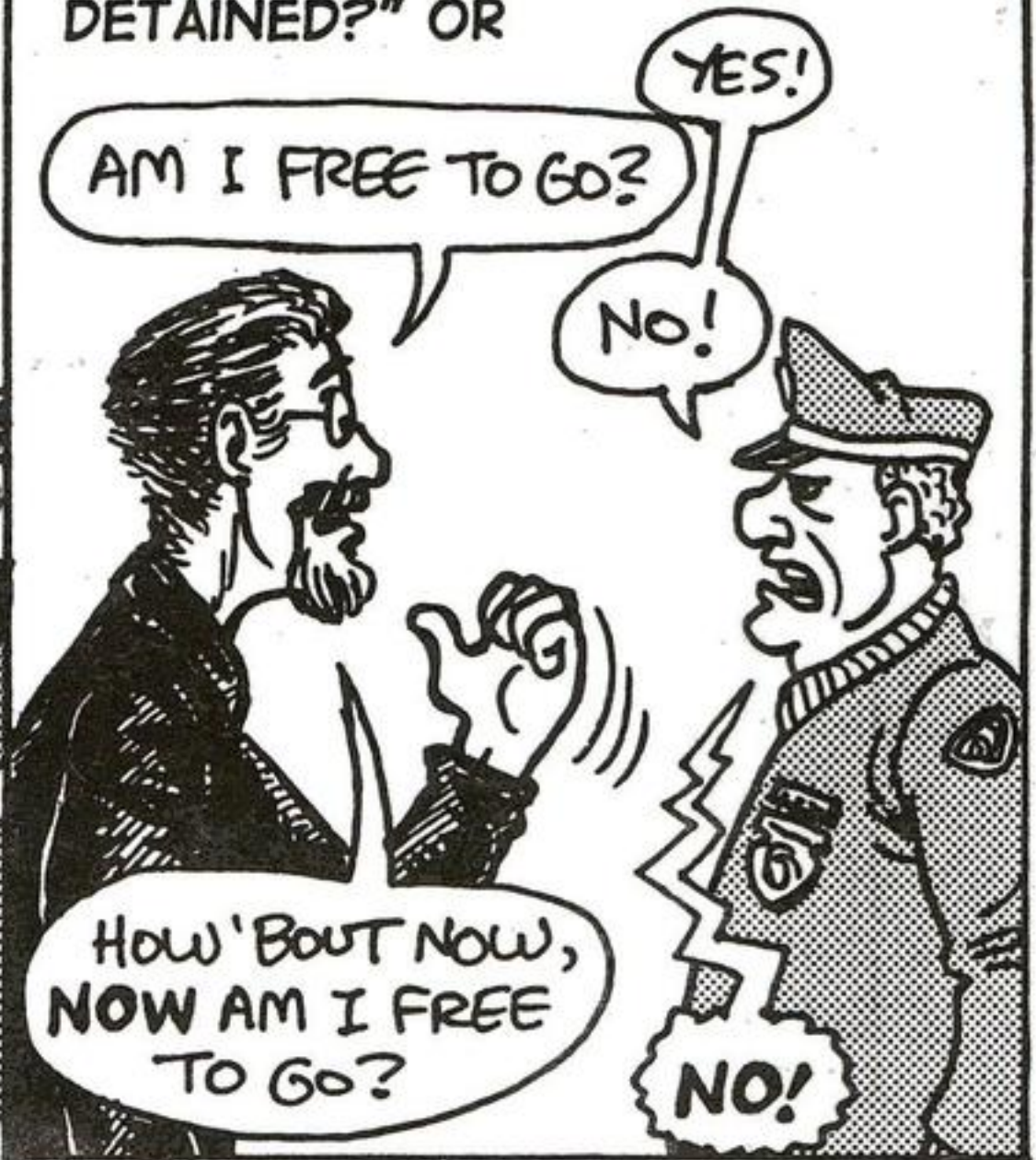

Three Felonies a Day, by Harvey Silvergate. A descriptive title - Federal laws and regulations have become so numerous and vague, hardly anyone can pass a day without committing a felony. Published by Encounter Books in 2011. The ISBN-10: 1594035229. I wasn't exaggerating: NOBODY is safe!

Rise of the Warrior Cop: The militarization of America's Police Forces, by Radley Balko. Published by PublicAffairs, 2014. Like the title says, how the old - fashioned cop on the beat became a heavily armed and armored threat to the people he's supposed to be protecting and serving. ISBN-10: 1610394577.

You and the Police! by "Boston T. Party". A no-nonsense, you could even say cynical, guide to surviving police encounters with one's skin, freedom, and maybe even dignity intact. The author has had to revise the book to keep up with the drop in the standards of police behaviour. Things are not just getting worse, they're degenerating ever faster. Published by Javelin Press, PO Box 31Y, Ignacio, Colorado 81137-0031. ISBN 1-888 766-09-3.

I reccomend visiting www.javelinpress.com. It's got several of Boston's other books, such as "Boston's Gun Bible", which a person who wishes to be well prepared might find useful.

ACTUAL INNOCENCE, When justice goes wrong, and how to make it right, by Barry Scheck, Peter Neufield and Jim Dwyer. Published by Signet in 2001, ISBN 0-451-20365-8.

Ten stories of prisoners who were freed when DNA evidence finally proved their innocence—except for those who'd already been executed. Ten stories of appalling, infuriating injustice. Almost without exception, the prosecutors and judges who had sent innocent people to death row fought tooth and nail to stop the exoneration of their victims. These sociopaths cared not at all that they'd ruined an innocent man's life—they really would rather murder an innocent person than suffer the momentary embarrassment of admitting they were wrong. And these folks are in charge of administering JUSTICE?!

And there's the chilling fact that most criminal cases do not involve DNA evidence at all. So anyone wrongfully convicted on false testimony or other circumstantial evidence, has little or no chance of ever clearing their name. What a system, huh?

One Nation Under Arrest: How Crazy Laws, Rogue Prosecutors, and Activist Judges Threaten Your Liberty, by Paul Rosenzweig. Published by the Heritage Foundation in 2010. ISBN-10: 089195-1342. I'm not the only one who's noticed the crazy expansion of all manner of laws and regulations designed to keep prisons full.

A Government of Wolves: The Emerging American Police State, by John Whitehead. Published by Selectbooks in 2013. ISBN-10: 1590799755. Old saw: "It does the sheep little good to vote for vegetarianism, as long as the wolves are of a different opinion". A detailed and footnoted warning about the police state that the USA is devolving into.

....as if we didn't know. Problem is, a minority of people in the States like to read at all, let alone pay money for books. If one wants to sound a warning about the cliff the USA is headed for at terrifying speed, publishing a book about it is just about the worst way possible to get the word out. I, and these other good authors are very likely wasting our time. But what else are we to do? Stand there with a finger up the nose, watching, but not doing anything? Warning the future victims of an approaching disaster is a moral duty. Not my fault if nobody listens. Gahh...

<http://witness.org/> helps train people to film police and how to hang onto the video afterwards. People (and cops ARE people, under all the armor and ammo pouches) tend to behave better when they know they're being recorded. Hence the push to equip entire police forces with lapel cameras. I'm told they exonerate the cop in up to 90% of cases, so they should have no objection to them. I'm sure the 10% were also grateful...

The original (and best?): www.copblock.org, "Badges don't grant extra rights" is their motto. I advise eating lightly before cruising this site, as the contents make my stomach churn. Hmmm.... I notice this page is heavy on copwatch sites, but not so much on prisoner support ones, like www.prisoneradvocacy.org/resources/support-groups/ for example. Just Google "prisoner support", and you'll find a much longer list that could possibly be reproduced in a little paper booklet like this one. Goes for all of these, I suppose. It's a different world, now that the Net is global.

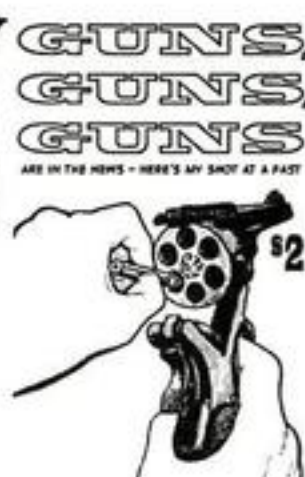

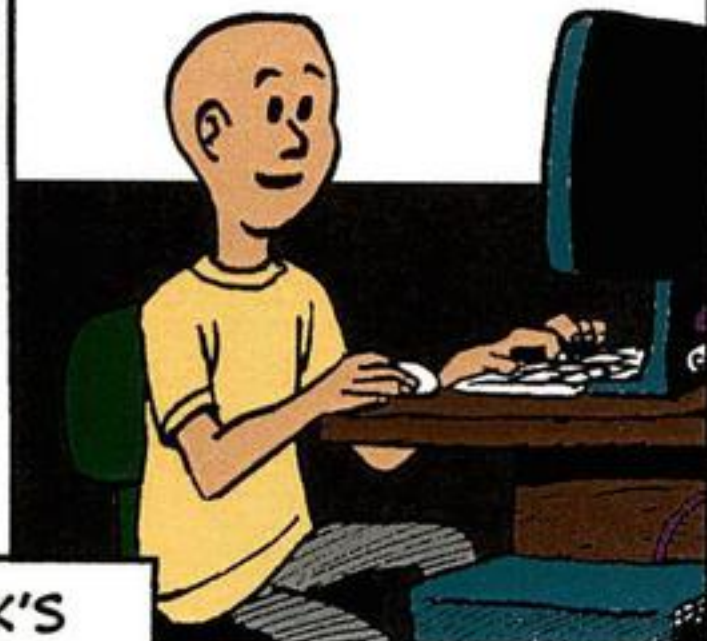
