

FOR MONEY AND POWER,

The "corrections" industry leases slave labor for pennies an hour to produce cheap goods that obliterate domestic competition. The number one buyer of slave labor is the Department of Defense. The Federal prison industry produces 100% of all military helmets, ammunition belts, bullet-proof vests, ID tags, shirts, pants, tents, bags and canteens.

HERE'S HOW IT WORKS:

Along with war supplies, prison workers supply 98% of the entire market for equipment assembly services: 93% of paints and paint brushes; 92% of stove assembly; 46% of body armor; 36% of home appliances; 30% of headphones/microphones and speakers; and 21% of office furniture. The domestic slave trade is a multi-billion dollar business, authorized by the 13th amendment which exempts prisoners from laws against forced labor. Today, there's more slaves than before slavery was legally abolished in the 1800's!

the real money for this corporate owned prison is just in warehousing people. They get paid by the State a set amount per prisoner. Every buck they save buying cheap food and cutting corners is extra money in their pockets. I don't imagine the staff of idiots they hire as guards get paid that much. The medical staff seems to only exist to prevent lawsuits. The prison commissary has a monopoly, they charge about twice as much what many of their items cost on the outside.

Unlike the state-run prisons where everyone must work, here (where the money is in warehousing inmates and making them work opens up potential for liability) the slave wage jobs are considered a privilege. There's a lot of competition for a 60 cents per hour job in the chow hall. People who don't have any outside help to send money, especially smokers who must have their overpriced tobacco from the commissary and

apply for these shitty jobs.
