Dear Mr. Kevitt

With a total of 33 yrs exiled to penal colonies, I can tell you there has been a successful paradigm shift in penology over the years. From the criminal college subculture before the era of T.V.<sup>s</sup> and Psych<sup>s</sup> infiltrated our noosphere here; maximum security prisons were indeed nurturing terrific criminals with scores to settle, who had nothing to fear from a tone 2 society. But now; with exercise weights and boxing rings removed - TV<sup>s</sup> in every cell - and soybeans replacing red meat... mediocrity prevails and the prison psychs thrive! If I were to assess this change and locate the underlying Cause of this paradigm shift, I'd pin it on: Overwhelming games of Responsibility, producing No responsibility amongst the vanquished - merging into the phenomena of apathy. The drastic surge in the glee of insanity cases support this hypothesis, if the booming psych. industry inside prisons are a true indicator.

That being said, this domination by nullification campaign within the state and federal Dept. Of Corrections & Rehabilitation throughout the country - where the psych industry usurps authority - may be 'helped' yet by introducing LRH tech. into the PV=AD<sup>x</sup> equation, in order to "Help" re-develop requisite social skills of prisoners reintergrating within the very same tone 2 society which exiled them to penal colonies in the first place.

From the beginning, I'd first engaged Tree Nebeker circa 1985, with pleas for Help, and consequently we had initiated an extension course program - before Criminon courses were available - and the success of this program both raised my I.Q. and corresponding responsibility, as well as it did among students of other races who I feared empowering at the time, not quite understanding the value of cleared cannibals.

That GPM has been my impetus for completing that cycle of action here now with this SPO campaign. After years of periodic solicitations for 'Help' once again, I'd engaged Joe Riley in 2013, whose TR-10 demonstration during a christmas day visit, sufficed to restore the ennobling dimension points I'd betrayed and... I'd determined to pioneer this SPO game - strictly to raise the Interest level in what CAN (and should) BE DONE ABOUT IT.

It's easy to see from the seditious newspaper articles circa 1995-99, on my blog site betweenthebars.org/blogs/420/william-goehler, that my overwhelming ordo ab chao serfac is very able to withstand the necessity level impingements required to handle the problems in prison without spinning off the ensuing roller coaster rides. And as you can also see by the above letterhead, I'm also well aware of leverage games which amplify my ability to apply force and intelligence.

The information I've gathered which may help you help others create SPO study groups is a rather simple proposition. Every prison is regulated by RLUIPA (Religious Land Use-Institutionalized Persons Act) which ensures the USC 2nd Amend. Freedom. And aside from those federal statutes, each state also have their Code of Regulations regarding Corrections Depts. similar to California's CCR Title 15, which you may view at [www.cdcr.ca.gov/regulations/adult\\_operations](http://www.cdcr.ca.gov/regulations/adult_operations), wherein section 3210 through 3213 addresses Religious Programs. It will also be prudent for you to consult the MAIL policies found in section 3130 through 3147, with particular attention upon section 3134.i regarding Publications. You may also consider section 3190 to further understand Religious Personal Property regulations differ somewhat according to custody levels. MCSP 'A'-facility is a level IV with more restrictions than MCSP 'B' or 'C'-facilities, which are level III's for instance. As the Dir. VM's HPP, you should also consider the leverage value of knowing section 3260 Public Info. & Community Relations.

Joe Riley reported to me that he had surrendered all of my mailings to him - over to you, so you've seen the exhaustive appeals I've filed to document the counter effort SP games here. Those appeals applied every legal-cite remedy to secure SPO access to CD lectures from Bridge Pub., as well as documented the rampant imparity of chapel access. I'd also sent JR MCSP's Operational Procedures regarding Volunteers for both religious or secular activities. You should also find our weekly meeting log as well - so I don't understand why you'd say that you have very little reality on our group. Do you in fact have all the material I'd mailed JR which documented the development of this SPO study group here? (Please reply).

Presently our group is in limbo during Ramadan, as the SP Imam 1/2 of A-facility chapel activities had transferred our group meeting time over to the supervision of the protestant chaplain just before the protestant chaplain was placed on suspension while under investigation for some wrong doing. But however that investigation turns out, I'm reluctant to continue in an apparent games cond. agony, without the long promised VM's 1/2 here. I'd started this game in order to raise interest and open the way for VM's, and this I've done! I will continue to check on and encourage active students outside the chapel though.

In further response to your June 1<sup>st</sup> letter, I'd like to point out my OCA improvements in every column but one, thanks to my involvement with Scientology since 2014. Despite the numerous ARC breaks, and SP games with the prison administration, I'm proud to report my plus randomness impingements have indeed presented a necessity level catalyst which produced reconn. which will help others, - which was my intent all along. Thank you for this opportunity to BE of service in Scientology's 4<sup>th</sup> dynamic salvage campaign, through your VM's Helping Prisoners Program.

Let me also point out the Valuable Final Product of SPO's Strategic Administrative Scale is the: "Responsible, Self-Determined PT Asset in Dynamics Exchange - with Optimum ARC Understanding". When prisoners realize their degree of freedom relies upon their degree of understanding, SPO's will then become DOC's resented asset, producing rehab. indeed!

Futhermore, as SPO's Policy is KSW, I'd like to also point out HCOPL 13 Nov 70 Planning By Product, and ask you to please consider the Havingness of prisoners who've been rejected by a tone 2 society. Having been degraded and exiled to penal colonies where SP's have had the un-checked Power to overwhelm and thus implant criminal behavior (per Matter and Energy lecture), prisoners survive or

they may succumb either into the fixated games cond. and/or into a dwindling spiral of compromised ethics. Adapt or die is the force behind the third postulate refuge of anaten in many cases, I expect. Dare ask WHY! What is it that penal colonies produce? Its a strange phenomena, isnt it? Criminals (SP's) have revenge as their PTS product, They've been degraded to an antagonistic enemy cond. at best. This is our primary target to confront and handle as a sort of triage amongst prisoners, I think. How do we present degraded beings an opportunity to remember who they really are? We begin with the enemy cond. formula and establish a comm line for them to inflow theta source material - by gradient.

As the pioneer of this SPD postulate, with the provincial benefit of 33 yrs experience of reaching out to every prison outreach ministry imaginable, the following is my thoughts on developing a bed-rock foundation for SPD's to flourish and prosper.

Harness the criminal serfoc trap "need of Help". If they've contacted Sen., then the very first dissemination is the booklet: Sen. Something CAN Be Done About It, which serves to introduce VM's and the solutions of lifes problems we can all relate to. This single publication will produce the admiration necessary to initiate an actual cycle of ennobling action, in every case! Enclosing one of your postage-paid business envelopes will also encourage interest to establish unimpeded ARC too, you see? Ack-ing a PTS unconditionally is a phenomenal reminder of WHO they really are. Then once prisoners use the return envelope to ack receipt of that Sen. booklet, they are agreeing to assume more responsibility for their cond., so that will be the proper time to send them an encouraging (form-) letter ack-ing their interest in Help, and providing them their first OCA questionnaire.

Every prisoners letter to any Sen. org should promptly open a case file referral to VM's HPP in order to initiate this salvage campaign - and as a data base means to monitor statistics, noting the prisoners initial contact date and VM reply; apparent time/ yrs in prison/sentence/release date/etc., as well as data base means to monitor materials mailed out to them and their corresponding WIN contributions.

Children and thetans love to look at pictures of theirself, dont they? OCA's are a fun self reflective game - made all the more intriguing by spelling out their OCA graph indicators for them to contemplate - and hopefully determine to improve. Furthermore, OCA's in case files, such as my Before and After improvements add statistical data to secure this VM's HPP, as well as permit VM's to minister to individual strengths and/or needs. There is also a potential value of comparative OCA improvements in future parole board/psych board consultations/hearings to consider as well.

Those candidates who fill out and return OCA's are then introduced to: "VM's HPP operates as a Group game relying upon group member contributions (cred's), wherein donated publications are exchanged for personal WIN reports explaining any cognitions the material produced toward applicability, as per HCOB 26 OCT 70 STUDENTS APPLY". This restorative game of ARC-line contributions will either raise their cond. up through doubt into liability and produce corresponding WIN's along the way, or lacking quid pro quo - it may drop the enemy cond. down to treason and produce corresponding blows<sup>⊕</sup>, in which case at least one or two VM comm's of affinity addressing cond. of confusion - is the least effort to expect - and could very well be all it would take to prevent another neglected criminal from returning to society with a score to settle. (⊕) I expect your computerized case-file system widely available to designated VM's, can

be programed to Pop-Up Alerts of comm-lag when students lag for 60-days or so - for any number of reasons). Vigilance is our standard, "if one does not like the crime, cruelty, injustice and violence of this society", VM's HPP understand disaster relief within the prison systems are the only hope of reversing the catastrophic consequences of this nations prison boom and the corresponding degradation produced by the infiltrating psych industry. Prisoners reading the lecture on Religious Influence, will expect: VM's help civilize [society], bring it conscience and kindness and love and freedom from travail by instilling into it trust, decency, honesty and tolerance.

Admiration being the very substance of a comm-line, and that thing which is considered desirable; As each prisoner produces their WIN's currency, a certificate (such as the enclosed example) should be granted to validate Havingness with a tangible reminder which they may share with family and friends in order to show what they're doing to better their self in prison. Now we're developing exchange by dynamics within a prisoners zone of influence, you see? Rehabing PT Responsibility! Be, Do, Have, with a Valuable Final Product purpose - you get this - right? This ennobling game can proceed through each of The Scientology Handbook booklets, beginning with Study Tech. and offering a catalog synopsis of booklets to follow - which aspiring students will be free to self-determine future topic of interest to study.

Yes, Criminon offers several of these VM courses, along with their TWTH prerequisite. But take a moment to consider criminon stats (and the burgeoning prison population/recidivism rates). How many prisoners begin TWTH prerequisite and blow? If criminon didn't have so many blows - VM's HPP wouldn't be necessary. This SPO intends to cultivate better Criminon students, while also opening the prison gates for VM's to enter and deliver Scn. 0 and Scn. 1 tech. in their religious capicity. And once inside, also offering to deliver ABLE material as secular activities.

These SPO/ABLE activities will produce a constant flow of WIN's which may be published in a new VM's HPP newsletter where students will see their contributions published - and Scn. patrons may monitor this program, and perhaps fund a LRH Lending Library, which will also provide return postage paid mail labels to help develop prisoner integrity.

VM's HPP newsletters publishing WIN's in prisons, serves to develop mutual ARC and upon that foundation SPO study groups will ultimately succeed and occupy chapel space in every prison! Mind you, utmost importance must be upon recruiting local VM's to assume In-Charge, where study groups reach out from non-existence condition. It's imperative that hatted VM's 1/2 maintain KSW Policy within each study group.

Mr Kevitt, this strategy will permit the Dir. of VM's HPP the freedom to manage delegated responsibilities over VM's 1/2 of regional study groups; the Lending Library; the Newsletter; and monitor computer case-file statistics, with the greatest economy - as I see it. I have many more long-term postulates regarding Scientology Prison Outreach, and the impact we may have on countless lives both directly and indirectly, I'd be honored to discuss with you anytime.
